**THE LEICESTER (CONSOLIDATION) TRAFFIC REGULATION ORDER 2006
(AMENDMENT) (CASTLE STREET) (No.171) ORDER 2015**

Leicester City Council (the Council) in exercise of their powers under Section 1 and 2 of the Road Traffic Regulation Act 1984 (The Act) and of Part IV of Schedule 9 to the Act and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act hereby make the following Order:-

1. This Order may be cited as The Leicester (Consolidation) Traffic Regulation Order 2006 (Amendment)) (Castle Street) (No.171) Order 2015 and shall be included amongst the Orders which may be cited as The Leicester (Consolidation) Traffic Regulation Order 2006 and shall come into force on the 8th July 2015.
2. (i) The expression "the Principal Order" means "the Leicester (Consolidation) Traffic Regulation Order 2006"
(ii) Any document referring to the Principal Order shall be construed as referring to the Principal Order as amended by this Order.
3. The Principal Order shall be amended as follows:
 - (i) In Schedule 1 to the Principal Order revoke the existing Schedules relating to

Castle Street
 - (ii) In Schedule 1 to the Principal Order insert Schedule 1 to this Order in the appropriate alphabetical order.
4. Nothing in this Order shall affect the Principal Order in its operation in relation to contraventions committed before the commencement of this Order

SCHEDULE 1

CASTLE STREET

Part 112 Prohibition of Driving, at all times, all motor vehicles at its junction with Southgates

North & East Side

Part 207 from its junction with St Nicholas Circle to a point 25 metres south of its junction with St Nicholas Circle

Part 404 from a point 25 metres south of its junction with St Nicholas Circle to a point 55 metres south of its junction with St Nicholas Circle

Part 207 from a point 55 metres south of its junction with St Nicholas Circle to a point 137 metres south of its junction with St Nicholas Circle excluding the lay by between 82 metres and 112 metres south east of its junction with St. Nicholas Circle

Part 404 the lay by between 82 metres and 112 metres south-east of its junction with St. Nicholas Circle

Part 404 from a point 137 metres south-east of its junction with St Nicholas Circle to a point 147 metres south-east of its junction with St Nicholas Circle

Part 207 from a point 147 metres south-east of its junction with St Nicholas Circle to a point 153 metres south-east of its junction with St Nicholas Circle

Part 404 from a point 153 metres south-east of its junction with St Nicholas Circle to a point 170 metres south-east of its junction with St Nicholas Circle

Part 207 from a point 170 metres south-east of its junction with St Nicholas Circle its south-eastern extremity

South & West Side

Part 207 from its south eastern extremity to a point 42 metres south-east of its junction with Castle View

Part 215 from a point 42 metres south-east of its junction with Castle View to a point 14 metres south-east of its junction with Castle View

Part 207 from a point 14 metres south-east of its junction with Castle View to a point 53 metres south of its junction with St. Nicholas Circle

Part 215 from a point 53 metres south of its junction with St. Nicholas Circle to a point 7 metres south of its junction with St. Nicholas Circle

Part 207 from a point 7 metres south of its junction with St. Nicholas Circle to its junction with St. Nicholas Circle
