THE LEICESTER (CONSOLIDATION) TRAFFIC REGULATION ORDER
2006 (AMENDMENT) (LOCAL ENVIRONMENTAL WORKS 12 – VARIOUS
SITES) (No.239) ORDER 2017

Leicester City Council (hereinafter referred to as "the Council") in exercise of their powers under Sections 1 and 2 of the Road Traffic Regulation Act 1984 ("the Act") and of Part IV of Schedule 9 to the Act and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act hereby make the following Order: -

1. This Order may be cited as the Leicester (Consolidation) Traffic Regulation Order 2006 (Amendment) (Local Environmental Works 12 Various sites) (No 239.) Order 2017, and shall be included among the Orders which may be cited as the Leicester (Consolidation) Traffic Regulation Order 2006 and shall come into force on the 11TH December 2017
2.
 - (i) The expression "the Principal Order" means "The Leicester (Consolidation) Traffic Regulation Order 2006" as amended.
 - (ii) Any document referring to the Principal Order shall be construed as referring to the Principal Order as amended by this Order.
3. The Principal Order shall be amended as follows:
 - (i) In Schedule 1 to the Principle Order revoke the existing Schedules relating to

Morley Road
St Saviours Hill
Wesley Street
 - (ii) In Schedule 1 to the Principal Order insert Schedule 1 hereto in appropriate alphabetical order
4. The Council hereby revoke all the restrictions in the Leicester (Consolidation) Traffic Regulation Order 1975 ("the 1975 Order") and its subsequent amendments in so far as they impose restrictions on the following roads. Restrictions imposed by the 1975 Order on other roads will remain in force.

Upper Charnwood Street
5. Nothing in this Order shall affect the principal Order in its operation in relation to contraventions committed before the commencement of this Order.

Part 100 from its junction with Vulcan Road to its junction with St Saviour's Hill in that direction

North-west Side

Part 207 from its junction with Vulcan Road to a point 4 metres north-east of its junction with Vulcan Road

South-east Side

Part 207 from its junction with St Saviour's Hill to a point 5 metres south-west of its junction with St Saviour's Hill

Part 207 from a point 9 metres north-east of a point in line with the north-west side of its junction with Vulcan Road to its junction with Vulcan Road

St Saviour's Hill

Part 100 from its junction with Morley Road to its junction with St Saviour's Road in that direction

North-west Side

Part 207 from its southern extremity to its junction with Morley Road

Part 207 from a point 6 metres south-west of its junction with St Saviour's Road to its junction with St Saviour's Road

South-east Side

Part 207 from its junction with St Saviour's Road to a point 6 metres south-west of its junction with St Saviour's Road

Upper Charnwood Street

Part 100 from its junction with Melbourne Street to its junction with Nedham Street

North-west Side

- Part 207 from its junction with Melbourne Street to a point 3 metres north-east of its junction with Melbourne Street
- Part 207 from a point 11 metres south-west of its junction with Nedham Street to its junction with Nedham Street
- Part 207 from its junction with Nedham Street to a point 5 metres north-east of its junction with Nedham Street
- Part 215 from a point 5 metres north-east of its junction with Nedham Street to a point 5 metres south-west of its junction with Vulcan Road
- Part 207 from a point 5 metres south-west of its junction with Vulcan Road to its junction with Vulcan Road

South-east Side

- Part 207 from its junction with Vulcan Road to a point 5 metres south-west of its junction with Vulcan Road
- Part 215 from a point 5 metres south-west of its junction with Vulcan Road to a point 5 metres north-east of its junction with Nedham Street
- Part 207 from a point 5 metres north-east of its junction with Nedham Street to its junction with Nedham Street
- Part 207 from its junction with Nedham Street to a point 33 metres south-west of its junction with Nedham Street
- Part 207 from a point 3 metres north-east of its junction with Holland Road to a point 2 metres south-west of its junction with Holland Road
- Part 207 from a point 3 metres north-east of its junction with Cecil Road to a point 2 metres south-west of its junction with Cecil Road
- Part 207 from a point 5 metres north-east of its junction with Melbourne Street to its junction with Melbourne Street

Wesley Street

North & East Side

- Part 207 from its junction with Thurcaston Road to a point 18 metres west of its eastern extremity
- Part 207 from a point 5 metres west of its eastern extremity to its eastern extremity

South & West Side

- Part 207 from its eastern extremity to a point 21 metres south of a point in line with the property boundary of Nos. 252 and 254 Beaumanor Road
- Part 215 from a point 21 metres south of a point in line with the property boundary of Nos. 252 and 254 Beaumanor Road to a point 3 metres south of a point in line with the property boundary of Nos. 252 and 254 Beaumanor Road
- Part 207 from a point 3 metres south of a point in line with the property boundary of Nos. 252 and 254 Beaumanor Road to its junction with Beaumanor Road
