THE LEICESTER (CONSOLIDATION) TRAFFIC REGULATION ORDER 2006 (AMENDMENT) (CHANCERY STREET) (No.234) ORDER 2017

Leicester City Council (the Council) in exercise of their powers under Section 1, 2, 32, 35, 45 and 46 of the Road Traffic Regulation Act 1984 (The Act) and of Part IV of Schedule 9 to the Act and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act hereby make the following Order:-

1. This Order may be cited as The Leicester (Consolidation) Traffic Regulation Order 2006 (Amendment) (Chancery Street) (No.234) Order 2017 and shall be included amongst the Orders which may be cited as The Leicester (Consolidation) Traffic Regulation Order 2006 and shall come into force on the 22 September 2017.
2.
 - (i) The expression "the Principal Order" means "the Leicester (Consolidation) Traffic Regulation Order 2006"
 - (ii) Any document referring to the Principal Order shall be construed as referring to the Principal Order as amended by this Order.
3. The Principal Order shall be amended as follows:
 - (i) In Schedule 1 to the Principal Order revoke existing Schedules relating to Chancery Street
 - (ii) In Schedule 1 to the Principal Order insert Schedule 1 to this Order in the appropriate alphabetical order.
4. Nothing in this Order shall affect the Principal Order in its operation in relation to contraventions committed before the commencement of this Order

SCHEDULE 1

CHANCERY STREET

- Part 239 Restricted Zone (no waiting and no loading/unloading at any time except in signed bays) from a point 55 metres north-east of its junction with Marble Street to its junction with Marble Street.

North-west side

- Part 207 from a point 55 metres north-east of its junction with Marble Street to its junction with Pocklingtons Walk.

South-east side

- Part 207 from its junction with Pocklingtons Walk to a point 10 metres south-west of its junction with Pocklingtons Walk.
- Part 211 from a point 10 metres south-west of its junction with Pocklingtons Walk to a point 24 metres south-west of its junction with Pocklingtons Walk.
- Part 207 from a point 24 metres south-west of its junction with Pocklingtons Walk to a point 55 metres north-east of its junction with Marble Street.
