THE LEICESTER (CONSOLIDATION) TRAFFIC REGULATION ORDER 2006 (AMENDMENT) (HUMBERSTONE GATE) (No.236) ORDER 2018

Leicester City Council (the Council) in exercise of their powers under Section 1, 2, 32, 35, 45 and 46 of the Road Traffic Regulation Act 1984 (The Act) and of Part IV of Schedule 9 to the Act and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act hereby make the following Order:-

1. This Order may be cited as The Leicester (Consolidation) Traffic Regulation Order 2006 (Amendment) (Humberstone Gate) (No.236) Order 2018 and shall be included amongst the Orders which may be cited as The Leicester (Consolidation) Traffic Regulation Order 2006 and shall come into force on the 13 April 2018.
2.
 - (i) The expression "the Principal Order" means "the Leicester (Consolidation) Traffic Regulation Order 2006"
 - (ii) Any document referring to the Principal Order shall be construed as referring to the Principal Order as amended by this Order.
3. The Principal Order shall be amended as follows:
 - (i) In Schedule 1 to the Principal Order revoke the existing Schedules relating to

Humberstone Gate
 - (ii) In Schedule 1 to the Principal Order insert Schedule 1 to this Order in the appropriate alphabetical order.
4. Nothing in this Order shall affect the Principal Order in its operation in relation to contraventions committed before the commencement of this Order

HUMBERSTONE GATE

- Part 101 Prohibited U Turn at its junction with Charles Street from the westbound to the eastbound carriageway
- Part 102 Prohibited Right Turn from Humberstone Gate into Rutland Street
- Part 127 Prohibition of entry and driving at any time all motor vehicles except permit holders and except loading Sunday to Friday 5am-11am Saturday 5am to 9am from its junctions with Gallowtree Gate to its junction with Charles Street
