THE LEICESTER TRAFFIC REGULATION (CONSOLIDATION) (UPPINGHAM ROAD) (AMENDMENT) ORDER 2019 NO 257.

Leicester City Council (the Council) in exercise of their powers under Section 32 and 35 of the Road Traffic Regulation Act 1984 (The Act) and of Part IV of Schedule 9 to the Act and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act hereby make the following Order:-

- 1. This Order may be cited as The Leicester Traffic Regulation (Consolidation) (Uppingham Road) (Amendment) Order (No) 2019 and shall be included amongst the Orders which may be cited as The Leicester (Consolidation) Traffic Regulation Order 2006 and shall come into force on the 9 October 2019
- 2. (i) The expression "the Principal Order" means "the Leicester (Consolidation) Traffic Regulation Order 2006"
 - (ii) Any document referring to the Principal Order shall be construed as referring to the Principal Order as amended by this Order.
- 3. The Principal Order shall be amended as follows:
 - In Schedule 1 to the Principal Order revoke the existing schedules relating to Uppingham Road
 - (ii) In Schedule 1 to the Principal Order insert Schedule 1 to this Order in the appropriate alphabetical order
- 4. Nothing in this Order shall affect the Principal Order in its operation in relation to contraventions committed before the commencement of this Order

TRAFFIC RESTRICTIONS

- Part 224 in the lay-by from a point 50 metres west of its junction with Turner Road to a point 23 metres west of its junction with Turner Road
- Part 200 from a point 55 metres north-west of its junction with Colchester Road to a point 10 metres south-east of its junction with Chrisett Close

Southern Side

- Part 204 from its junction with King Edward Road in a westerly direction to its junction with Trafford Road excluding the Lay-by areas
- Part 204 from its junction with Trafford Road in a westerly direction to its junction with Coleman Road excluding the lay-by area

Part 224	The lay-by located 2 metres east of its junction with Freeman Road North heading in an easterly direction for a distance of 17.5 metres
Part 224	The lay-by located 3 metres west of its junction with King Edward Road heading in a westerly direction for a distance of 21 metres
Part 309	The lay-by located 5.5 metres east of its junction with Trafford Road heading in an easterly direction for a distance of 21 metres
Part 224	The lay-by located 3 metres west of its junction with Trafford Road heading in a westerly direction for a distance of 26 metres
