ACCESS BETWEEN 10AM AND 3PM) ORDER 2025

WHEREAS the Leicestershire County Council (hereinafter referred to as "the Council") being the Traffic Authority for various roads in Melton Mowbray, including Nottingham Street, South Parade, Cheapside, Market Place and High Street is satisfied that traffic in the said roads should be restricted for public safety to allow Melton Borough Council to implement a safe pedestrianised area.

NOW, THEREFORE, the Council in exercise of the powers conferred by Section 14(1) of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers hereby makes the following Order:-

1. Save as provided in Article 2 of this Order no person shall cause or permit any vehicle to proceed along those lengths of roads as specified in Schedule 1 to this Order.
2. The provisions of Article 1 of this Order shall not have the effect of preventing access for more than eight hours in any period of twenty four hours for vehicles of any class to any premises situated on or adjacent to the roads mentioned in Article 1 or to any other premises accessible for such vehicles from and only from the said roads.
3. This Order shall come into force on the **11th day of March Two Thousand and Twenty Five** for a period of up to 12 months, and may be cited as "THE LEICESTERSHIRE COUNTY COUNCIL (VARIOUS ROADS, MELTON MOWBRAY) (TEMPORARY PROHIBITION OF VEHICULAR ACCESS BETWEEN 10AM AND 3PM) ORDER 2025"

Market Place from South Parade to Sherrard Street, Melton Mowbray

High Street from Wilton Road to Cheapside, Melton Mowbray
