The Leicestershire County Council ("the Council") in exercise of its powers under Sections 1 (1), 2 (1) 2 (2) 4 5 and Part IV of Schedule 9 of the Road Traffic Regulations Act 1984 ("the Act") and of all other enabling powers and after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act and Regulation 23 of the Local Authorities Traffic Order (Procedure) England and Wales Regulations 1996, hereby makes the following Order:-

- This Order may be cited as "The Leicestershire County Council (Lower Church Street, Ashby de la Zouch) (District of North West Leicestershire) (Prohibition of Vehicular Movements) Order 2019"
- 2. The Order shall come into force on the sixteenth day of November 2019
- "The County of Leicester (Urban District of Ashby de la Zouch) (Traffic Regulation) Order 1966" is hereby revoked in full.
- 4. No person shall, except upon the direction of or with the permission of a police officer, or a community support officer, cause or permit any vehicle to proceed along the length of road specified in Schedule 1 to this Order in a direction other than that specified in the said Schedule.

From its junction with Wood Street to its junction with South Street.


