

THE LEICESTERSHIRE COUNTY COUNCIL
(VARIOUS ROADS, CASTLE DONINGTON AND KEGWORTH
(AREA 1), DISTRICT OF NORTH WEST LEICESTERSHIRE)
CONSOLIDATION AND AMENDMENT ORDER 2009

The Leicestershire County Council ("the Council") in exercise of its powers under Sections 1(1) and 2(1) to (3) 4(2) 32 and 35 and Part IV of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers, hereby makes the following Order:-

1. This Order shall come into force on the Second day of November 2009 and may be cited as "The Leicestershire County Council (Various Roads, Castle Donington and Kegworth (Area 1), District of North West Leicestershire) Consolidation and Amendment Order 2009".
2. The exemptions contained in this Order as set out in column 1 of Schedule 1 shall hereafter be referred to by reference to the code letters given in column 2 of Schedule 1.
3. The Orders specified in Schedule 2 are hereby revoked and re-enacted in Schedule 3 without alteration to the restrictions imposed by those Orders.
4. The Order specified in Schedule 4 is hereby revoked to the extent indicated in the Schedule of that Order and re-enacted without alteration to the provisions imposed by the Order.
5. (1) In this Order –

"authorised cab rank" means any area of carriageway which is comprised within and indicated by a road marking complying with diagram 1028.2 in Schedule 6 of The Traffic Signs Regulations and General Directions 2002;

"authorised parking place" means any parking place on a road authorised or designated by an Order made or having effect as if made under the Act;

"bus" means any Public Service Vehicle or bus operating a local stage carriage service as defined in the Transport Act 1985;

"bus stop area" means any area of carriageway on the sides of roads specified in this Order which is comprised within and indicated by a road marking complying with either diagram 1025.2 or diagram 1025.3 to the Traffic Signs Regulations and General Directions 2002;

"C.E.O." mean a duly authorised Civil Enforcement Officer

"disabled person's badge" has the same meaning as in The Disabled Persons (Badges for Motor Vehicles)(Amendment) Regulations 1991; or the Disabled Persons (Badges for Motor Vehicles)(England) Regulations 2000 and the Local Authorities' Traffic Orders (Exemptions for Disabled Persons)(England) Regulations 2000;

"disabled person's vehicle" has the same meaning as in The Local Authorities' Traffic Orders (Exemption for Disabled Persons)(England and Wales)(Amendment) Regulations 1991;

"disabled persons designated parking bay" means the part of the carriageway or side of road marked in accordance with Schedule 6 of the Traffic Signs Regulations and General Directions 2002 by the marking shown in diagram 1028.3 (or permitted variant thereof) and with a white broken line bounding the words "DISABLED" marked outside the bay;

"hackney carriage" has the same meaning as in section 38(1) of the Vehicles (Excise) Act 1971;

"heavy commercial vehicle" has the same meaning as in Section 138 of the Act;

"market day" means any day of the week approved and authorised under a market charter for the holding of a market or such other bona fide licensed market;

"market trader" means any person duly authorised an appropriate body to trade from an authorised market stall or stand or location as from time to time may be specified by the appropriate body for the purposes of his or her trading;

"motor vehicle" means any vehicle as defined by the Construction and Use Regulations 1986 (as amended) which is mechanically propelled except where otherwise provided;

"parking disc" means a disc, issued by a local authority, complying with the requirements of the British Standard Specification for Parking Discs (BS No.4631:1970) but coloured orange, and capable of showing the quarter hour period during which a period of waiting begins, or a blue badge under the Disabled Persons (Badges for Motor Vehicles)(England) Regulations 2000;

"permitted parking place" means any part of a road hereby authorised by the Council for use as a parking place being a place where vehicles may wait and is indicated as such by signs and road markings;

"permit" means a written warrant issued by or on behalf of Leicestershire County Council allowing the holder to wait in a specified location;

"permit holder" means a vehicle which displays a valid permit;

"residents' parking permit holder / residents' permit holder" means a vehicle which displays a valid permit issued to a resident of the specified location;

"road / roads" means the carriageway the footway and any verges being the full width of the highway extent from one boundary to another;

"school entrance" means any area of carriageway on the side of the road where vehicles are not permitted to stop and indicated by a road marking complying with diagram 1027.1 of the 2002 Regulations;

"vehicle" means any Motor Vehicle as defined in this Order and any other vehicle (capable of the carriage of persons or goods) except cycles unless otherwise provided;

"4.00 p.m. to 10.00 a.m. the following morning" wherever referred to in this Order means that period of time commencing at 4.00 p.m. in the afternoon of any day and terminating at 10.00 a.m. on the morning of the next day;

"The Act" means The Road Traffic Regulation Act 1984.

- (2) For the purpose of this Order a vehicle shall be regarded as displaying a disabled person's badge in the relevant position, where in accordance with the Disabled Persons (Badges for Motor Vehicles) (Amendment) Regulations 1991 and the Disabled Persons (Badges for Motor Vehicles) (England) Regulations 2000
- (i) the Badge is displayed on the vehicle's dashboard or fascia panel with the front of the Badge facing forward with the details thereon clearly visible from an external position, or
 - (ii) where the vehicle has no dashboard or fascia panel or windscreen where the Badge may be exhibited or displayed it shall be exhibited in a conspicuous position on the front or near side of the vehicle and

in either case a parking disc is exhibited in the relevant position prescribed in the Disabled Persons (Badges for Motor Vehicles) (Amendment) Regulations 1991 or the Disabled Persons (Badges for Motor Vehicles) (England) Regulations 2000.

6. The following articles shall relate to the re-enacted provisions of Schedule 3 and are amended by the insertion of a reference to a "C.E.O." and by virtue of Section 32 and 35 of the Road Traffic Regulation Act 1984 where appropriate to create permitted parking places.

7.1 No person shall, except upon the direction or with the permission of a police officer in uniform, a community support officer, a parking attendant or a C.E.O., cause or permit any vehicle to wait between the hours of 8.00 a.m. and 6.30 p.m. on any day other than on a Sunday, in the permitted parking place specified in Schedule 3 Part 1 to this Order:-

- (a) For a period longer than 1 hour, or
- (b) If a period of less than 1 hour has elapsed since the last period of waiting by that vehicle in the same permitted parking place;

7.2 No person shall, except upon the direction or with the permission of a police officer in uniform, a community support officer, a parking attendant or a C.E.O., cause or permit any vehicle to wait between the hours of 8.00 a.m. and 6.00 p.m. on any day other than a Sunday, in the permitted parking place specified in Schedule 3 Part 2 to this Order:-

- (a) For a period longer than 1 hour; or
- (b) If a period of less than 1 hour has elapsed since the last period of waiting by that vehicle in the same permitted parking place;

7.3 No person shall, except upon the direction or with the permission of a police officer in uniform, a community support officer, a parking attendant or a C.E.O., cause or permit any vehicle to wait between the hours of 8.00 a.m. and 6.30 p.m. on any day other than on a Sunday, in the permitted parking place specified in Schedule 3 Part 3 to this Order:-

- (a) For a period longer than 4 hours, or
- (b) If a period of less than 2 hours has elapsed since the last period of waiting by that vehicle in the same permitted parking place;

7.4 No person shall, except upon the direction or with the permission of a police officer in uniform, a community support officer, a parking attendant or a C.E.O., cause or permit any vehicle to wait at any time in the permitted parking place specified in Schedule 3 Part 4 to this Order, except for disabled persons vehicle.

7.5 No person shall, except upon the direction or with the permission of a police officer in uniform, a community support officer, a parking attendant or a C.E.O., cause or permit any vehicle to wait between the hours of 8.00 a.m. and 6.00 p.m. on any day other than a Sunday, in the permitted parking place specified in Schedule 3 Part 5 to this Order, except for disabled persons vehicle.

7.6 No person shall, except upon the direction or with the permission of a police officer in uniform, a community support officer, a parking attendant or a C.E.O., or in accordance with the exemption provisions, cause or permit any vehicle to wait at any time on any day, on the sides of road specified in Schedule 3 Part 6 to this Order.

7.7 No person shall, except upon the direction or with the permission of a police officer in uniform, a community support officer, a parking attendant or a C.E.O., or in accordance with the

exemption provisions, cause or permit any vehicle to wait between the hours of 8.00 a.m. and 6.30 p.m. on any day other than a Sunday, on the sides of road specified in Schedule 3 Part 7 to this Order.

8. Except where otherwise stated, a reference in this order to a numbered Article or Schedule is reference to the Article or Schedule bearing that number in this Order.

For a disabled person's vehicle which displays in the relevant position a disabled person's badge, and a parking disc (on which the driver, or other person in charge of the vehicle, has marked the time at which the period of waiting began) to wait on the sides of roads referred to in that Article for a period not exceeding three hours (not being a period separated by an interval of less than one hour from a previous period of waiting by the same vehicle on the same side of road on the same day) provided that no such vehicle shall wait in any length of road where there is for the time being a prohibition of loading and unloading. For vehicles to wait on the sides of roads referred to therein for so long as may be necessary while any gate or other barrier at the entrance to premises to which the vehicle requires access or from which it has just emerged is being opened or closed, if it is not reasonably practicable for the vehicle to wait otherwise than in that road while such a gate or barrier is opened or closed. For any disabled person's vehicle which displays in the relevant position a disabled person's badge and a parking badge (on which the driver or other person in charge of the vehicle has marked the time at which waiting began) to wait, load or unload in those parts of the road specified in the schedule to this order for a period not exceeding 3 hours, with no return within 3 hours. If the vehicle is being used to attend any of the properties numbered 2-30 Mantle Lane, but for the purposes of loading/unloading of goods or equipment at such property only.	LCCT

BOROUGH STREET, CASTLE DONINGTON

- (i) The north-west side from a point 13.5 metres north-east the boundary of Nos. 25 Market Street / Nos. 1 Borough Street in a north-easterly direction for a distance of 102 metres.
- (ii) The north-west side from a point 30 metres north-east of the boundary of Nos. 45/47 Borough Street in a north-easterly direction for a distance of 24.5 metres.
- (iii) The south-east side from a point 19 metres north-east of its junction with St Annes Lane in a north-easterly direction for a distance of 87 metres.
- (iv) The south-east side from a point 2 metres north-east of its junction with Church Lane in a north-easterly direction for a distance of 17 metres.

MARKET STREET, CASTLE DONINGTON

The north-west side from a point 8 metres north-west of its junction with Bondgate in a north-easterly direction for a distance of 97 metres.

- (i) The north-west side from a point 115.5 metres north-east of the boundary of Nos. 25 Market Street / Nos. 1 Borough Street in a north-easterly direction for a distance of 6.5 metres.
- (ii) The south-east side from a point 19 metres north-east of its junction with Church Lane in a north-easterly direction for a distance of 5 metres.
- (iii) The south-east side from a point 13.5 metres north-east of its junction with St Annes Lane in a north-easterly direction for a distance of 5.5 metres.

BROADHILL ROAD, KEGWORTH

Both sides from its junction with Ashby Road and High Street in a southerly direction for a distance of 36 metres.

CHURCH GATE, KEGWORTH

- (i) The north-east side from its junction with Dragwell in a south-easterly direction for a distance of 41 metres.
- (ii) The south-west side from its junction with The Croft in a north-westerly direction for a distance of 7 metres.

CHURCH LANE, CASTLE DONINGTON

- (i) The north side from its junction with Borough Street in a south-easterly direction for a distance of 34 metres.
- (ii) The north side from its junction with Clapgun Street in a north-westerly direction for a distance of 12 metres.
- (iii) The south side from its junction with Clapgun Street in a north-westerly direction to its junction with Borough Street.

CLAPGUN STREET, CASTLE DONINGTON

- (i) The east side from a point 3 metres north of its junction with St Anne's Lane in a northerly direction for a distance of 59 metres.
- (ii) The east side from a point 9 metres north of its junction with Apiary Gate in a northerly direction to a point 3 metres north of its junction with St. Anne's Lane.
- (iii) The east side from its junction with The Hollow in a southerly direction for a distance of 33 metres.
- (iv) The west side from its junction with St Anne's Lane to its junction with The Hollow.

DELVEN LANE, CASTLE DONINGTON

- (i) The north side from its junction with Dovecote to a point 30 metres west of its junction with Dovecote.
- (ii) The north side from its junction with High Street in a south-easterly direction for a distance of 47 metres.

(iii) The south side from a point 23 metres west of the centreline of its junction with Dovecote in a westerly direction for a distance of 41 metres.

(iv) The south side from a point opposite the centreline of Dovecote to a point 23 metres west of a point opposite the centreline of Dovecote.

(v) The south side from its junction with High Street in a south-easterly direction for a distance of 44 metres.

DERBY ROAD, KEGWORTH

(i) The north-east side between its junction with Borough Street and a point 117 metres north-west of that junction.

(ii) The north-east side from its junction with Borough Street to its junction with Dragwell.

(iii) The south-west side from its junction with High Street to a point 344 metres north-west of that junction.

DRAGWELL, KEGWORTH

(i) Both sides from a point 76 metres from of its junction with Nottingham Road, in a south-westerly direction for a distance of approximately 38 metres.

(ii) Both sides from a point 114 metres south-west of its junction with Nottingham Road in a south-westerly direction to its junction with Church Gate.

(iii) The north-west side from a point 70 metres south-west of its junction with Nottingham Road in a south-westerly direction for a distance of 6 metres.

(iv) The south-east side from a point 62 metres south-west of its junction with Nottingham Road in a south-westerly direction for a distance of 14 metres.

HIGH STREET, CASTLE DONINGTON

(i) The south-east side from its junction with the southern arm of Delven Lane in a south-westerly direction for a distance of 64 metres.

- (ii) The west side from its junction with Park Lane in a southerly direction for a distance of 428 metres.

HIGH STREET, KEGWORTH

- (i) The north side from its junction with Church Gate in a westerly direction for a distance of 27 metres.
- (ii) The north side from a point 27 metres west of its junction with Church Gate in a westerly direction to its junction with Packington Hill.
- (iii) The south side from its junction with Derby Road in a westerly direction for a distance of 26 metres.
- (iv) The south side from the centreline of Broadhill Road in an easterly direction for a distance of 42 metres.
- (v) The south side from a point 14 metres east of its junction with Pleasant Place in a westerly direction to a point 11 metres west of that junction.

MARKET PLACE, KEGWORTH

- (i) The north-east side from a point 41 metres south-east of its junction with Dragwell to a point 29 metres west of the western boundary of No. 26 Market Place.
- (ii) The west side from its junction with Church Gate in a southerly direction for a distance of 4 metres.

MARKET STREET, CASTLE DONINGTON

- (i) The north side from its junction with Bondgate in an easterly direction for a distance of 8 metres.
- (ii) The north-west side from a point 122 metres from its junction with Bondgate in a north-easterly direction for a distance of 18 metres to a point adjacent the north east corner of property 25 Market Street.
- (iii) The south side from its junction with Bondgate in an easterly direction for a distance of 14 metres.

- (iv) The south-east side from a point 8 metres north-east of its junction with Apiary Gate in a north-easterly direction to its junction with St Annes Lane.

MOUNT PLEASANT, CASTLE DONINGTON

- (i) The north side from its junction with Dovecote to a point 27 metres east of its junction with Dovecote.
- (ii) The south side from a point opposite the centreline of Dovecote to a point 16 metres east of a point opposite the centreline of Dovecote.

NEW STREET, KEGWORTH

- (i) The east side from its junction with Station Road in a southerly then south-westerly direction to a point 2 metres south-west of the south-western boundary of No. 26 New Street a distance of 45 metres.
- (ii) The north-east side adjacent to No. 70 Station Road from the southern kerb line of Station Road in a southerly direction for a distance of 12 metres.
- (iii) The south-west side adjacent to No. 70 Station Road from the southern kerb line of Station Road in a southerly direction for a distance of 14 metres.
- (iv) The west side adjacent to No. 104 Station Road from the southern kerb line of Station Road in a southerly direction for a distance of 8 metres.
