

THE LEICESTERSHIRE COUNTY COUNCIL
(VARIOUS ROADS, ASHBY DE LA ZOUCH (AREA 3),
DISTRICT OF NORTH WEST LEICESTERSHIRE)
CONSOLIDATION AND AMENDMENT ORDER 2009

The Leicestershire County Council ("the Council") in exercise of its powers under Sections 1(1) and 2(1) to (3) 4(2) 32 and 35 and Part IV of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers, hereby makes the following Order:-

1. This Order shall come into force on the Second day of November 2009 and may be cited as "The Leicestershire County Council (Various Roads, Ashby De La Zouch (Area 3), District of North West Leicestershire) Consolidation and Amendment Order 2009".
2. The exemptions contained in this Order as set out in column 1 of Schedule 1 shall hereafter be referred to by reference to the code letters given in column 2 of Schedule 1.
3. The Orders specified in Schedule 2 are hereby revoked and re-enacted in Schedule 3 without alteration to the restrictions imposed by those Orders.
4. The Order specified in Schedule 4 is hereby revoked to the extent indicated in the Schedule of that Order and re-enacted without alteration to the provisions imposed by the Order
5. (1) In this Order –

"authorised cab rank" means any area of carriageway which is comprised within and indicated by a road marking complying with diagram 1028.2 in Schedule 6 of The Traffic Signs Regulations and General Directions 2002;

"authorised parking place" means any parking place on a road authorised or designated by an Order made or having effect as if made under the Act;

"bus" means any Public Service Vehicle or bus operating a local stage carriage service as defined in the Transport Act 1985;

"bus stop area" means any area of carriageway on the sides of roads specified in this Order which is comprised within and indicated by a road marking complying with either diagram 1025.2 or diagram 1025.3 to the Traffic Signs Regulations and General Directions 2002;

"C.E.O." mean a duly authorised Civil Enforcement Officer

"disabled person's badge" has the same meaning as in The Disabled Persons (Badges for Motor Vehicles)(Amendment) Regulations 1991; or the Disabled Persons (Badges for Motor Vehicles)(England) Regulations 2000 and the Local Authorities' Traffic Orders (Exemptions for Disabled Persons)(England) Regulations 2000;

"disabled person's vehicle" has the same meaning as in The Local Authorities' Traffic Orders (Exemption for Disabled Persons)(England and Wales)(Amendment) Regulations 1991;

"disabled persons designated parking bay" means the part of the carriageway or side of road marked in accordance with Schedule 6 of the Traffic Signs Regulations and General Directions 2002 by the marking shown in diagram 1028.3 (or permitted variant thereof) and with a white broken line bounding the words "DISABLED" marked outside the bay;

"hackney carriage" has the same meaning as in section 38(1) of the Vehicles (Excise) Act 1971;

"heavy commercial vehicle" has the same meaning as in Section 138 of the Act;

"market day" means any day of the week approved and authorised under a market charter for the holding of a market or such other bona fide licensed market;

"market trader" means any person duly authorised an appropriate body to trade from an authorised market stall or stand or location as from time to time may be specified by the appropriate body for the purposes of his or her trading;

"motor vehicle" means any vehicle as defined by the Construction and Use Regulations 1986 (as amended) which is mechanically propelled except where otherwise provided;

"parking disc" means a disc, issued by a local authority, complying with the requirements of the British Standard Specification for Parking Discs (BS No.4631:1970) but coloured orange, and capable of showing the quarter hour period during which a period of waiting begins, or a blue badge under the Disabled Persons (Badges for Motor Vehicles)(England) Regulations 2000;

"permitted parking place" means any part of a road hereby authorised by the Council for use as a parking place being a place where vehicles may wait and is indicated as such by signs and road markings;

"permit" means a written warrant issued by or on behalf of Leicestershire County Council allowing the holder to wait in a specified location;

"permit holder" means a vehicle which displays a valid permit;

"residents' parking permit holder / residents' permit holder" means a vehicle which displays a valid permit issued to a resident of the specified location;

"road / roads" means the carriageway the footway and any verges being the full width of the highway extent from one boundary to another;

"school entrance" means any area of carriageway on the side of the road where vehicles are not permitted to stop and indicated by a road marking complying with diagram 1027.1 of the 2002 Regulations;

"vehicle" means any Motor Vehicle as defined in this Order and any other vehicle (capable of the carriage of persons or goods) except cycles unless otherwise provided;

"4.00 p.m. to 10.00 a.m. the following morning" wherever referred to in this Order means that period of time commencing at 4.00 p.m. in the afternoon of any day and terminating at 10.00 a.m. on the morning of the next day;

"The Act" means The Road Traffic Regulation Act 1984.

- (2) For the purpose of this Order a vehicle shall be regarded as displaying a disabled person's badge in the relevant position, where in accordance with the Disabled Persons (Badges for Motor Vehicles) (Amendment) Regulations 1991 and the Disabled Persons (Badges for Motor Vehicles) (England) Regulations 2000
- (i) the Badge is displayed on the vehicle's dashboard or fascia panel with the front of the Badge facing forward with the details thereon clearly visible from an external position, or
 - (ii) where the vehicle has no dashboard or fascia panel or windscreen where the Badge may be exhibited or displayed it shall be exhibited in a conspicuous position on the front or near side of the vehicle and

in either case a parking disc is exhibited in the relevant position prescribed in the Disabled Persons (Badges for Motor Vehicles) (Amendment) Regulations 1991 or the Disabled Persons (Badges for Motor Vehicles) (England) Regulations 2000.

6. The following articles shall relate to the re-enacted provisions of Schedule 3 and are amended by the insertion of a reference to a "C.E.O." and by virtue of Section 32 and 35 of the Road Traffic Regulation Act 1984 where appropriate to create permitted parking places

7.1 No person shall, except upon the direction or with the permission of a police officer in uniform, a community support officer, a parking attendant or a C.E.O., cause or permit any vehicle to wait between the hours of 8.00 a.m. and 6.30 p.m. on any day other than on a Sunday, in the permitted parking place specified in Schedule 3 Part 1 to this Order:-

- (a) For a period longer than 1 hour, or
- (b) If a period of less than 1 hour has elapsed since the last period of waiting by that vehicle in the same permitted parking place;

7.2 No person shall, except upon the direction or with the permission of a police officer in uniform, a community support officer, a parking attendant or a C.E.O., cause or permit any vehicle to

wait between the hours of 8.00 a.m. and 6.00 p.m. on any day other than a Sunday, in the permitted parking place specified in Schedule 3 Part 2 to this Order:-

(a) For a period longer than 2 hours, or

(b) If a period of less than 2 hours has elapsed since the last period of waiting by that vehicle on the same permitted parking place;

7.3 No person shall, except upon the direction or with the permission of a police officer in uniform, a community support officer, a parking attendant or a C.E.O., cause or permit any vehicle to wait on any day, in the permitted parking place specified in Schedule 3 Part 3 to this Order:-

(a) For a period longer than 6 hours, or

(b) If a period of less than 24 hours has elapsed since the last period of waiting by that vehicle on the same permitted parking place;

7.4 No person shall, except upon the direction or with the permission of a police officer in uniform, a community support officer, a parking attendant or a C.E.O., cause or permit any vehicle to wait between the hours of 8.00 a.m. and 6.00 p.m. on any day other than a Sunday, in the permitted parking place specified in Schedule 3 Part 4 to this Order, except for disabled persons vehicle.

7.5 No person shall, except upon the direction or with the permission of a police officer in uniform, a community support officer, a parking attendant or a C.E.O., or in accordance with the exemption provisions, cause or permit any vehicle to wait between the hours of 9.00 p.m. and midnight and midnight and 2.00 a.m. on any day and between the hours of 8.00 a.m. and 9.30 a.m. and 4.30 p.m. and 6.30 p.m. on any day other than a Sunday, for the purpose of enabling goods to be loaded or unloaded from the vehicle on the sides of road specified in Schedule 3 Part 5 to this Order.

7.6 No person shall, except upon the direction or with the permission of a police officer in uniform, a community support officer, a parking attendant or a C.E.O., or in accordance with the exemption provisions, cause or permit any vehicle to wait between the hours of 8.00 a.m. and 9.30 a.m. and 4.30 p.m. and 6.30 p.m. on any day other than a Sunday, for the purpose of enabling goods to be loaded or unloaded from the vehicle on the sides of road specified in Schedule 3 Part 6 to this Order.

- 7.7 No person shall, except upon the direction or with the permission of a police officer in uniform, a community support officer, a parking attendant or a C.E.O., or in accordance with the exemption provisions, cause or permit any vehicle to wait at any time on any day, on the sides of road specified in Schedule 3 Part 7 to this Order.
- 7.8 No person shall, except upon the direction or with the permission of a police officer in uniform, a community support officer, a parking attendant or a C.E.O., or in accordance with the exemption provisions, cause or permit any vehicle to wait between the hours of 2.00 a.m. and 9.00 p.m. on any day on the sides of road specified in Schedule 3 Part 8 to this Order.
- 7.9 No person shall, except upon the direction or with the permission of a police officer in uniform, a community support officer, a parking attendant or a C.E.O., or in accordance with the exemption provisions, cause or permit any vehicle to wait between the hours of 8.00 a.m. and 6.30 p.m. on any day other than a Sunday, on the sides of road specified in Schedule 3 Part 9 to this Order.
- 7.10 No person shall, except upon the direction or with the permission of a police officer in uniform, a community support officer, a parking attendant or a C.E.O., or in accordance with the exemption provisions, cause or permit any vehicle to stop or wait between the hours of 9.00 p.m. and midnight and midnight and 2.00 a.m. on any day, except for any licensed hackney carriage or taxi, on the sides of road specified in Schedule 3 Part 10 to this Order.

8. Except where otherwise stated, a reference in this order to a numbered Article or Schedule is reference to the Article or Schedule bearing that number in this Order

MARKET STREET, ASHBY-DE-LA-ZOUCH

- (i) The north side from a point 37 metres east of its junction with Market Street in an easterly direction for a distance of 14 metres.

- (ii) The north-west side from a point 53 metres north-east of its junction with Brook Street to a point 123 metres north-east of its junction with Brook Street.

- (iii) The north-west side from a point 87 metres south-west of its junction with Lower Church Street in a south-westerly direction for a distance of 10 metres.

- (iv) The south-east side from a point 1 metre south-west of a point outside the boundary of Nos. 72 and 74 Market Street in a south-westerly direction for a distance of 51 metres.

- (v) The south-east side from a point 23 metres north-east of a point outside the south-western boundary of No. 34 Market Street in a south-westerly direction.

- (vi) The south-east side from a point 51 metres north-east of the centreline of its junction with Brook Street in a north-easterly direction for a distance of 12 metres.

- (ii) The north side the lay by on the eastbound carriageway of the Ashby Bypass (A511), in the Parish of Ashby de la Zouch. The centre of which is located in the north verge of the bypass, approximately 455 metres east of the centre of the roundabout at Ashby Road, Boundary for the length of the lay by where parking is facilitated at the rear of the lay by for approximately 100 metres

- (iii) The south-east side from a point outside the north-eastern boundary of the public house/No 56 Market Street in a south-westerly direction for a distance of 6 metres.

(iii) The south side from its junction with Bath Street to a point 6 metres east of a point outside the boundary of Nos. 10 and 12 Market Street.

(iv) The south-east side from a point 114 metres south-west of the centreline of its junction with Lower Church Street in a south-westerly direction for a distance of 23 metres.

WOOD STREET, ASHBY-DE-LA-ZOUCH

- (i) The north side from the centreline of its junction with Lower Church Street to a point of 95 metres north-east of its junction with Upper Church Street.

- (iii) The south-east side from its junction with Lower Church Street to a point 28 metres north-east of its junction with Upper Church Street.

A511 ASHBY ROAD, COLEORTON

- (i) The south-west side from its junction with Coalfield Way in a south-easterly direction for a distance of 10 metres.

- (ii) The south-west side from its junction with Coalfield Way in a north-westerly direction for a distance of 10 metres.

ASHBY BYPASS (A511), ASHBY-DE-LA-ZOUCH

- (i) The lay by on the eastbound carriageway of the Ashby Bypass (A511), in the Parish of Ashby de la Zouch. The centre of which is located in the north verge of the bypass, approximately 455 metres east of the centre of the roundabout at Ashby Road, Boundary.

- (ii) The lay by on the westbound carriageway of the Ashby Bypass (A511), in the Parish of Ashby de la Zouch. The centre of which is located in the south verge of the bypass, approximately 580 metres west of the centre of the roundabout at Smisby Road, Ashby.

AVENUE ROAD, ASHBY-DE-LA-ZOUCH

Both sides from its junction with Tamworth Road for a distance of 20 metres in a south-easterly direction.

BATH STREET, ASHBY-DE-LA-ZOUCH

The east side from the centreline of South Street in a northerly direction for a distance of 12 metres.

BROOK STREET, ASHBY-DE-LA-ZOUCH

(i) The north-east side from its junction with Market Street in a north-westerly direction for a distance of 22 metres.

(ii) The south-west side from its junction with Market Street in a north-westerly direction for a distance of 20 metres.

BURTON ROAD, ASHBY-DE-LA-ZOUCH

(i) Both sides from its junction with Derby Road in a westerly direction for a distance of 94 metres.

(ii) Both sides from a point 94 metres west of its junction with Derby Road in a generally westerly direction to a point 1 metre west of the boundary of Nos. 56 and 56a.

CLIFTON AVENUE, ASHBY-DE-LA-ZOUCH

Both sides from its junction with Smisby Road in a south-westerly direction for a distance of 4 metres.

COALFIELD WAY, ASHBY-DE-LA-ZOUCH

(i) The north-west side from its junction with A511 Ashby Road in a south-westerly direction for a distance of 25 metres.

(ii) The north-west side from its junction with Smithy Road in a north-easterly direction for a distance of 91 metres.

(iii) The south & south-east side from its junction with A511 Ashby Road for its entire length to its southern extremity (an approximate distance of 603 metres).
