

THE LEICESTERSHIRE COUNTY COUNCIL
(VARIOUS ROADS, IBSTOCK (AREA 4), DISTRICT OF NORTH WEST LEICESTERSHIRE)
CONSOLIDATION AND AMENDMENT ORDER 2009

The Leicestershire County Council ("the Council") in exercise of its powers under Sections 1(1) and 2(1) to (3) 4(2) 32 and 35 and Part IV of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers, hereby makes the following Order:-

1. This Order shall come into force on the Second day of November 2009 and may be cited as "The Leicestershire County Council (Various Roads, Ibstock (Area 4), District of North West Leicestershire) Consolidation and Amendment Order 2009".
2. The exemptions contained in this Order as set out in column 1 of Schedule 1 shall hereafter be referred to by reference to the code letters given in column 2 of Schedule 1.
3. The Orders specified in Schedule 2 are hereby revoked and re-enacted in Schedule 3 without alteration to the restrictions imposed by those Orders.
4. The Order specified in Schedule 4 is hereby revoked to the extent indicated in the Schedule of that Order and re-enacted without alteration to the provisions imposed by the Order
5. (1) In this Order –

"authorised cab rank" means any area of carriageway which is comprised within and indicated by a road marking complying with diagram 1028.2 in Schedule 6 of The Traffic Signs Regulations and General Directions 2002;

"authorised parking place" means any parking place on a road authorised or designated by an Order made or having effect as if made under the Act;

"bus" means any Public Service Vehicle or bus operating a local stage carriage service as defined in the Transport Act 1985;

"bus stop area" means any area of carriageway on the sides of roads specified in this Order which is comprised within and indicated by a road marking complying with either diagram 1025.2 or diagram 1025.3 to the Traffic Signs Regulations and General Directions 2002;

"C.E.O." mean a duly authorised Civil Enforcement Officer

"disabled person's badge" has the same meaning as in The Disabled Persons (Badges for Motor Vehicles)(Amendment) Regulations 1991; or the Disabled Persons (Badges for Motor Vehicles)(England) Regulations 2000 and the Local Authorities' Traffic Orders (Exemptions for Disabled Persons)(England) Regulations 2000;

"disabled person's vehicle" has the same meaning as in The Local Authorities' Traffic Orders (Exemption for Disabled Persons)(England and Wales)(Amendment) Regulations 1991;

"disabled persons designated parking bay" means the part of the carriageway or side of road marked in accordance with Schedule 6 of the Traffic Signs Regulations and General Directions 2002 by the marking shown in diagram 1028.3 (or permitted variant thereof) and with a white broken line bounding the words "DISABLED" marked outside the bay;

"hackney carriage" has the same meaning as in section 38(1) of the Vehicles (Excise) Act 1971;

"heavy commercial vehicle" has the same meaning as in Section 138 of the Act;

"market day" means any day of the week approved and authorised under a market charter for the holding of a market or such other bona fide licensed market;

"market trader" means any person duly authorised an appropriate body to trade from an authorised market stall or stand or location as from time to time may be specified by the appropriate body for the purposes of his or her trading;

"motor vehicle" means any vehicle as defined by the Construction and Use Regulations 1986 (as amended) which is mechanically propelled except where otherwise provided;

"parking disc" means a disc, issued by a local authority, complying with the requirements of the British Standard Specification for Parking Discs (BS No.4631:1970) but coloured orange, and capable of showing the quarter hour period during which a period of waiting begins, or a blue badge under the Disabled Persons (Badges for Motor Vehicles)(England) Regulations 2000;

"permitted parking place" means any part of a road hereby authorised by the Council for use as a parking place being a place where vehicles may wait and is indicated as such by signs and road markings;

"permit" means a written warrant issued by or on behalf of Leicestershire County Council allowing the holder to wait in a specified location;

"permit holder" means a vehicle which displays a valid permit;

"residents' parking permit holder / residents' permit holder" means a vehicle which displays a valid permit issued to a resident of the specified location;

"road / roads" means the carriageway the footway and any verges being the full width of the highway extent from one boundary to another;

"school entrance" means any area of carriageway on the side of the road where vehicles are not permitted to stop and indicated by a road marking complying with diagram 1027.1 of the 2002 Regulations;

"vehicle" means any Motor Vehicle as defined in this Order and any other vehicle (capable of the carriage of persons or goods) except cycles unless otherwise provided;

"4.00 p.m. to 10.00 a.m. the following morning" wherever referred to in this Order means that period of time commencing at 4.00 p.m. in the afternoon of any day and terminating at 10.00 a.m. on the morning of the next day;

"The Act" means The Road Traffic Regulation Act 1984.

- (2) For the purpose of this Order a vehicle shall be regarded as displaying a disabled person's badge in the relevant position, where in accordance with the Disabled Persons (Badges for Motor Vehicles) (Amendment) Regulations 1991 and the Disabled Persons (Badges for Motor Vehicles) (England) Regulations 2000
- (i) the Badge is displayed on the vehicle's dashboard or fascia panel with the front of the Badge facing forward with the details thereon clearly visible from an external position, or
 - (ii) where the vehicle has no dashboard or fascia panel or windscreen where the Badge may be exhibited or displayed it shall be exhibited in a conspicuous position on the front or near side of the vehicle and

in either case a parking disc is exhibited in the relevant position prescribed in the Disabled Persons (Badges for Motor Vehicles) (Amendment) Regulations 1991 or the Disabled Persons (Badges for Motor Vehicles) (England) Regulations 2000.

6. The following articles shall relate to the re-enacted provisions of Schedule 3 and are amended by the insertion of a reference to a "C.E.O." and by virtue of Section 32 and 35 of the Road Traffic Regulation Act 1984 where appropriate to create permitted parking places.

- 7.1 No person shall, except upon the direction or with the permission of a police officer in uniform, a community support officer, a parking attendant or a C.E.O., cause or permit any vehicle to wait between the hours of 8.00 a.m. and 6.00 p.m. on any day other than a Sunday, in the permitted parking place specified in Schedule 3 Part 1 to this Order:-
- (a) For a period longer than 1 hour; or
 - (b) If a period of less than 1 hour has elapsed since the last period of waiting by that vehicle in the same permitted parking place;

- 7.2 No person shall, except upon the direction or with the permission of a police officer in uniform, a community support officer, a parking attendant or a C.E.O., cause or permit any vehicle to wait on any day, in the permitted parking place specified in Schedule 3 Part 2 to this Order:-
- (a) For a period longer than 12 hours, or
 - (b) If a period of less than 24 hours has elapsed since the last period of waiting by that vehicle on the same permitted parking place;
- 7.3 No person shall, except upon the direction or with the permission of a police officer in uniform a traffic warden a community support officer, a parking attendant or a C.E.O., cause or permit any vehicle to wait on any day, in the permitted parking place specified in Schedule 3 Part 3 to this Order:-
- (a) For a period longer than 15 minutes, or
 - (b) If a period of less than 45 minutes has elapsed since the last period of waiting by that vehicle on the same permitted parking place;
- 7.4 No person shall, except upon the direction or with the permission of a police officer in uniform, a community support officer, a parking attendant or a C.E.O., cause or permit any vehicle to wait between the hours of 8.00 a.m. and 6.00 p.m. on any day other than a Sunday, in the permitted parking place specified in Schedule 3 Part 4 to this Order:-
- (a) For a period longer than 40 minutes, or
 - (b) If a period of less than 20 minutes has elapsed since the last period of waiting by that vehicle on the same permitted parking place;
- 7.5 No person shall, except upon the direction or with the permission of a police officer in uniform, a community support officer, a parking attendant or a C.E.O., or in accordance with the exemption provisions, cause or permit any vehicle to wait at any time on any day, on the sides of road specified in Schedule 3 Part 5 to this Order.
- 7.6 No person shall, except upon the direction or with the permission of a police officer in uniform, a community support officer, a parking attendant or a C.E.O., or in accordance with the exemption provisions, cause or permit any vehicle to wait between the hours of 8.00 a.m. and 6.00 p.m. on any day other than a Sunday, on the sides of road specified in Schedule 3 Part 6 to this Order.

8. Except where otherwise stated, a reference in this order to a numbered Article or Schedule is reference to the Article or Schedule bearing that number in this Order

ASHBY ROAD, IBSTOCK

- (i) Both sides from its junction with Melbourne Road (A447) in a westerly direction to the 30 m.p.h. signs a distance of 171 metres.

- (ii) The north side from its junction with Melbourne Road (A447) in an easterly direction to a point 3 metres east of the boundary between Nos. 35 and 33 Ashby Road, a distance of 88 metres.

- (iii) The south side from its junction with Melbourne Road (A447) in an easterly direction to its junction with Chapel Street, a distance of 185 metres.

CENTRAL AVENUE, IBSTOCK

Both sides one from a point 97 metres north of the centreline of Curzon Street in a northerly direction for a distance of 10 metres and one from a point on the boundary of properties 63/65 Chapel Street in a southerly direction for a distance of 9 metres.

CURZON STREET, IBSTOCK

(i) The north side from and including its junction with High Street and Chapel Street in a north-easterly direction to a point located 27 metres south-west of the centreline of Copson Street, a distance of some 31 metres from the boundary between No. 2 Curzon Street and No. 1 High Street.

(ii) The south side from and including its junction with High Street and Chapel Street in a north-easterly direction to a point located 28 metres south-west of the centreline of Copson Street, a distance of 31 metres from the boundary between No. 2 Curzon Street and No. 1 High Street.

GLADSTONE STREET, IBSTOCK

(i) The east side from its junction with High Street in a northerly direction for a distance of 31 metres.

(ii) The west side from its junction with High Street in a northerly direction for a distance of 33 metres.

GRANGE ROAD, IBSTOCK

Both sides from its junction with High Street in a south-easterly direction for a distance of 15 metres.

HARRATTS CLOSE, IBSTOCK

Both sides from a line produced along the north-western kerb line of High Street at its junction with High Street in a northerly direction for a distance of 20 metres.

HIGH STREET, IBSTOCK

(i) The north-west side from a point 57 metres west of the centreline of Harratts Close in a westerly direction for a distance of 6 metres.

(ii) The north-west side from a point 69 metres west of the centreline of Harratts Close in a westerly direction for a distance of 23 metres.

(iii) The north-west side from a point 98 metres west of the centreline of Harratts Close in a westerly direction for a distance of 8 metres.

- (iv) The north-west side from and including its junction with Chapel Street and Curzon Street in a south-westerly direction to a point located 10 metres south-west of the boundary between Nos. 4 and 6 High Street, a distance of some 45 metres from the boundary between No. 2 Curzon Street and No. 1 High Street.
- (v) The north-west side from a point 33 metres west of the centreline of Harratts Close in a westerly direction for a distance of 6 metres.
- (vi) The north-west side from a point 128 metres west of the centreline of Harratts Close in a westerly direction for a distance of 15 metres.
- (vii) The north-west side from a point 181 metres west of the centreline of Harratts Close in a westerly direction for a distance of 35 metres up to the centreline of Gladstone Street.
- (viii) The north-west side from the centreline of Gladstone Street in a westerly direction for a distance of 36 metres.
- (ix) The north-west side from 54 metres west of the centreline of Gladstone Street in a south-westerly direction to a point 23 metres east of its junction with Overton Road.
- (x) The north-west side from a point located some 28 metres south-west of the boundary between Nos. 4 and 6 High Street to a point located on the boundary of the eastern wall of the house at Nos. 40/42 High Street located 11 metres to the west of the centreline of Harratts Close, a distance of some 65 metres.
- (xi) The south-east side from and including its junction with Chapel Street and Curzon Street in a south-westerly direction to and including its junction with Orchard Street.
- (xii) The south-east side from and including its junction with Orchard Street in a south-westerly direction to a point located on the boundary between Nos. 111 and 113 High Street located approximately 101 metres west of its junction with Legion Drive.
- (xiii) The south-east side from a point 135 metres south-west of Legion Drive in a south-westerly direction for a distance of 9 metres.
- (xiv) The south-east side from a point 170 metres south-west of Legion Drive in a south-westerly direction for a distance of 11 metres (at its junction with South Road).

(xv) The south-east side from a point 202 metres south-west of Legion Drive in a south-westerly direction for a distance of 13 metres.

(xvi) The south-east side from a point 225 metres south-west of Legion Drive in a south-westerly direction to a point 22 metres east of its junction with Overton Road.

LEGION DRIVE, IBSTOCK

(i) The east side from its junction with High Street in a southerly direction for a distance of 14 metres.

(ii) The west side from its junction with High Street in a southerly direction for a distance of 13 metres.

LEICESTER ROAD, IBSTOCK

(i) The north-west side from a point approximately 50 metres north-east of its junction with Victoria Road (boundary between Nos. 244 and 246) in a south-westerly direction for a distance of 101 metres (a point 1 metre south of the boundary between Nos. 204 and 206).

(ii) The south-east side from a point approximately 52 metres north-east of its junction with Victoria Road in a south-westerly direction for a distance of 102 metres (boundary between Nos. 204 and 206).

(iii) The south-east side from its junction with Chapel Street to a point 4 metres north-east of the south-western boundary of No. 4 Leicester Road.

MELBOURNE ROAD, IBSTOCK

(i) The east side from the boundary between Nos. 207 and 209 Melbourne Road in a northerly direction, including its junction with Ashby Road to a point 7 metres north of the boundary between Nos. 237 and 239 Melbourne Road, a distance of 152 metres.

(ii) The east side from a point 1 metre north-west of the northern boundary line (produced) of house No. 133 in a south-easterly direction for a distance of 66 metres.

(iii) The north-west side from a point adjacent to the rear boundary of No. 2 Royal Oak Close in north-easterly direction to the boundary of Nos. 78/80 Melbourne Road.

(iv) The west side from the boundary between Nos. 207 and 209 Melbourne Road in a northerly direction, including its junction with Ashby Road to a point 9 metres north of the boundary between Nos. 266 and 268 Melbourne Road, a distance of 164 metres.

ORCHARD STREET, IBSTOCK

(i) The north-east side from the south-eastern kerb line of High Street in a south-easterly direction for a distance of 15 metres.

(ii) The north-east side from a point 40 metres south-east of the kerb line of High Street in a south-easterly direction for a distance of 14 metres.

(iii) The south-west side from the south-eastern kerb line of High Street in a south-easterly direction for a distance of 57 metres.

PARKDALE, IBSTOCK

Both sides from its junction with Ashby Road in a southerly direction for a distance of 12 metres.

THE HASTINGS, IBSTOCK

(i) The north side from the western kerb line of Chapel Street at its junction with Chapel Street in a westerly direction for a distance of 12 metres.

(ii) The south side from the western kerb line of Chapel Street at its junction with Chapel Street in a westerly direction for a distance of 14 metres.

VALLEY ROAD, IBSTOCK

(i) The north-east side from a point opposite a point 6 metres south-east of the south-eastern boundary of No. 2 Valley Road in a south-easterly direction to its junction with Melbourne Road.

(ii) The south-west side from a point 4 metres south-east of the south-eastern boundary of No. 2 Valley Road in a south-easterly direction for a distance of 15 metres.

(iii) The south-west side from a point 40 metres south-east of the south-eastern boundary of No. 2 Valley Road in a south-easterly direction to its junction with Melbourne Road.
