

THE LEICESTERSHIRE COUNTY COUNCIL
(VARIOUS ROADS, GLENFIELD (AREA 5), DISTRICT OF DISRICT OF BLABY)
EXPERIMENTAL ORDER 2010

The Leicestershire County Council ("the Council") in exercise of its powers under Section 9 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers, hereby makes the following Order:-

1. This Order shall come into force on the First day of November 2010 and may be cited as "The Leicestershire County Council (Various Roads, Glenfield (Area 5), District of Blaby) Experimental Order 2010".
2. The exemptions contained in this Order as set out in column 1 of Schedule 1 shall hereafter be referred to by reference to the code letters given in column 2 of Schedule 1.
3. (1) In this Order –

"authorised cab rank" means any area of carriageway which is comprised within and indicated by a road marking complying with diagram 1028.2 in Schedule 6 of The Traffic Signs Regulations and General Directions 2002;

"authorised parking place" means any parking place on a road authorised or designated by an Order made or having effect as if made under the Act;

"bus" means any Public Service Vehicle or bus operating a local stage carriage service as defined in the Transport Act 1985;

"bus stop area" means any area of carriageway on the sides of roads specified in this Order which is comprised within and indicated by a road marking complying with either diagram 1025.2 or diagram 1025.3 to the Traffic Signs Regulations and General Directions 2002;

"C.E.O." means a duly authorised Civil Enforcement Officer;

"disabled person's badge" has the same meaning as in The Disabled Persons (Badges for Motor Vehicles)(Amendment) Regulations 1991; or the Disabled Persons (Badges for Motor Vehicles)(England) Regulations 2000 and the Local Authorities' Traffic Orders (Exemptions for Disabled Persons)(England) Regulations 2000;

"disabled person's vehicle" has the same meaning as in The Local Authorities' Traffic Orders (Exemption for Disabled Persons)(England and Wales)(Amendment) Regulations 1991;

"disabled persons designated parking bay" means the part of the carriageway or side of road marked in accordance with Schedule 6 of the Traffic Signs Regulations and General Directions 2002 by the marking shown in diagram 1028.3 (or permitted variant thereof) and with a white broken line bounding the words "DISABLED" marked outside the bay;

"doctors' permit holders" means a vehicle which displays a valid permit issued to a Doctor for use in a specified location;

"footway parking area" means an area of the footway specifically designated for the purpose of waiting;

"hackney carriage" has the same meaning as in section 38(1) of the Vehicles (Excise) Act 1971;

"Loading" and "Unloading" means the collection or delivery of goods (parcels, stock and other items of that nature) to or from a vehicle where the goods cannot be reasonably collected or delivered except by the use of that vehicle in a particular length of road.

"market day" means any day of the week approved and authorised under a market charter for the holding of a market or such other bona fide licensed market;

"Market trader" means any person duly authorised an appropriate body to trade from an authorised market stall or stand or location as from time to time may be specified by the appropriate body for the purposes of his or her trading;

"motor vehicle" means any vehicle as defined by the Construction and Use Regulations 1986 (as amended) which is mechanically propelled except where otherwise provided;

"parking disc" means a disc, issued by a local authority, complying with the requirements of the British Standard Specification for Parking Discs (BS No.4631:1970) but coloured orange, and capable of showing the quarter hour period during which a period of waiting begins, or a blue badge under the Disabled Persons (Badges for Motor Vehicles)(England) Regulations 2000;

"permitted parking place" means any part of a road hereby authorised by the Council for use as a parking place being a place where vehicles may wait and is indicated as such by signs and road markings;

"permit" means a written warrant issued by or on behalf of Leicestershire County Council allowing the holder to wait in a specified location;

"permit holder" means a vehicle which displays a valid permit;

"residents' parking permit holder / residents' permit holder" means a vehicle which displays a valid permit issued to a resident of the specified location;

"road / roads" means the carriageway the footway and any verges being the full width of the highway extent from one boundary to another;

"school entrance" means any area of carriageway on the side of the road specified in Schedule 12 of this Order where vehicles are not permitted to stop and indicated by a road marking complying with diagram 1027.1 of the 2002 Regulations;

"vehicle" means any Motor Vehicle as defined in this Order and any other vehicle (capable of the carriage of persons or goods) except cycles unless otherwise provided;

"4.00 p.m. to 10.00 a.m. the following morning" wherever referred to in this Order means that period of time commencing at 4.00 p.m. in the afternoon of any day and terminating at 10.00 a.m. on the morning of the next day;

"The Act" means The Road Traffic Regulation Act 1984.

- (2) For the purpose of this Order a vehicle shall be regarded as displaying a disabled person's badge in the relevant position, where in accordance with the Disabled Persons (Badges for Motor Vehicles) (Amendment) Regulations 1991 and the Disabled Persons (Badges for Motor Vehicles) (England) Regulations 2000
- (i) the Badge is displayed on the vehicle's dashboard or fascia panel with the front of the Badge facing forward with the details thereon clearly visible from an external position, or
 - (ii) where the vehicle has no dashboard or fascia panel or windscreen where the Badge may be exhibited or displayed it shall be exhibited in a conspicuous position on the front or near side of the vehicle and

in either case a parking disc is exhibited in the relevant position prescribed in the Disabled Persons (Badges for Motor Vehicles) (Amendment) Regulations 1991 or the Disabled Persons (Badges for Motor Vehicles) (England) Regulations 2000.

- (3) For the purposes of this Order and where any article permits, it shall not be unlawful to cause or permit a disabled person's vehicle which displays in the relevant position a disabled person's badge and a parking disc (on which the driver, or other person in charge of the vehicle, has marked the time at which the period of waiting began) to wait on the sides of roads referred to in the specific article, for a period not exceeding 3 hours unless otherwise stated (not being a period separated by an interval of less than one hour, unless otherwise stated, from a previous period of waiting by the same vehicle on the same side of road on the same day) provided that no such vehicle shall wait in any length of road where there is for the time being a prohibition of loading and unloading.

4. "The Leicestershire County Council (Various Roads, Glenfield (Area 5), District of Blaby) Consolidation and Amendment Order 2009" is hereby revoked in respect of that length of road as specified in Schedule 2 to this Order.

- 5.1 No person shall, except upon the direction or with the permission of a police officer in uniform, a community support officer, a parking attendant or a C.E.O., cause or permit any vehicle to wait on any day other than a Sunday, in the permitted parking place specified in Schedule 3 Part 1 to this Order:-
 - (a) For a period longer than 2 hours, or
 - (b) If a period of less than 2 hours has elapsed since the last period of waiting by that vehicle on the same permitted parking place;

- 5.2 No person shall, except upon the direction or with the permission of a police officer in uniform, a community support officer, a parking attendant or a C.E.O., or in accordance with the exemption provisions, cause or permit any vehicle to wait at any time on any day, on the sides of road specified in Schedule 3 Part 2 to this Order.

- 5.3 No person shall, except upon the direction or with the permission of a police officer in uniform, a community support officer, a parking attendant or a C.E.O., or in accordance with the exemption provisions, cause or permit any vehicle to wait between the hours of 7.00 a.m. and 6.00 p.m. on any day other than a Saturday or Sunday, on the sides of road specified in Schedule 3 Part 3 to this Order.

6. Except where otherwise stated, a reference in this Order to a numbered Article or Schedule is reference to the Article or Schedule bearing that number in this Order.

7. The plans annexed to this Order and marked drawing numbers TM3503/1/2010 marked Plan A and Plan B are for identification purposes only.

For a disabled person's vehicle which displays in the relevant position a disabled person's badge, and a parking disc (on which the driver, or other person in charge of the vehicle, has marked the time at which the period of waiting began) to wait on the sides of roads referred to in that Schedule for a period not exceeding three hours (not being a period separated by an interval of less than one hour from a previous period of waiting by the same vehicle on the same side of road on the same day) provided that no such vehicle shall wait in any length of road where there is for the time being a prohibition of loading and unloading. For vehicles to wait on the sides of roads referred to therein for so long as may be necessary while any gate or other barrier at the entrance to premises to which the vehicle requires access or from which it has just emerged is being opened or closed, if it is not reasonably practicable for the vehicle to wait otherwise than in that road while such a gate or barrier is opened or closed. Nothing shall render it unlawful to cause or permit a public service vehicle to stop for a longer time than is necessary for taking up and setting down passengers at any time on any day on the east side of Melbourne Road fronting the coach depot occupying 211/213 Melbourne Road	LCCR
For any disabled person's vehicle which displays in the relevant position a disabled person's badge and a parking badge (on which the driver or other person in charge of the vehicle has marked the time at which waiting began) to wait, load or unload in those parts of the road specified in the schedule to this order for a period not exceeding 3 hours, with no return within 3 hours. If the vehicle is being used to attend any of the properties numbered 2-30 Mantle Lane, but for the purposes of loading/unloading of goods or equipment at such property only	LCCT
If the vehicle is an official wedding or funeral car attending any of the properties numbered 2 -30 Mantle Lane for the purpose of allowing passengers to board or alight.	LCCU
For any vehicle in excess of 7.5 tonnes loading or unloading on that part of Biggin Street between its junction with Fennel Street and a pint 35 metres north of its junction with Swan Street, such vehicle shall have entered Biggin Street from its junction with Fennel Street between the hours of 4.00p.m. to midnight and midnight to 10.00 a.m.	LCCV

- (iv) The east side from a point 214.5 metres south of its junction with Leicester Road in a southerly direction for a distance of 16 metres.
- (v) The east side from a point 238.5 metres south of its junction with Leicester Road in a southerly direction for a distance of 6 metres.
- (vi) The east side from a point 258.5 metres south of its junction with Leicester Road in a southerly direction for a distance of 8 metres.
- (vii) The east side from a point 274 metres south of its junction with Leicester Road in a southerly direction for a distance of 10 metres.
- (viii) The east side from a point 300.5 metres south of its junction with Leicester Road in a southerly direction for a distance of 10.5 metres.
- (ix) The east side from a point 42 metres south of its junction with Leicester Road in a southerly direction for a distance of 11 metres.
- (x) The east side from a point 73 metres south of its junction with Leicester Road in a southerly direction for a distance of 6 metres.
- (xi) The west side from a point 55 metres south of its junction with Leicester Road in a southerly direction for a distance of 11 metres.
- (xii) The west side from a point 107.5 metres south of its junction with Leicester Road in a southerly direction for a distance of 13 metres.
- (xiii) The west side from a point 156.5 metres south of its junction with Leicester Road in a southerly direction for a distance of 24 metres.
- (xiv) The west side from a point 240 metres south of its junction with Leicester Road in a southerly direction for a distance of 25 metres.

(xv) The west side from a point 273 metres south of its junction with Leicester Road in a southerly direction for a distance of 13 metres.

(i) The east side from its junction with Leicester Road in a south-westerly direction for a distance of 19 metres.

(ii) The west side from its junction with Leicester Road in a south-westerly direction for a distance of 17 metres.

GLENFIELD FRITH DRIVE, GLENFIELD

(i) The east side from its junction with Leicester Road in a southerly direction for a distance of 42 metres.

(ii) The east side from a point 53 metres south of its junction with Leicester Road in a southerly direction for a distance of 20 metres.

(iii) The east side from a point 79 metres south of its junction with Leicester Road in a southerly direction for a distance of 8.5 metres.

(iv) The east side from a point 101.5 metres south of its junction with Leicester Road in a southerly direction for a distance of 23 metres.

(v) The east side from a point 148.5 metres south of its junction with Leicester Road in a southerly direction for a distance of 36 metres.

(vi) The west side from its junction with Leicester Road in a southerly direction for a distance of 55 metres.

(vii) The west side from a point 66 metres south of its junction with Leicester Road in a southerly direction for a distance of 41.5 metres.

(viii) The west side from a point 120.5 metres south of its junction with Leicester Road in a southerly direction for a distance of 36 metres.

(ix) The west side from a point 180.5 metres south of its junction with Leicester Road in a southerly direction for a distance of 59.5 metres.

LEICESTER ROAD (NORTH-WEST BOUND CARRIAGEWAY), GLENFIELD

(i) The south side from a point 77.5 metres north-west of its junction with Gallimore Close in a north-westerly direction for a distance of 43 metres.

(ii) The south side from a point 15 metres south-east of its junction with Faire Road in a north-westerly direction for a distance of 49 metres.

(iii) The south side from a point 7 metres south-east of its junction with Oakfield Avenue in a north-westerly direction for a distance of 21.5 metres.

(iv) The south side from a point 59 metres south-east of its junction with Glenfield Frith Drive in a north-westerly direction for a distance of 176 metres.

OAKFIELD AVENUE, GLENFIELD

Both sides from its junction with Leicester Road in a south-westerly direction for a distance of 10 metres.
