



BOROUGH OF CHARNWOOD (OFF-STREET PARKING PLACES) ORDER
2014 AMENDMENT ORDER NO. 1 2017

The Council of the Borough of Charnwood (hereinafter referred to as "the Council") in exercise of its powers under Sections 32, 35 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act") and all other enabling powers and with the consent of the Leicestershire County Council in accordance with Section 39(3) of the Act and after consulting the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act, HEREBY MAKES the following Order:-

1. (i) This Order is supplemental to the Borough of Charnwood (Off-Street Parking Places) Order 2014 ("the Original Order") which subject as hereinafter mentioned remains in full force and effect.

(ii) This Order shall come into operation on 31st March 2017 and may be cited as the Borough of Charnwood (Off-Street Parking Places) Order 2014 Amendment Order No. 1 2017.

(iii) Definitions and interpretation are as provided in the Original Order with the exception that the replacement amended or additional definitions set out or described in the Second Schedule hereto shall be read and construed as if the same were incorporated in Article 3 of the Original Order and any replaced or redundant wording of that said Article 3 as identified in the Second Schedule shall now be revoked to the extent that the same is inconsistent with such replacement amended or additional definitions.
2. The First Schedule to the Original Order shall be revoked and replaced with the First Schedule hereto which shall now be read and construed as if the same was First Schedule to the Original Order.
3. Article 13 of the Original Order shall be amended by inserting the words "Electric Vehicle" immediately following the word "Coach" and immediately before the words "or Motor Cycle"

4. Article 14 of the Original Order shall be amended by inserting the wording, "with marked Parking Bays" immediately before the words "shall be positioned wholly within one Parking Bay" in the second line of the said Article.
5. A new Article, being numbered Article 20A shall be inserted into the Original Order following Article 20 and shall provide "In those Parking Places with Electric Vehicle Charge Point Bays, Electric Vehicles may park only within specifically designated bays marked for such Vehicles if the Owner or Driver is charging the Electric Vehicle at the Charge Point during the time the Vehicle occupies the Parking Place.
6. A new Article, being numbered as Article 24A, shall be inserted in the Original Order following Article 24 and shall provide "At the Council's discretion, it may grant an Outwoods Season Permit for the parking of a specified Vehicle".
7. A new Article, being numbered as Article 24B, shall be inserted in the Original Order following Article 24 and shall provide "At the Council's discretion, it may grant an Outwoods Volunteer Permit for the parking of a specified Vehicle".
8. A new Article, being numbered as Article 44A shall be inserted in the Original Order following Article 44 and shall provide "Where an Electric Vehicle parks within an Electric Charge Point Parking Bay during the charged hours specified in column 5 of Schedule 1, the Driver shall pay such charges or shall display such badge, permit or ticket as is specified in column 6 of Schedule 1 in such manner as provided in this Order"
9. A new Article, being numbered as Article 44B shall be inserted in the Original Order following Article 44A and shall provide "Where an Electric Vehicle uses a Charge Point, the Council will not levy any charge for the electricity used. There may be a charge payable to the operator of the equipment for which the Driver or Owner of the Electric Vehicle is solely responsible."
10. A new Article, being numbered as Article 47A, shall be inserted in the Original Order following Article 47 and shall provide "Any Electric Vehicle using or remaining in any Electric Charge Point Parking Bay shall be at the Owners or Drivers risk and the Council its agents officers or employees shall not be liable for loss or damage caused to it, its contents, accessories or equipment used to charge the Vehicle howsoever arising including damage caused directly or indirectly as a result of a Vehicle being removed from the parking Place under the provisions of Articles 68-73".

11. Article 57 of the Original Order shall be amended by inserting the words, "(where the Parking Place has marked Parking Bays)" immediately following the words "A Vehicle shall not be permitted to wait in a Parking Place other than in a Parking Bay".

 - iii. The definition of "Electric Vehicle" shall be added as "means a Vehicle which can be charged with electricity at the Charge Point"
 - iv. The definition of "Outwoods Season Permit" shall be added as "means a permit issued by the Council in accordance with the terms and conditions provided by the Council when issuing the permit in those Parking Places where indicated in Column 6 of Schedule 1;"
 - v. The definition of "Outwoods Volunteer Permit" shall be added as "means a permit issued by the Council in accordance with the terms and conditions provided by the Council when issuing the permit in those Parking Places where indicated in Column 6 of Schedule 1"
