

THE LEICESTERSHIRE COUNTY COUNCIL
(VARIOUS ROAD, BURBAGE (AREA 3), DISTRICT OF HINCKLEY AND BOSWORTH)
CONSOLIDATION AND AMENDMENT ORDER 2009

The Leicestershire County Council ("the Council") in exercise of its powers under Sections 1(1) and (2) 2(1) to (3) 4(2) 32 and 35 and Part IV of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers, hereby makes the following Order:-

1. This Order shall come into force on the Sixteenth day of February 2009 and may be cited as "The Leicestershire County Council (Various Roads, Burbage (Area 3), District of Hinckley and Bosworth) Consolidation and Amendment Order 2009".
2. The exemptions contained in this Order as set out in column 1 of Schedule 1 shall hereafter be referred to by reference to the code letters given in column 2 of Schedule 1.
3. The Orders specified in Schedule 2 are hereby revoked and re-enacted in Schedule 3 without alteration to the restrictions imposed by those Orders.
4. The Order specified in Schedule 4 is hereby revoked to the extent indicated in the Schedule of that Order and re-enacted without alteration to the provisions imposed by the Order
5. (1) In this Order –
 - "authorised cab rank" means any area of carriageway which is comprised within and indicated by a road marking complying with diagram 1028.2 in Schedule 6 of The Traffic Signs Regulations and General Directions 2002;
 - "authorised parking place" means any parking place on a road authorised or designated by an Order made or having effect as if made under the Act;
 - "bus" means any Public Service Vehicle or bus operating a local stage carriage service as defined in the Transport Act 1985;
 - "bus stop area" means any area of carriageway on the sides of roads specified in this Order which is comprised within and indicated by a road marking complying with either

diagram 1025.2 or diagram 1025.3 to the Traffic Signs Regulations and General Directions 2002;

"C.E.O." mean a duly authorised Civil Enforcement Officer;

"disabled person's badge" has the same meaning as in The Disabled Persons (Badges for Motor Vehicles)(Amendment) Regulations 1991; or the Disabled Persons (Badges for Motor Vehicles)(England) Regulations 2000 and the Local Authorities' Traffic Orders (Exemptions for Disabled Persons)(England) Regulations 2000;

"disabled person's vehicle" has the same meaning as in The Local Authorities' Traffic Orders (Exemption for Disabled Persons)(England and Wales)(Amendment) Regulations 1991;

"disabled persons designated parking bay" means the part of the carriageway or side of road marked in accordance with Schedule 6 of the Traffic Signs Regulations and General Directions 2002 by the marking shown in diagram 1028.3 (or permitted variant thereof) and with a white broken line bounding the words "DISABLED" marked outside the bay;

"hackney carriage" has the same meaning as in section 38(1) of the Vehicles (Excise) Act 1971;

"heavy commercial vehicle" has the same meaning as in Section 138 of the Act;

"market day" means any day of the week approved and authorised under a market charter for the holding of a market or such other bona fide licensed market;

"market trader" means any person duly authorised an appropriate body to trade from an authorised market stall or stand or location as from time to time may be specified by the appropriate body for the purposes of his or her trading;

"motor vehicle" means any vehicle as defined by the Construction and Use Regulations 1986 (as amended) which is mechanically propelled except where otherwise provided;

"parking disc" means a disc, issued by a local authority, complying with the requirements of the British Standard Specification for Parking Discs (BS No.4631:1970) but coloured orange, and capable of showing the quarter hour period during which a period of waiting begins, or a blue badge under the Disabled Persons (Badges for Motor Vehicles)(England) Regulations 2000;

"permit" means a written warrant issued by or on behalf of Leicestershire County Council allowing the holder to wait in a specified location;

"permitted parking place" means any part of a road hereby authorised by the Council for use as a parking place being a place where vehicles may wait and is indicated as such by signs and road markings;

"permit holder" means a vehicle which displays a valid permit;

"residents' parking permit holder / residents' permit holder" means a vehicle which displays a valid permit issued to a resident of the specified location;

"road / roads" means the carriageway the footway and any verges being the full width of the highway extent from one boundary to another;

"school entrance" means any area of carriageway on the side of the road where vehicles are not permitted to stop and indicated by a road marking complying with diagram 1027.1 of the 2002 Regulations;

"vehicle" means any Motor Vehicle as defined in this Order and any other vehicle (capable of the carriage of persons or goods) except cycles unless otherwise provided;

"4.00 p.m. to 10.00 a.m. the following morning" wherever referred to in this Order means that period of time commencing at 4.00 p.m. in the afternoon of any day and terminating at 10.00 a.m. on the morning of the next day;

"The Act" means The Road Traffic Regulation Act 1984.

- (2) For the purpose of this Order a vehicle shall be regarded as displaying a disabled person's badge in the relevant position, where in accordance with the Disabled Persons (Badges for Motor Vehicles) (Amendment) Regulations 1991 and the Disabled Persons (Badges for Motor Vehicles) (England) Regulations 2000
- (i) the Badge is displayed on the vehicle's dashboard or fascia panel with the front of the Badge facing forward with the details thereon clearly visible from an external position, or
 - (ii) where the vehicle has no dashboard or fascia panel or windscreen where the Badge may be exhibited or displayed it shall be exhibited in a conspicuous position on the front or near side of the vehicle and

in either case a parking disc is exhibited in the relevant position prescribed in the Disabled Persons (Badges for Motor Vehicles) (Amendment) Regulations 1991 or the Disabled Persons (Badges for Motor Vehicles) (England) Regulations 2000.

6. The following articles shall relate to the re-enacted provisions of Schedule 3 and are amended by the insertion of a reference to a "C.E.O." and by virtue of Section 32 and 35 of the Road Traffic Regulation Act 1984 where appropriate to create permitted parking places.

- 6.1 No person shall, except upon the direction or with the permission of a police officer in uniform, a community support officer, a parking attendant or a C.E.O., cause or permit any vehicle to wait between the hours of 8.30 a.m. and 6.30 p.m. on any day other than a Sunday, in the permitted parking place specified in Schedule 3 Part 1 to this Order:-
- (a) For a period longer than 1 hour, or
 - (b) If a period of less than 1 hour has elapsed since the last period of waiting by that vehicle on the same permitted parking place;
- 6.2 No person shall, except upon the direction or with the permission of a police officer in uniform, a community support officer, a parking attendant or a C.E.O., cause or permit any vehicle to wait between the hours of 8.30 a.m. and 6.30 p.m. on any day other than a Sunday, in the permitted parking place specified in Schedule 3 Part 2 to this Order:-
- (a) For a period longer than 30 minutes, or

(b) If a period of less than 30 minutes has elapsed since the last period of waiting by that vehicle on the same permitted parking place;

- 6.3 No person shall, except upon the direction or with the permission of a police officer in uniform, a community support officer, a parking attendant or a C.E.O., or in accordance with the exemption provisions, cause or permit any vehicle to wait at any time on any day, on the sides of road specified in Schedule 3 Part 3 to this Order.
- 6.4 No person shall, except upon the direction or with the permission of a police officer in uniform, a community support officer, a parking attendant or a C.E.O., or in accordance with the exemption provisions, cause or permit any vehicle to wait any day other than a Sunday, on the sides of road specified in Schedule 3 Part 4 to this Order.
- 6.5 No person shall, except upon the direction or with the permission of a police officer in uniform, a community support officer, a parking attendant or a C.E.O., or in accordance with the exemption provisions, cause or permit any vehicle to wait between the hours of 8.30 a.m. and 6.30 p.m. on any day other than a Sunday, on the sides of road specified in Schedule 3 Part 5 to this Order.
- 6.6 No person shall, except upon the direction or with the permission of a police officer in uniform, a community support officer, a parking attendant or a C.E.O., or in accordance with the exemption provisions, cause or permit any vehicle to wait between the hours of 8.00 a.m. and 4.00 p.m. on any day other than a Saturday or Sunday, on the sides of road specified in Schedule 3 Part 6 to this Order.

7. Except where otherwise stated, a reference in this order to a numbered Article or Schedule is reference to the Article or Schedule bearing that number in this Order.

For a disabled person's vehicle which displays in the relevant position a disabled person's badge, and a parking disc (on which the driver, or other person in charge of the vehicle, has marked the time at which the period of waiting began) to wait on the sides of roads referred to in that Article for a period not exceeding three hours (not being a period separated by an interval of less than one hour from a previous period of waiting by the same vehicle on the same side of road on the same day) provided that no such vehicle shall wait in any length of road where there is for the time being a prohibition of loading and unloading. For vehicles to wait on the sides of roads referred to therein for so long as may be necessary while any gate or other barrier at the entrance to premises to which the vehicle requires access or from which it has just emerged is being opened or closed, if it is not reasonably practicable for the vehicle to wait otherwise than in that road while such a gate or barrier is opened or closed. Any vehicle bona fide associated or used in connection with or for the purpose of licensed markets or special events.	LCCL
Where the person in control of the vehicle is directed or given permission to stop by a police officer, a traffic warden, community support officer, a parking attendant or a civil enforcement officer.	LCCM

Nothing shall render it unlawful to cause or permit any vehicle to wait in connection with the maintenance or repair of any premises adjoining the roads which can only be carried out from the road being such works as are required to be carried out to comply with any statutory obligation condition or stipulation subject to such waiting being limited to a maximum of two hours in any period of 24 hours. Nothing shall render it unlawful to cause or permit a public service vehicle to stop for a longer time than is necessary for taking up and setting down passengers at any time on any day on the east side of Melbourne Road fronting the coach depot occupying 211/213 Melbourne Road.	LCCR
For any disabled person's vehicle which displays in the relevant position a disabled person's badge and a parking badge (on which the driver or other person in charge of the vehicle has marked the time at which waiting began) to wait, load or unload in those parts of the road specified in the schedule to this order for a period not exceeding 3 hours, with no return within 3 hours. If the vehicle is being used to attend any of the properties numbered 2-30 Mantle Lane, but for the purposes of loading/unloading of goods or equipment at such property only.	LCCT
If the vehicle is an official wedding or funeral car attending any of the properties numbered 2-30 Mantle Lane for the purpose of allowing passengers to board or alight.	LCCU

Nothing shall render it unlawful to cause any vehicle to enter Market Place if the vehicle is a vehicle- (a) in the service of a Police or Fire or Health or Local Authority and is being used for Police, Fire, Ambulance or Local Authority purposes as the case may be; being used by a resident of Market Place for the purpose of gaining access to his place of residence there. - (viii) The west side from its junction with Grove Road to a point 27 metres south of that junction.
- (ix) The west side from a point 8 metres south of a point outside the boundary of Nos. 60 and 62 Church Street in a southerly direction to a point 1 metre west of a point outside the boundary of Nos. 40 to 42 Church Street.

COVENTRY ROAD, BURBAGE

- (i) The north-west side from its junction with Salem Road for a distance of 13 metres in a south-westerly direction.
- (ii) The south-east side from the centre line of its junction with Salem Road for a distance of 18 metres in a south-westerly direction.

FORRESTERS ROAD, BURBAGE

- (i) The north-west side from its junction with Hinckley Road for a distance of 16 metres in a westerly direction.
- (ii) The south-east side from its junction with Hinckley Road for a distance of 14 metres in a westerly direction.

FREEMANS LANE, BURBAGE

Both sides from its junction with Windsor Street for a distance of 14 metres in a southerly direction.

GROSVENOR CRESCENT, BURBAGE

Both sides from the centre of its junction with Grove Road for a distance of 14 metres in a westerly direction.

GROVE PARK, BURBAGE

- (i) The north-east side from its junction with Grove Road in a north-westerly direction for a distance of 15 metres.

- (ii) The south-west side from its junction with Grove Road in a north-westerly direction for a distance of 16 metres.

GROVE ROAD, BURBAGE

- (i) Both sides from its junction with Church Street to a point 20 metres west of its junction with New Road.
- (ii) The west side from a point 17.6 metres south of the centre of its junction with Grosvenor Crescent heading in a northerly direction for a distance of 35.2 metres.
- (iii) The west side from a point 35 metres west of its junction with Twycross Road heading in a north-easterly direction for a distance of 55 metres.

HERALD WAY, BURBAGE

- (i) The north side starting from the junction Herald Way with Rugby Road finishing 48 metres in a westerly direction.
- (ii) The south side starting from the junction Herald Way with Rugby Road finishing 14 metres in a westerly direction.

HINCKLEY ROAD, BURBAGE

- (i) The east side from a point 15 metres north of its junction with Woodland Avenue to a point 10 metres south of that junction.
- (ii) The east side from a point 50 metres north of its junction with Grove Road to that junction.
- (iii) The east side from a point 10 metres south of its junction with Woodland Avenue for a distance of 14 metres in a southerly direction.
- (iv) The east side from a point 15 metres north of its junction with Woodland Avenue for a distance of 24 metres in a northerly direction.
- (v) The east side from a point 50 metres north of its junction with Grove Road for a distance of 10 metres in a northerly direction.
- (vi) The east side from a point 14 metres south of its junction with School Close in a southerly direction for a distance of 34 metres.
- (vii) The west side from a point 18 metres north of its junction with Grove Road to that junction.

(viii) The west side from a point 15 metres north of its junction with Woodland Avenue to a point 17 metres north of its junction with Forresters Road.

(ix) The west side from a point 51 metres north of its junction with Grove Road to a point 15 metres north of its junction with Woodland Avenue.

LANCE CLOSE, BURBAGE

Both sides starting from its junction with Herald Way finishing 14 metres in an easterly direction.

LUTTERWORTH ROAD, BURBAGE

(i) The east side from its junction with Lychgate Lane for a distance of 18 metres in a southerly direction.

(ii) The west side from its junction with Windsor Street for a distance of 10 metres in a southerly direction.

LUTTERWORTH ROAD/CHURCH STREET, BURBAGE

Outside the Burbage Liberal Club from a point 21 metres south-west of the northern property line of No. 5 Lutterworth Road to a point 3 metres north of a point opposite its southern boundary.

LYCHGATE LANE, BURBAGE

(i) The north side from its junction with Church Street for a distance of 12 metres in an easterly direction.

(ii) The south side from its junction with Lutterworth Road for a distance of 13 metres in an easterly direction.

NEW ROAD, BURBAGE

(i) The east side from its junction with Grove Road to a point 14 metres south of that junction.

(ii) The east side from a point 27 metres south of the southern boundary of No. 3 New Road to a point 8 metres west of a point outside the boundary of Nos. 32 and 34 Church Street.

(iii) The west side for the whole length.

PIKE CLOSE, BURBAGE

- (i) The east side from its junction with Sketchley Lane for a distance of 22 metres in a southerly direction.
- (ii) The west side from its junction with Sketchley Lane for a distance of 18.3 metres in a southerly direction.

SALEM ROAD, BURBAGE

- (i) Both sides from its junction with Sketchley Road for a distance of 14 metres in a south-easterly direction.
- (ii) The east side from its junction with Coventry Road for a distance of 10 metres in a northerly direction.
- (iii) The west side from its junction with Coventry Road for a distance of 13 metres in a northerly direction.

SKETCHLEY LANE, BURBAGE

- (i) The north side starting from the junction Sketchley Lane with Herald Way finishing 52 metres in a north westerly direction.
- (ii) The south side starting from the junction Sketchley Lane with Herald Way finishing 23 metres in a north westerly direction.
- (iii) The south side from a point 23 metres north east of its junction with Herald Way to a point 7.2 metres west of its junction with Pike Close.

SKETCHLEY ROAD, BURBAGE

Both sides starting from its junction with Rugby Road finishing 24 metres in an easterly direction.

SKETCHLEY ROAD/ GROVE ROAD, BURBAGE

The east side from a point 17.8 metres south-west of the centreline of the Sketchley Road/Salem Road junction heading in a north-easterly direction along Sketchley Road and then Grove Road for a distance of 35.3 metres.

TWYXCROSS ROAD, BURBAGE

Both sides from its junction with Grove Road for a distance of 13 metres in a north-westerly direction.

WINDSOR STREET, BURBAGE

- (i) The north-west side from its junction with Salem Road for a distance of 32 metres in a north-easterly direction.
- (ii) The south side from its junction with Freemans Lane for a distance of 7 metres in a westerly direction.
- (iii) The south side from its junction with Freemans Lane for a distance of 6 metres in an easterly direction.
- (iv) The south side from its junction with Strutt Road to a point 4 metres east of its junction with Strutt Road.
- (v) The south side from its junction with Church Street to a point 8 metres west of its junction with Church Street.
- (vi) The south-east side from the centre line of its junction with Salem Road to a point 11 metres north-east of its junction with Britannia Road.

WOODLAND AVENUE, BURBAGE

- (i) The north-west side from its junction with Hinckley Road for a distance of 12 metres in an easterly direction.
- (ii) The south-east side from its junction with Hinckley Road for a distance of 13 metres in an easterly direction.

- (i) The north-east side from its junction with Windsor Street to a point 4 metres north-east of the eastern boundary of 14 Lutterworth Road.

2. Where in any of the Orders specified in Schedule 1 of this Order there is reference to "a police constable in uniform, a traffic warden, a community support officer or a parking attendant" there shall be inserted the term "Civil Enforcement Officer".
3. The Orders specified in Schedule 1 shall be read and construed as if the term "Civil Enforcement Officer" had been included in the original Order.
4. Except where otherwise stated, a reference in this Order to a numbered Article or Schedule is reference to the Article or Schedule bearing that number in this Order.
