

THE LEICESTERSHIRE COUNTY COUNCIL

(PROHIBITION OF VEHICULAR MOVEMENTS) ORDER 2019

The Leicestershire County Council ("the Council") in exercise of its powers under Sections 1 (1) , 2 (1) 2 (2) 4 5 and Part IV of Schedule 9 of the Road Traffic Regulations Act 1984 ("the Act") and of all other enabling powers and after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act and Regulation 23 of the Local Authorities Traffic Order (Procedure) England and Wales Regulations 1996, hereby makes the following Order:-

1. This Order may be cited as "The Leicestershire County Council (Lower Church Street, Ashby de la Zouch) (District of North West Leicestershire) (Prohibition of Vehicular Movements) Order 2019"
2. The Order shall come into force on the sixteenth day of November 2019
3. "The County of Leicester (Urban District of Ashby de la Zouch) (Traffic Regulation) Order 1966" is hereby revoked in full.
4. No person shall, except upon the direction of or with the permission of a police officer, or a community support officer, cause or permit any vehicle to proceed along the length of road specified in Schedule 1 to this Order in a direction other than that specified in the said Schedule.

5. The plan annexed to this Order and marked drawing number TM4471/T1/1 is for identification purposes only.

SCHEDULE 1

Imposition of One Way Traffic

Lower Church Street, Ashby de la Zouch

From its junction with Wood Street to its junction with South Street.

South Street, Ashby de la Zouch

From its junction with Lower Church Street to a point 141 metres south –west of its junction with Lower Church Street

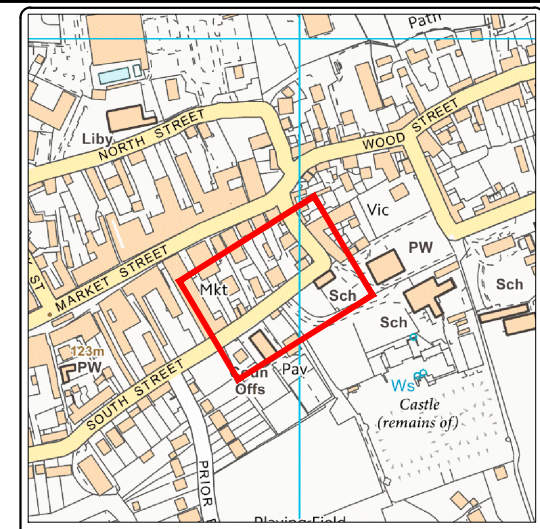
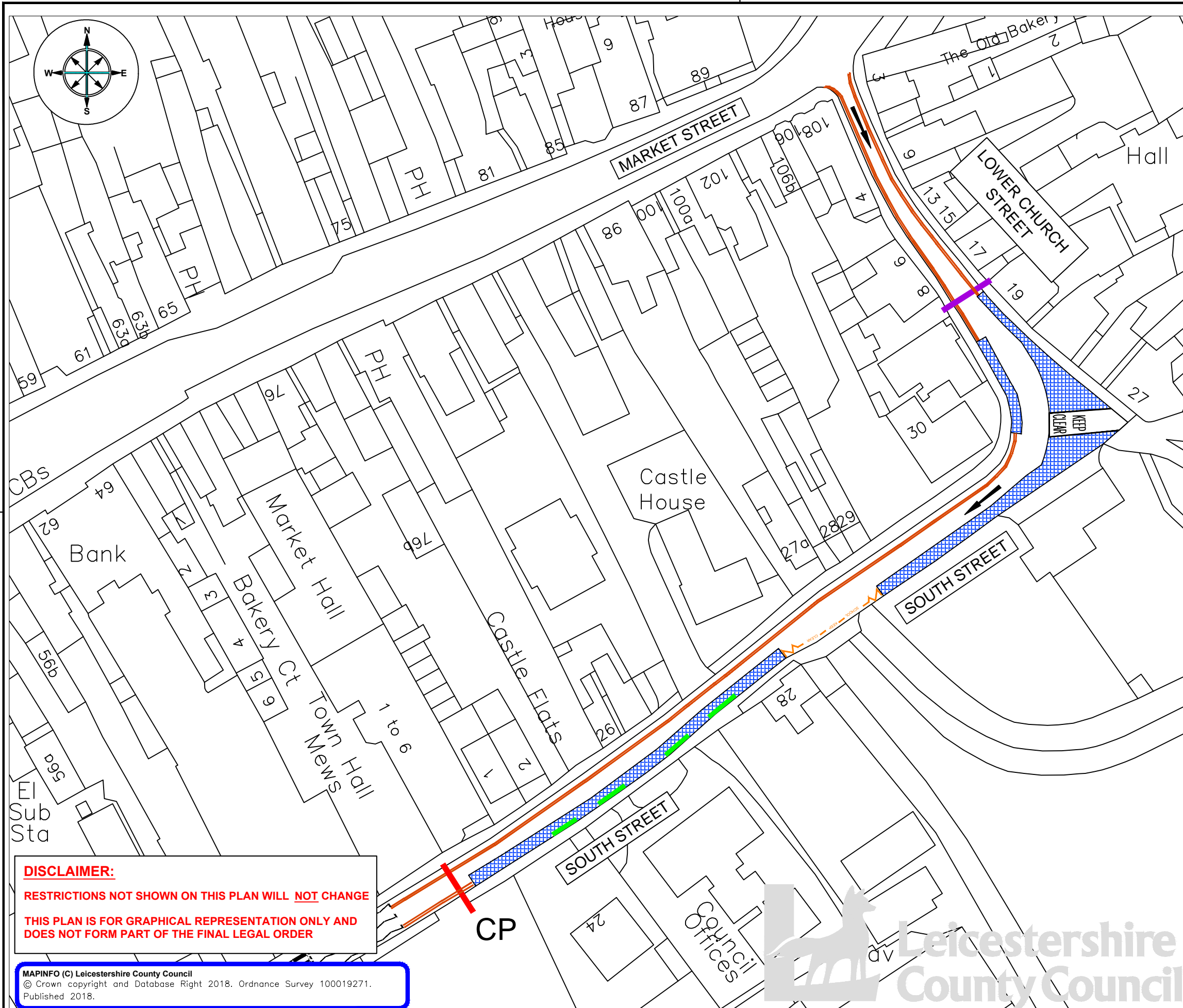
