

THE LEICESTERSHIRE COUNTY COUNCIL
(VARIOUS ROADS, WIGSTON (AREA 2), DISTRICT OF OADBY AND WIGSTON)
(AMENDMENT) ORDER 2011

The Leicestershire County Council ("the Council") in exercise of its powers under Section 1(1) and 2(1) to (3) 4(2) 32 35 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers, hereby makes the following Order:-

1. This Order shall come into force on the Twenty-Sixth day of September 2011 and may be cited as "The Leicestershire County Council (Various Roads, Wigston (Area 2), District of Oadby and Wigston) Amendment Order No. 1 2011".
2. The exemptions contained in this Order as set out in column 1 of Schedule 1 shall hereafter be referred to by reference to the code letters given in column 2 of Schedule 1.
3. (1) In this Order –

"authorised cab rank" means any area of carriageway which is comprised within and indicated by a road marking complying with diagram 1028.2 in Schedule 6 of The Traffic Signs Regulations and General Directions 2002;

"authorised parking place" means any parking place on a road authorised or designated by an Order made or having effect as if made under the Act;

"bus" means any Public Service Vehicle or bus operating a local stage carriage service as defined in the Transport Act 1985;

"bus stop area" means any area of carriageway on the sides of roads specified in this Order which is comprised within and indicated by a road marking complying with either diagram 1025.2 or diagram 1025.3 to the Traffic Signs Regulations and General Directions 2002;

"C.E.O." means a duly authorised Civil Enforcement Officer;

"disabled person's badge" has the same meaning as in The Disabled Persons (Badges for Motor Vehicles)(Amendment) Regulations 1991; or the Disabled Persons (Badges for Motor Vehicles)(England) Regulations 2000 and the Local Authorities' Traffic Orders (Exemptions for Disabled Persons)(England) Regulations 2000;

"disabled person's vehicle" has the same meaning as in The Local Authorities' Traffic Orders (Exemption for Disabled Persons)(England and Wales)(Amendment) Regulations 1991;

"disabled persons designated parking bay" means the part of the carriageway or side of road marked in accordance with Schedule 6 of the Traffic Signs Regulations and General Directions 2002 by the marking shown in diagram 1028.3 (or permitted variant thereof) and with a white broken line bounding the words "DISABLED" marked outside the bay;

"doctors' permit holders" means a vehicle which displays a valid permit issued to a Doctor for use in a specified location;

"footway parking area" means an area of the footway specifically designated for the purpose of waiting;

"hackney carriage" has the same meaning as in section 38(1) of the Vehicles (Excise) Act 1971;

"Loading" and "Unloading" means the collection or delivery of goods (parcels, stock and other items of that nature) to or from a vehicle where the goods cannot be reasonably collected or delivered except by the use of that vehicle in a particular length of road.

"market day" means any day of the week approved and authorised under a market charter for the holding of a market or such other bona fide licensed market;

"Market trader" means any person duly authorised an appropriate body to trade from an authorised market stall or stand or location as from time to time may be specified by the appropriate body for the purposes of his or her trading;

"motor vehicle" means any vehicle as defined by the Construction and Use Regulations 1986 (as amended) which is mechanically propelled except where otherwise provided;

"parking disc" means a disc, issued by a local authority, complying with the requirements of the British Standard Specification for Parking Discs (BS No.4631:1970) but coloured orange, and capable of showing the quarter hour period during which a period of waiting begins, or a blue badge under the Disabled Persons (Badges for Motor Vehicles)(England) Regulations 2000;

"permitted parking place" means any part of a road hereby authorised by the Council for use as a parking place being a place where vehicles may wait and is indicated as such by signs and road markings;

"permit" means a written warrant issued by or on behalf of Leicestershire County Council allowing the holder to wait in a specified location;

"permit holder" means a vehicle which displays a valid permit;

"residents' parking permit holder / residents' permit holder" means a vehicle which displays a valid permit issued to a resident of the specified location;

"road / roads" means the carriageway the footway and any verges being the full width of the highway extent from one boundary to another;

"school entrance" means any area of carriageway on the side of the road specified in Schedule 12 of this Order where vehicles are not permitted to stop and indicated by a road marking complying with diagram 1027.1 of the 2002 Regulations;

"vehicle" means any Motor Vehicle as defined in this Order and any other vehicle (capable of the carriage of persons or goods) except cycles unless otherwise provided;

"4.00 p.m. to 10.00 a.m. the following morning" wherever referred to in this Order means that period of time commencing at 4.00 p.m. in the afternoon of any day and terminating at 10.00 a.m. on the morning of the next day;

"The Act" means The Road Traffic Regulation Act 1984.

- (2) For the purpose of this Order a vehicle shall be regarded as displaying a disabled person's badge in the relevant position, where in accordance with the Disabled Persons (Badges for Motor Vehicles) (Amendment) Regulations 1991 and the Disabled Persons (Badges for Motor Vehicles) (England) Regulations 2000
- (i) the Badge is displayed on the vehicle's dashboard or fascia panel with the front of the Badge facing forward with the details thereon clearly visible from an external position, or
 - (ii) where the vehicle has no dashboard or fascia panel or windscreen where the Badge may be exhibited or displayed it shall be exhibited in a conspicuous position on the front or near side of the vehicle and

in either case a parking disc is exhibited in the relevant position prescribed in the Disabled Persons (Badges for Motor Vehicles) (Amendment) Regulations 1991 or the Disabled Persons (Badges for Motor Vehicles) (England) Regulations 2000.

- (3) For the purposes of this Order and where any article permits, it shall not be unlawful to cause or permit a disabled person's vehicle which displays in the relevant position a disabled person's badge and a parking disc (on which the driver, or other person in charge of the vehicle, has marked the time at which the period of waiting began) to wait on the sides of roads referred to in the specific article, for a period not exceeding 3 hours unless otherwise stated (not being a period separated by an interval of less than one hour, unless otherwise stated, from a previous period of waiting by the same vehicle on the same side of road on the same day) provided that no such vehicle shall wait in any length of road where there is for the time being a prohibition of loading and unloading.

4. "The Leicestershire County Council (Various Roads, Wigston (Area 2), District of Oadby and Wigston) Consolidation, Amendment and Confirmation of Experimental Order 2008" is hereby revoked in respect of those lengths of roads as specified in Schedule 2 to this Order.

- 4.1 No person shall, except upon the direction or with the permission of a police officer in uniform, a community support officer, a parking attendant or a C.E.O., or in accordance with the exemption provisions, cause or permit any vehicle to wait at any time on any day, on the sides of road specified in Schedule 3 to this Order.
- 4.2 The written restriction applicable to those lengths of roads referred to in Schedule 4 are hereby revoked and re-enacted as amended in Schedule 5. Such amendments shall have no practical effect on the restrictions as set out on those lengths of roads and shall not affect the use of such roads by members of the public.
- 4.3 No person shall, except upon the direction or with the permission of a police officer in uniform, a community support officer, a parking attendant or a C.E.O., cause or permit any vehicle to wait at any time in the permitted parking place specified in Schedule 5 Part 1 to this Order, except for disabled persons vehicle.
- 4.4 No person shall, except upon the direction or with the permission of a police officer in uniform, a community support officer, a parking attendant or a C.E.O., or in accordance with the exemption provisions, cause or permit any vehicle to wait at any time on any day for the purpose of enabling goods to be loaded or unloaded from the vehicle on the sides of road specified in Schedule 5 Part 2 to this Order.
- 4.5 No person shall, except upon the direction or with the permission of a police officer in uniform, a community support officer, a parking attendant or a C.E.O., or in accordance with the exemption provisions, cause or permit any vehicle to wait between the hours of 10.00 a.m. and 4.00 p.m. on any day, for the purpose of enabling goods to be loaded or unloaded from the vehicle on the sides of road specified in Schedule 5 Part 3 to this Order.
- 4.6 No person shall, except upon the direction or with the permission of a police officer in uniform, a community support officer, a parking attendant or a C.E.O., or in accordance with the exemption provisions, cause or permit any vehicle to wait at any time on any day, on the sides of road specified in Schedule 5 Part 4 to this Order.

- 4.7 No person shall, except upon the direction or with the permission of a police officer in uniform, a community support officer, a parking attendant or a C.E.O., or in accordance with the exemption provisions, cause or permit any vehicle to wait between the hours of 8.00 a.m. and 6.30 p.m. on any day other than a Sunday, on the sides of road specified in Schedule 5 Part 5 to this Order.
- 4.8 No person shall, except upon the direction or with the permission of a police officer in uniform, a community support officer, a parking attendant or a C.E.O., or in accordance with the exemption provisions, cause or permit any vehicle to stop or wait at any time, except for any licensed hackney carriage or taxi, on the sides of road specified in Schedule 5 Part 6 to this Order.
5. Except where otherwise stated, a reference in this Order to a numbered Article or Schedule is reference to the Article or Schedule bearing that number in this Order.
6. The plan annexed to this Order and marked drawing number TM3442/2/2009 is for identification purposes only.

- (i) The north side from a point 17 metres east of its junction with Long Street to a point 47.5 metres east of that junction.
- (ii) The south side from a point 13 metres east of its junction with Long Street to a point 55.5 metres east of that junction.

LONG STREET, WIGSTON

- (i) The north side from a point 11 metres west of its junction with Bell Street in a generally north-westerly direction for a distance of 11 metres.
- (ii) The south side from a point 13 metres west of its junction with Bell Street in a generally south-westerly direction for a distance of 9 metres.

NO LOADING 10.00 AM – 4.00 PM

BELL STREET, WIGSTON

- (i) The north side from a point 47.5 metres east of its junction with Long Street to its junction with Bull Head Street.
- (ii) The south side from a point 55.5 metres east of its junction with Long Street to its junction with Bull Head Street.

NO WAITING AT ANY TIME

BELL STREET, WIGSTON

- (i) The north side from a point 17 metres east of its junction with Long Street to its junction with Bull Head Street.
- (ii) The south side from a point 13 metres east of its junction with Long Street to its junction with Bull Head Street.

BULL HEAD STREET, WIGSTON

The east side from a point 30 metres north of its junction with Church Nook to a point 55 metres south of its junction with Church Nook.

LEICESTER ROAD, WIGSTON

The east side between its junction with Long Street and Wakes Road.

LONG STREET, WIGSTON

- (i) The east side from Leicester Road in a southerly direction to the northern boundary of the Memorial Park.
- (ii) The north side from a point 11 metres west of its junction with Bell Street in a generally north-westerly direction for a distance of 11 metres.

**NO WAITING
MONDAY - SATURDAY 8.00 AM - 6.30 PM**

BULL HEAD STREET, WIGSTON

The east side from a point 14 metres north of its junction with Glebe Close to a point 30 metres north of its junction with Church Nook.

**NO WAITING AT ANY TIME
EXCEPT FOR LICENSED HACKNEY CARRIAGES**

BELL STREET/LONG STREET, WIGSTON

The south side from a point on Bell Street 7 metres east of its junction with Long Street to a point on Long Street 13 metres west of its junction with Bell Street.

- (i) The north side from a point 6.5 metres east of its junction with Leicester Road in an easterly direction for a distance of 28 metres.

The east side from its junction with Bell Street in a southerly direction to the northern boundary of the Memorial Park, a distance of 121 metres.

BULL HEAD STREET, WIGSTON

The east side from a point 17 metres north of its junction with Glebe Close in a southerly direction for a distance of 127.5 metres.
