

THE LEICESTERSHIRE COUNTY COUNCIL
(BELL STREET, WIGSTON, BOROUGH OF OADBY & WIGSTON)
(PROHIBITION OF DRIVING) EXPERIMENTAL ORDER 2015

The Leicestershire County Council ("the Council") in exercise of its powers under Sections 9 and 10 (2) of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order:-

1. This Order shall come into force on the 14th day of December 2015 and may be cited as " The Leicestershire County Council (Bell Street, Wigston, Borough of Oadby & Wigston) (Prohibition of Driving) Experimental Order 2015 ".

2. (1) In this Order –

"motor vehicle" means any vehicle as defined by the Construction and Use Regulations 1986 (as amended) which is mechanically propelled except where otherwise provided;

"The Act" means The Road Traffic Regulation Act 1984.

3. The "Borough of Oadby and Wigston (Various Roads, Wigston Town Centre) (Traffic Management) Order 1999" And "The Leicestershire County Council (Various Roads, Wigston (Area 2), District of Oadby and Wigston) Consolidation, Amendment & Confirmation Of Experimental Order 2008" is hereby revoked in respect of that length of road specified in Schedule 2 to this Order.

4. No person shall, except upon the direction or with the permission of a police officer, a community support officer, or in accordance with the exemption provisions, cause or permit any person to drive any motor vehicle along the length of road as specified in Schedule 2 to this Order.

5. Except where otherwise stated, a reference in this Order to a numbered Article or Schedule is reference to the Article or Schedule bearing that number in this order.

6. The plan annexed to this Order and marked drawing number 4539.000/Z1/1/2 is for identification purposes only.


