

ROAD TRAFFIC REGULATION ACT 1984

LINCOLNSHIRE COUNTY COUNCIL

(OFF-STREET PARKING PLACES)

AMENDMENT ORDER 2023

THE LINCOLNSHIRE COUNTY COUNCIL in exercise of its powers under Sections 1, 2(1) and (2), 3, 4, 5, 32, 35, 45, 46, 49, 53, 124 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (the Act of 1984) as amended and the Traffic Management Act 2004 (the Act of 2004) and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order.

1. This Order shall come into operation on **24 August 2023** and may be cited as the Lincolnshire County Council (Off-Street Parking Places) Amendment Order 2023.
2. The Lincolnshire County Council (Off-Street Parking Places) Order 2021 shall be amended by the Lincolnshire County Council (Off-Street Parking Places) Amendment Order 2023.

3. Schedule 1 of the Lincolnshire County Council (Off-Street Parking Places)

Amendment Order 2023 shall be amended to have the following added:

Scarborough Avenue car park	Motorcycles; Motor Cars; Private Light Goods Vehicles	As indicated by white lines or signs or other markings.	Charges applicable 1 st March – 31 st October inclusive	Up to 2 hours = Free Up to 3 hours = £2.50 Up to 4 hours = £3.50 Over 4 hours (All Day) = £8.00 Blue Badge Holders = No Charge
Scarborough Avenue car park	Motorcycles; Motor Cars; Private Light Goods Vehicles	As indicated by white lines or signs or other markings.	1 st November to last day of February	Up to 2 hours = Free All Day = £2.00 Blue Badge Holders = No Charge

4. Any restriction or requirement made or having effect as if made under the Act of 1984 or any other enactment is hereby revoked insofar as it relates to the length and sides of road specified in this Order.

5. The prohibition imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act of 1984 or by or under any other enactment.
