**The City Council of Liverpool (Abbeyvale Drive Area)
(Revocation & 20mph Speed Limit Zone) Order, 2017**

The **City Council of Liverpool** (hereinafter referred to as "**the Council**") in exercise of its powers under **Sections 1, 2, 4, 84 & Part IV of Schedule 9 to The Road Traffic Regulation Act 1984** (which said Act of 1984 is hereinafter referred to as "**the Act of 1984**") and of all other enabling powers and after consultation with the chief officer of police in accordance with **Part III of Schedule 9** to the Act of 1984, hereby makes the following Order:-

Section 1: Commencement, Citation, Interpretations and General Articles

1. This Order shall come into operation on the **15th day of May 2017** and may be cited as: - **The City Council of Liverpool (Abbeyvale Drive Area) (Revocation & 20mph Speed Limit Zone) Order, 2017.**
2. (1) In this Order, except where otherwise stated, any reference in this Order to a numbered Article is a reference to the Article bearing that number in this Order.
3. The prohibition and restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act of 1984 or by or under any other enactment.

Section 2: Revocation

4. **The City Council of Liverpool (Abbeyvale Drive and Stapleford Road) (Twenty Miles Per Hour Speed Limit Zone) Order, 2007,** is hereby revoked in its entirety.

Section 3: 20mph Speed Limit Zone

5. No person shall cause or permit any vehicle to be driven at a speed in excess of 20 miles per hour on the entire lengths of: - (a) **Abbeyvale Drive;** (b) **Braehurst Way;** (c) **Endbrook Way;** & (d) **Stapleford Road.**

Section 4: Contravention Of The Order

6. Any person who contravenes **Article** of this Order, or who uses a vehicle, or causes or permits a vehicle to be used in contravention of **Article** of this Order, shall be guilty of an offence.
