**(Granby 4 Street Market) (Various Roads)
(Prohibition of Driving) Order, 2019**

The **City Council of Liverpool** (hereinafter referred to as "**the Council**") in exercise of its powers under **Sections 1 & 2 of The Road Traffic Regulation Act 1984** (which said Act of 1984 is hereinafter referred to as "**the Act of 1984**") and of all other enabling powers and after consultation with the chief officer of police in accordance with **Part III of Schedule 9** to the Act of 1984, hereby makes the following Order:-

Section 1: Commencement, Citation, Interpretations and General Articles

1. This Order shall come into operation **between the hours of 7.00 a.m. and 6.00 p.m.** on the **first Saturday of each month (except January)** commencing on the **6 day of April 2019** and may be cited as: - **The City Council of Liverpool (Granby 4 Street Market) (Various Roads) (Prohibition of Driving) Order, 2019.**
2. This Order shall make permanent the effect of **The City Council of Liverpool (Granby 4 Street Market) (Various Roads) (Prohibition of Driving) (Experimental) Order, 2017**, that was initially made under **Sections 9 & 10** of the Act of 1984 and came into operation on the **7 day of October 2017** for a maximum period of up to **eighteen months** and which would have expired on the **6 day of April 2019.**
3. Except where otherwise stated, any reference in this Order to a numbered Article is a reference to the Article bearing that number in this Order.
4. The prohibition and restriction imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act of 1984 or by or under any other enactment.

Section 2: Prohibition of Driving

5. No person shall cause or permit any vehicle to proceed in: - (1) **Cairns Street**, from its junction with Princes Avenue to its junction with Kingsley Road; (2) **Ducie Street**, from its junction with Granby Street to its junction with Kingsley Road; (3) **Jermyn Street**, from its junction with Princes Avenue to its junction with Kingsley Road; & (4) **Granby Street**, from its junction with Beaconsfield Road to its junction with Princes Avenue, **between the hours of 7.00 a.m. and 6.00 p.m. on the first Saturday of each month (except January).**

Section 3: Contravention Of The Order

6. Any person who contravenes **Article 5** of this Order, or who uses a vehicle, or causes or permits a vehicle to be used in contravention of **Article 5** of this Order, shall be guilty of an offence.
