(Speke Boulevard Slip Road) (Prohibition of Waiting & Prohibition of Loading and Unloading)
Order, 2018

The **City Council of Liverpool** (hereinafter referred to as "**the Council**") in exercise of its powers under **Sections 1(1) and (2), 2(1) to (3), 4(2) and Part IV of Schedule 9 to The Road Traffic Regulation Act 1984** (which said Act of 1984 is hereinafter referred to as "**the Act of 1984**") and of all other enabling powers and after consultation with the chief officer of police in accordance with **Part III of Schedule 9** to the Act of 1984, hereby makes the following Order:-

Section 1: Commencement, Citation, Interpretations and General Articles

1. This Order shall come into operation on the **28 day of May 2018** and may be cited as: - **The City Council of Liverpool (Speke Boulevard Slip Road) (Prohibition of Waiting & Prohibition of Loading and Unloading) Order, 2018.**

2. (1) In this Order, save as otherwise defined within this Order, each and every expression shall have the meaning assigned to it by **The Traffic Signs Regulations and General Directions 2016:-**

"**authorised cab rank**" means any area of carriageway which is comprised with and indicated by a road marking complying with **diagram 1028.2 in Schedule 2 of The Traffic Signs Regulations and General Directions, 2016;**

"**authorised parking place**" means any parking place on a road authorised or designated by an Order made or having effect as if made under the Act of 1984;

"**civil enforcement officer**" means a person authorized by or on behalf of the City of Liverpool under **Section 76 of The Traffic Management Act 2004** to supervise and enforce the restrictions imposed by Traffic Regulation Orders made by the Council.

"**disabled person**" means a disabled person of a description prescribed by **Regulation 2(1) of The Disabled Persons (Badges for Motor Vehicles) (England) Regulations, 2000.**

"**disabled person's badge**" has the same meaning as in **Regulation 2(1) of The Disabled Persons (Badges for Motor Vehicles) (England) Regulations, 2000**, as amended by **Regulation 10 of The Disabled Persons (Badges for Motor Vehicles) (England) (Amendment) Regulations, 2007**, and issued by a local authority for display on a Motor Vehicle driven by a Disabled Person or used for the carriage of a Disabled Person or of several Disabled Persons including a duplicate badge issued pursuant to the above Regulations.

"**disabled person's vehicle**" means a vehicle lawfully displaying in a conspicuous position a disabled person's badge and which is a vehicle, which, immediately before or after any period of waiting allowed by virtue of a provision of a kind required by **The Local Authorities' Traffic Orders (Exemptions for Disabled Persons) (England) Regulations 2000** to be included in an Order under the 1984 Act, has been or is to be driven by a disabled person or, as the case maybe, has been or is to be used for carrying disabled persons as passengers.

"**hackney carriage**" means a vehicle standing or plying for hire and holding a licence for the same under **The Town Police Clauses Act, 1847.**

"**hackney carriage stand**" means any area of carriageway designated as such by the Council under **Section 63 of The Local Government (Miscellaneous Provisions) Act, 1976.**

"**loading and unloading**" means the transference from (or to) a vehicle to (or from) premises adjacent to where the vehicle is parked of heavy or unmanageable Goods that are not designed to be carried by hand other than over a very short distance.

"**penalty charge**" and "**reduced penalty charge**" means a charge set by the City of Liverpool under the provisions of **Section 77 of The Traffic Management Act 2004** in accordance with guidance given by the Secretary of State for Transport which is to be paid in the manner described in the penalty charge notice not later than the last day of the period of 28 days beginning with the date on which the Penalty Charge Notice was served or 14 days of the date the notice was served in the case of a reduced penalty charge;

“**penalty charge notice**” means a notice issued by a civil enforcement officer pursuant to the provisions of **The Traffic Management Act 2004** and any Statutory Instruments made by the Secretary of State there under.

“**postal operator**” means a person who provides the service of conveying postal packets from one place to another by post or any of the incidental services of receiving, collecting, sorting and delivering such packets.

“**postal packet**” means a letter, parcel, packet or other article transmissible by post.

“**telecommunications apparatus**” has the same meaning as in **The Telecommunications Act 1984**.

2. (2) Except where otherwise stated, any reference in this Order to a numbered Article is a reference to the Article bearing that number in this Order.

3. The prohibition and restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act of 1984 or by or under any other enactment.

Section 2: Prohibitions Of Waiting & Loading and Unloading

4. Save as provided in **Article 6** no person shall, except upon the direction or with the permission of a police officer in uniform or of a civil enforcement officer, cause or permit any vehicle to wait at any time on **Speke Boulevard Slip Road, both sides**, from the city boundary to its junction with Speke Boulevard.

5. No person shall, except upon the direction or with the permission of a police officer in uniform or of a civil enforcement officer, cause or permit any vehicle to wait for the purposes of loading and unloading at any time on **Speke Boulevard Slip Road, both sides**, from the city boundary to its junction with Speke Boulevard.

Section 3: The Exemptions From The Waiting Restrictions

6. (1) Nothing in **Article 4** shall render it unlawful to cause or permit any vehicle to wait in **the said sides of lengths of road** referred to in that Article, for so long as may be necessary to enable: -

(a) a person to board or alight from the vehicle;

(b) the vehicle, if it cannot conveniently be used for such purposes in any other road, to be used in connection with any of the following operations, namely: -

(i) building, industrial or demolition operations;

(ii) the removal of any obstruction to traffic;

(iii) the maintenance, improvement or reconstruction of **the said sides of lengths of road**;

(iv) the laying, erection, alteration or repair in, or in land adjacent to, **the said road or length of road** of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telecommunications apparatus as defined in **Section 4 of The Telecommunications Act, 1984**, including telephone kiosks;

(c) the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in the service of a local authority in pursuance of statutory powers or duties;

(d) the vehicle to be used by a postal operator for the purpose of delivering or collecting postal packets from premises or postal boxes adjacent to **the said sides of lengths of road**;

(e) the vehicle to be used in connection with any wedding or funeral;

(f) the vehicle to be used for fire brigade, ambulance or police purposes; or

(g) the vehicle which, for a period not exceeding three hours, displays a valid disabled person's badge and parking disc/clock and that same vehicle is to be used by a disabled person whose badge and parking disc/clock is correctly on display in accordance with the **Department for Transport's** guidebook, **"The Blue Badge Scheme: Rights And Responsibilities In England"**;

6. (3) Nothing in **Article 4** shall render it unlawful to cause or permit any vehicle: -

(a) to wait upon an authorised parking place; or

(b) being a hackney carriage, to wait upon a hackney carriage stand.

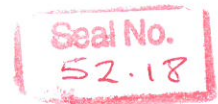
Section 4: Contravention Of The Order, Penalty Charge And Penalty Charge Notice

7. If a vehicle is left at any time in contravention of a provision of this Order a penalty charge shall be payable.
8. In the case of a vehicle in respect of which a penalty charge is payable, a penalty charge notice showing the information required by **The Traffic Management Act 2004** may then be issued by a civil enforcement officer in accordance with the requirements of that Act and any Statutory Instruments made by the Secretary of State there under.

(Baltic Weekender Event) (Greenland Street Area) (Temporary Prohibition of Driving) (Special Events) Order, 2018

Liverpool City Council (hereinafter referred to as "**the Council**") in exercise of its powers under **Section 16A of The Road Traffic Regulation Act, 1984**, and all enabling powers hereby makes the following Order:-

1. Citation, Commencement and Duration

1.1. This Order may be cited as: - **The City Council of Liverpool (Baltic Weekender Event) (Greenland Street Area) (Temporary Prohibition of Driving) (Special Events) Order, 2018.**

1.2. This **Order** shall come into effect on **both** the **25-27 May & 1-3 June 2018.**

2. Interpretation

2.1 "**the organisation**" means **Greenland Venue Management, 35-39 Greenland Street, Liverpool, L1 0BS (event organiser/manager contact details: - Rebecca Pope, telephone: - 0151-345-6302, email: - becky@constellations-liv.com)**

2.2 "**the event**" means the **Baltic Weekender Event.**

2.3 "**the event date(s)**", "**the event times**", "**the road(s)**" and "**the alternative route(s)**" (if any) mean those particular details which are specified within **Section 4 (The Restrictions).**

2.4 "**vehicle**" means any vehicle including a motor cycle; motor car; van; heavy goods vehicle; coach; articulated vehicle or any other vehicle of any description whatsoever.

3. Background

3.1. **The organisation** wishes to hold **the event** on **the event date(s)** during **the event times.**

3.2. **The event** will entail the use of **the road(s).**

3.3. **The council** is satisfied that traffic on **the road(s)** should be prohibited/suspended in the manner set out in **Section 4 (The Restrictions)** of this **Order** for the purposes of: - (a) Facilitating the holding of **the event**; (b) Enabling members of the public to watch **the event**; and (c) Reducing the disruption to traffic likely to be caused by **the event.**

3.4. **The organisation** has been made aware that all signage in respect to the temporary suspensions/prohibitions etc. and the alternative routes (if any) for vehicular traffic will be erected prior to, maintained throughout, and removed immediately after **the event date(s).**

3.5 In addition to ensuring that all restrictions are signed correctly, **the organisation** has been further made aware that the restrictions should also be staffed, where appropriate, by event officials/marshals/stewards whose presence shall be visibly maintained, like the signage, for as long as is necessary.

3.6 Furthermore, **the organisation** will make the necessary arrangements for the formal notification of the **Temporary Traffic Regulation (Special Events) Order** to the affected properties within the area.

4. The Restrictions

4. No person shall cause or permit any vehicle, other than an emergency services vehicle, to enter, leave or proceed in **Greenland Street, L1**, from its junction with Jamaica Street to its junction with Crump Street & **Newhall Street, L1**, from its junction with New Bird Street for the rest of its remaining length in a south westerly direction, **from 11.59pm on the 25 May 2018 until 2pm on the 27 May 2018** and again **from 6am on the 1 June 2018 until 2pm on the 3 June 2018** or for such lesser or greater period of time as determined on safety grounds.

5. Access for businesses will be available where applicable.

6. There will be a signed diversion in place.


5. Exemptions

7. The restrictions set out in **Section 4 (The Restrictions)** of this Order shall not apply:- (a) To anything done with the permission or at the direction of a Police Constable in uniform; & (b) To any vehicle being used for police, fire brigade or ambulance purposes or for the purposes of a statutory undertaker in any emergency (such as the loss of supplies of gas, electricity or water to premises in the area) which requires vehicles to be brought onto any section of highway to which the Order applies.

6. General

8. The Order will not have the effect of preventing at any time reasonable access for pedestrians to premises situated on or adjacent to any road to which the Order relates or to any premises only accessible to pedestrians from such a road.
