(Towerlands Street Area) (Revocation & Prohibition of Driving)
Order, 2018

The City Council of Liverpool (hereinafter referred to as "the Council") in exercise of its powers under Sections 1, 2, 4 & Part IV of Schedule 9 to The Road Traffic Regulation Act 1984 (which said Act of 1984 is hereinafter referred to as "the Act of 1984") and of all other enabling powers and after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

Section 1: Commencement, Citation, Interpretations and General Articles

1. This Order shall come into operation on the 12 day of November 2018 and may be cited as: - **The City Council of Liverpool (Towerlands Street Area) (Revocation & Prohibition of Driving) Order, 2018.**

2. (1) In this Order, save as otherwise defined within this Order, each and every expression shall have the meaning assigned to it by **The Traffic Signs Regulations and General Directions 2016:-**

"pedal cycle" means a pedal bicycle or pedal tricycle, not being in either case a motor vehicle;

2. (2) Except where otherwise stated, any reference in this Order to a numbered Article is a reference to the Article bearing that number in this Order.

3. The prohibition and restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act of 1984 or by or under any other enactment.

Section 2: Revocation

4. **The City Council of Liverpool (Mason Street, Highgate Street, Paddington and Helsby Street) (Revocation, Prohibition of Waiting and Revocation, Prohibition of Waiting and Parking Place for Loading and Unloading) Order, 2008**, is hereby revoked in full.

5. **The City Council of Liverpool (Mason Street and Paddington) (Prohibition of Waiting and Prohibition of Loading and Unloading) Order, 2011**, is hereby revoked in full.

Section 2: Prohibition Of Driving

6. No person shall cause or permit any vehicle, other than a pedal cycle, to proceed at any time in **Towerlands Street, west side**, from a point 45.8m north of its junction with Wavertree Road, in a northerly direction, for a distance of 3m.

Section 3: Contravention Of The Order

7. Any person who contravenes **Article 6** of this Order, or who uses a vehicle, or causes or permits a vehicle to be used in contravention of **Article 6** of this Order, shall be guilty of an offence.
