# The Parking Places and Controlled Parking Zone (Liverpool) (Order 2009) (Variation N°97) Order, 2018

The City Council of Liverpool (hereinafter referred to as "the Council") in exercise of its powers under Sections 1, 2, 3, 4, 9, 19, 32, 35, 38, 45, 46, 47, 48, 49, 50, 51, 52, 53 and Part IV of Schedule 9 of The Road Traffic Regulation Act 1984 (which said Act of 1984 is hereinafter referred to as "the Act of 1984") and of all other enabling powers and after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

#### 1. Commencement and Citation

This Order shall come into operation on the 22 day of October 2018 and may be cited as: - The Parking Places and Controlled Parking Zone (Liverpool) (Order 2009) (Variation N°97) Order, 2018.

### 2. Interpretation

- (1) In this Order except where the context otherwise requires, the several words and expressions for which meanings are assigned by the Order of 2009 shall have the same respective meaning.
- (2) Furthermore, in this Order the expression "Order of 2009" means The Parking Places and Controlled Parking Zone (Liverpool) Order 2009, as amended.

## Variation Of The Order Of 2009 As Respects Areas of Highway Designated As Parking Places With Ticket Issuing Machines And/Or Requiring The Display of Permits And/Or Vouchers Part I – Inner Zone

- 3. The Order of 2009 shall have effect as though in Schedule 1: -
- (a) The existing inner zone roads numbered **16A** & **16B** were omitted from the Order as specified in **Schedule 1** to this Order.
- (b) The new inner zone roads numbered 16A & 16B were included as specified in Schedule 2 to this Order.

# <u>Variation Of The Order Of 2009 As Respects Areas of Highway Designated As Parking Places With Ticket Issuing Machines And/Or Requiring The Display of Permits And/Or Vouchers Part II – Outer Zone (Multi-Use Parking Places)</u>

- 4. The Order of 2009 shall have effect as though in Schedule 1: -
- (a) The existing outer zone roads numbered 83C & 231A were omitted from the Order as specified in Schedule 3 to this Order.
- (b) The new outer zone roads numbered 11B, 83C, 231A, 231B & 231C were included as specified in Schedule 4 to this Order.

## <u>Variation Of The Order Of 2009 As Respects Areas Of Highways Designated As Parking Places For Vehicles For Loading And Unloading</u>

- 5. The Order of 2009 shall have effect as though in **Schedule 3: -**
- (a) The existing inner zone road numbered **175** was omitted from the Order as specified in **Schedule 5** to this Order.
- (b) The new inner zone roads numbered 16 & 175 were included as specified in **Schedule 6** to this Order.

### <u>Variation Of The Order Of 2009 As Respects Roads And Parts Of Roads In Which Waiting Is Prohibited</u> <u>Between The Hours Of 8.00 a.m. and 6.00 p.m. On Mondays To Sundays</u>

- 6. The Order of 2009 shall have effect as though in Schedule 14: -
- (a) The existing inner zone roads numbered **175A** & **175B** were omitted from the Order as specified in **Schedule 7** to this Order.
- (b) The new inner zone road numbered 175A was included as specified in Schedule 8 to this Order.
- (c) The existing outer zone road numbered **231** was omitted from the Order as specified in **Schedule 9** to this Order.
- (d) The new outer zone roads numbered **231A** & **231B** were included as specified in **Schedule 10** to this Order.

### <u>Variation Of The Order Of 2009 As Respects Roads And Parts Of Roads In Which Waiting Is Prohibited</u> Twenty-Four Hours A Day

- 7. The Order of 2009 shall have effect as though in Schedule 15: -
- (a) The existing inner zone road numbered **175C** was omitted from the Order as specified in **Schedule 11** to this Order.
- (b) The existing outer zone road numbered 231 was omitted from the Order as specified in Schedule 12 to this Order.
- (c) The new outer zone roads numbered 231A & 231B were included as specified in Schedule 13 to this Order.

<u>Variation Of The Order Of 2009 As Respects Roads And Parts Of Roads In Which Loading and Unloading Is Prohibited Between The Hours Of 8.30 a.m. and 9.30 a.m. and Between The Hours Of 4.30 p.m. and 6.00 p.m.</u>

- (a) The existing inner zone road numbered **175B** was omitted from the Order as specified in **Schedule 14** to this Order.
- (b) The existing outer zone road numbered **231** was omitted from the Order as specified in **Schedule 15** to this Order.
- (c) The new outer zone roads numbered 231A & 231B were included as specified in Schedule 16 to this Order.
