The City Council of Liverpool in exercise of its powers under Sections 1-4, 9, 19, 32, 35, 38, 45-53 and Part IV of Schedule 9 to The Road Traffic Regulation Act 1984 and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to The Road Traffic Regulation Act 1984 hereby makes the following Order:-

## 1. Commencement and Citation

This Order shall come into operation on the 14 day of January 2019 and may be cited as: - The City Council of Liverpool (Football Match Parking Places and Controlled Parking Zone) (Order 2009) (Variation N°49) Order, 2019.

## 2. Interpretation

- (1) In this Order except where the context otherwise requires, the several words and expressions for which meanings are assigned by the Order of 2009 shall have the same respective meaning.
- (2) In this Order the expression "Order of 2009" means The City Council of Liverpool Football Match Parking Places and Controlled Parking Zone Order, 2009 as amended.

## <u>Variation the Order of 2009 as respects Areas of Highway Designated as Disabled Residents Parking Places</u>

3. The Order of 2009 shall have effect as though in **Schedule 6**: - (a) the existing disabled resident parking places were omitted as described and numbered in **Schedule 1** to this Order; & (b) the new disabled resident parking place was included as described and numbered in **Schedule 2** to this Order
