The **City Council of Liverpool** in exercise of its powers under **Sections 1-4, 9, 19, 32, 35, 38, 45-53 and Part IV of Schedule 9 to The Road Traffic Regulation Act 1984** and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with **Part III of Schedule 9 to The Road Traffic Regulation Act 1984** hereby makes the following Order:-

1. Commencement and Citation

This Order shall come into operation on the 20 day of May 2019 and may be cited as: -

2. Interpretation

(1) In this Order except where the context otherwise requires, the several words and expressions for which meanings are assigned by the Order of 2009 shall have the same respective meaning.

(2) In this Order the expression "Order of 2009" means **The City Council of Liverpool Football Match Parking Places and Controlled Parking Zone Order, 2009** as amended.

Variation Of The Order Of 2009 As Respects Areas Of Highways Designated As Residents Parking Places

3. The Order of 2009 shall have effect as though in **Schedule 1** the new residents parking place (in the form of a **Permitted Parking Area**) was included as specified in **Schedule 1** to this Order.

Variation Of The Order Of 2009 As Respects Roads And Parts Of Roads In Which Waiting Is Prohibited Twenty-Four Hours Each Day

4. The Order of 2009 shall have effect as though in **Schedule 4**: -

(a) The existing waiting restrictions were omitted from the Order as specified in **Schedule 2** to this Order.

(b) The new waiting restrictions were included as specified in **Schedule 3** to this Order.

Variation Of The Order Of 2009 As Respects Roads And Parts Of Roads In Which Loading And Unloading Is Prohibited Between The Hours Of 5.00 p.m. And 10.00 p.m. On Mondays To Fridays Inclusive And Between The Hours Of 10.00 a.m. And 6.00 p.m. On Saturdays And Sundays From The Months Of August To May Inclusive

5. The Order of 2009 shall have effect as though in **Schedule 13**: -

(a) The existing loading and unloading restrictions were omitted from the Order as specified in **Schedule 4** to this Order.

(b) The new loading and unloading restrictions were included as specified in **Schedule 5** to this Order.
