The Parking Places and Controlled Parking Zone (Liverpool) (Order 2009) (Variation No115) Order, 2022

The City Council of Liverpool (hereinafter referred to as "the Council") in exercise of its powers under Sections 1-4, 9, 19, 32, 35, 38, 45-53 & Part IV of Schedule 9 of The Road Traffic Regulation Act 1984 (which said Act of 1984 is hereinafter referred to as "the Act of 1984") and of all other enabling powers and after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act of 1984. hereby makes the following Order:-

1. Commencement and Citation

This Order shall come into operation on the 24 day of October 2022 and may be cited as: - The Parking Places and Controlled Parking Zone (Liverpool) (Order 2009) (Variation N°115) Order, 2022.

2. Interpretation

- (1) In this Order except where the context otherwise requires, the several words and expressions for which meanings are assigned by the Order of 2009 shall have the same respective meaning.
- (2) Furthermore, in this Order the expression "Order of 2009" means The Parking Places and Controlled Parking Zone (Liverpool) Order 2009, as amended.

Variation Of The Order Of 2009 As Respects Areas Of Highways Designated As Parking Places For **Vehicles For Loading And Unloading**

3. The Order of 2009 shall have effect as though in Schedule 3 the new inner zone road numbered 55D was included as specified in Schedule 1 to this Order.

Variation Of The Order Of 2009 As Respects Areas Of Highways Designated As Disabled Persons' **Parking Places**

- 4. The Order of 2009 shall have effect as though in **Schedule 5:** -
- (a) The existing inner zone road numbered 55A was omitted from the Order as specified in Schedule 2 to this Order.
- (b) The new inner zone roads numbered **55A** was included as specified in **Schedule 3** to this Order.

Variation Of The Order Of 2009 As Respects Roads And Parts Of Roads In Which Waiting Is Prohibited Twenty-Four Hours A Day

5. The Order of 2009 shall have effect as though in **Schedule 15** the existing inner zone road numbered **55J** was omitted from the Order as specified in **Schedule 4** to this Order.

Variation Of The Order Of 2009 As Respects Roads And Parts Of Roads In Which Loading and Unloading Is Prohibited Between The Hours Of 8.00 a.m. and 6.00 p.m.

6. The Order of 2009 shall have effect as though in **Schedule 20** the existing inner zone road numbered **55M** was omitted from the Order as specified in **Schedule 5** to this Order.
