**The City Council of Liverpool**  
**(Horrocks Avenue and Island Road South)**  
**(Revocation and Prohibition of Driving)**  
**Order, 2009**

The **City Council of Liverpool** (hereinafter referred to as "**the Council**") in exercise of its powers under **Sections 1(1) and (2), 2(1) to (3), 4(2) and Part IV of Schedule 9 to The Road Traffic Regulation Act 1984** (which said Act of 1984 is hereinafter referred to as "**the Act of 1984**") and of all other enabling powers and after consultation with the chief officer of police in accordance with **Part III of Schedule 9** to the Act of 1984, hereby makes the following Order:-

**Section One – Commencement, Citation, Interpretations and General Articles**

1. This Order shall come into operation on the **11<sup>th</sup> day of May 2009** and may be cited as:-

**The City Council of Liverpool**  
**(Horrocks Avenue and Island Road South)**  
**(Revocation and Prohibition of Driving)**  
**Order, 2009**

2. (1) In this Order, save as otherwise defined within this Order, each and every expression shall have the meaning assigned to it by **The Traffic Signs Regulations and General Directions 2002**: -

"**pedal cycle**" means a pedal bicycle or pedal tricycle, not being in either case a motor vehicle;

2. (2) Except where otherwise stated, any reference in this Order to a numbered Article is a reference to the Article bearing that number in this Order.

3. The prohibition and restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act of 1984 or by or under any other enactment.

**Section Two – The Revocation Of Any Existing Traffic Regulation Orders Necessary To Accommodate This Order**

4. Any **Traffic Regulation Order** made by **Liverpool City Council** in so far as it relates to a prohibition of driving on **Horrocks Avenue** from **Horrocks Avenue Service Road** to **Island Road South**, is hereby revoked in so far as it relates to that particular prohibition.

**Section Three – The Prohibitions And Restrictions To This Order**

5. No person shall cause or permit any vehicle, other than a pedal cycle, to proceed in **Island Road South** at its junction with **Horrocks Avenue Service Road**.

**Section Four – Contravention Of The Order**

6. Any person who contravenes **Article 5** of this Order, or who uses a vehicle, or causes or permits a vehicle to be used in contravention of **Article 5** of this Order, shall be guilty of an offence.
