**The City Council of Liverpool (Brownlow Hill and Mount Pleasant)
(Revocation, Prohibition and Restriction of Waiting and Prohibition of
Loading and Unloading) Order, 2008**

The City Council of Liverpool (hereinafter referred to as "**the Council**") in exercise of its powers under **Sections 1(1) and (2), 2(1) to (3), 4(2) and Part IV of Schedule 9 to The Road Traffic Regulation Act 1984** (which said Act of 1984 is hereinafter referred to as "**the Act of 1984**") and of all other enabling powers and after consultation with the chief officer of police in accordance with **Part III of Schedule 9** to the Act of 1984, hereby makes the following Order:-

Section One – Commencement, Citation, Interpretations and General Articles

1. This Order shall come into operation on the **27th day of October 2008** and may be cited as: - **The City Council of Liverpool (Brownlow Hill and Mount Pleasant) (Revocation, Prohibition and Restriction of Waiting and Prohibition of Loading and Unloading) Order, 2008.**

2. (1) In this Order, save as otherwise defined within this Order, each and every expression shall have the meaning assigned to it by **The Traffic Signs Regulations and General Directions 2002**: -

"**authorised cab rank**" means any area of carriageway which is comprised with and indicated by a road marking complying with **diagram 1028.2** in **Schedule 2 of The Traffic Signs Regulations and General Directions, 2002**;

"**authorised parking place**" means any parking place on a road authorised or designated by an Order made or having effect as if made under the Act of 1984;

"**civil enforcement officer**" means a person authorized by or on behalf of the City of Liverpool under **Section 76 of The Traffic Management Act 2004** to supervise and enforce the restrictions imposed by Traffic Regulation Orders made by the Council.

"**disabled person**" means a disabled person of a description prescribed by **Regulation 2(1) of The Disabled Persons (Badges for Motor Vehicles) (England) Regulations, 2000.**

"**disabled person's badge**" has the same meaning as in **Regulation 2(1) of The Disabled Persons (Badges for Motor Vehicles) (England) Regulations, 2000**, as amended by **Regulation 10 of The Disabled Persons (Badges for Motor Vehicles) (England) (Amendment) Regulations, 2007.**

"**disabled person's vehicle**" means a vehicle lawfully displaying in a conspicuous position a disabled person's badge and which is a vehicle, which, immediately before or after any period of waiting allowed by virtue of a provision of a kind required by **The Local Authorities' Traffic Orders (Exemptions for Disabled Persons) (England) Regulations 2000** to be included in an Order under the 1984 Act, has been or is to be driven by a disabled person or, as the case maybe, has been or is to be used for carrying disabled persons as passengers.

"hackney carriage" means a vehicle standing or plying for hire and holding a licence for the same under **The Town Police Clauses Act, 1847**.

"hackney carriage stand" means any area of carriageway designated as such by the Council under **Section 63 of The Local Government (Miscellaneous Provisions) Act, 1976**.

"loading and unloading" means the transference from (or to) a vehicle to (or from) premises adjacent to where the vehicle is parked of heavy or unmanageable Goods that are not designed to be carried by hand other than over a very short distance.

"penalty charge" and **"reduced penalty charge"** means a charge set by the City of Liverpool under the provisions of **Section 77 of The Traffic Management Act 2004** in accordance with guidance given by the Secretary of State for Transport which is to be paid in the manner described in the penalty charge notice not later than the last day of the period of 28 days beginning with the date on which the Penalty Charge Notice was served or 14 days of the date the notice was served in the case of a reduced penalty charge;

"penalty charge notice" means a notice issued by a civil enforcement officer pursuant to the provisions of **The Traffic Management Act 2004** and any Statutory Instruments made by the Secretary of State there under.

"postal operator" means a person who provides the service of conveying postal packets from one place to another by post or any of the incidental services of receiving, collecting, sorting and delivering such packets.

"postal packet" means a letter, parcel, packet or other article transmissible by post.

"telecommunications apparatus" has the same meaning as in **The Telecommunications Act 1984**.

2. (2) Except where otherwise stated, any reference in this Order to a numbered Article is a reference to the Article bearing that number in this Order.

3. The prohibition and restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act of 1984 or by or under any other enactment.

Section Two – The Revocation In Part Of An Existing Traffic Regulation Order Which Is Necessary To Accommodate This Order

4. **The City Council of Liverpool (Brownlow Hill/Mount Pleasant) (Prohibition and Restriction of Waiting) Order, 1970**, is hereby revoked in so far as it relates to the restriction of waiting between the hours of 7.00 a.m. and 7.00 p.m., on Mondays to Saturdays inclusive: - (a) for a longer period than two hours; or (b) if a period of less than two hours has elapsed since the termination during the said hours of the last period of waiting (if any) of the vehicle on that side of road, on the northwest side of Mount Pleasant from a point opposite the north side of Oxford Street to a point 45.72 metres southwest of its junction with Brownlow Hill.

Section Three – The Prohibition And Restriction Of Waiting To This Order

5. Save as provided in **Article 9** no person shall, except upon the direction or with the permission of a police officer in uniform or of a civil enforcement officer, cause or permit any vehicle to wait at any time on: - (a) Brownlow Hill - (i) north side, from a point 163.3 metres east of its junction with Great Newton Street to a point 42.2 metres west of its junction with Peach Street; and (ii) south side, from a point 114.8 metres east of its junction with Great Newton Street in an easterly direction to a point 134.5 metres west of its junction with Crown Street ; and (b) Mount Pleasant, north west side, from its junction with Brownlow Hill in a south westerly direction for a distance of 85 metres.

6. Save as provided in **Article 9** no person shall, except upon the direction or with the permission of a police officer in uniform or of a civil enforcement officer, cause or permit any vehicle to wait between the hours of 7.00 a.m. and 7.00 p.m. on Mondays to Saturdays inclusive: - (a) for a longer period than two hours; or (b) if a period of less than two hours has elapsed since the termination during the said hours of the last period of waiting (if any) of the vehicle on that side of road, on Mount Pleasant, north west side, from a point 85 metres south west of its junction with Brownlow Hill in a south westerly direction to a point opposite the north side of Oxford Street.

7. Save as provided in **Article 9** no person shall, except upon the direction or with the permission of a police officer in uniform or of a civil enforcement officer, cause or permit any vehicle to wait between the hours of 8.00 a.m. and 6.00 p.m. on Mondays to Sundays inclusive on Brownlow Hill: - (a) north side from its junction with Great Newton Street in an easterly direction to a point 163.3 metres east of the said junction; (b) north side from a point 50 metres west of its junction with Crown Street in a westerly direction to a point 134.5 metres west of the said junction; (c) south side from its junction with Great Newton Street in an easterly direction to a point 114.8 metres east of the said junction; and (d) south side from a point 50 metres west of its junction with that part of Crown Street which is situated to the north of Brownlow Hill, in an westerly direction to a point 42.2 metres west of its junction with Peach Street.

Section Four – The Prohibition Of Loading And Unloading To This Order

8. Save as provided in **Article 9(1) and Article 9(3)** no person shall, except upon the direction or with the permission of a police officer in uniform or of a civil enforcement officer, cause or permit any vehicle to wait for the purposes of loading and unloading between the hours of 8.30 a.m. and 9.30 a.m. and between the hours of 4.30 p.m. and 6.00 p.m. Mondays to Saturdays inclusive on: - (a) Brownlow Hill – (i) north side, from a point 163.3 metres east of its junction with Great Newton Street to a point 134.5 metres west of its junction with Crown Street; and (ii) south side, from a point 114.8 metres east of its junction with Great Newton Street in an easterly direction to its junction with Mount Pleasant.; and (b) Mount Pleasant, north west side, from its junction with Brownlow Hill in a south westerly direction for a distance of 74.9 metres.

Section Three – The Exemptions From The Waiting Restrictions To This Order

9. (1) Nothing in **Article 5, Article 6, Article 7** or in **Article 8** shall render it unlawful to cause or permit any vehicle to wait in **the said sides of lengths of roads** referred to in

those Articles, for so long as may be necessary to enable: - (a) a person to board or alight from the vehicle; (b) the vehicle, if it cannot conveniently be used for such purposes in any other road, to be used in connection with any of the following operations, namely: - (i) building, industrial or demolition operations; (ii) the removal of any obstruction to traffic; (iii) the maintenance, improvement or reconstruction of **the said sides of lengths of roads**; (iv) the laying, erection, alteration or repair in, or in land adjacent to, **the said sides of lengths of roads** of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telecommunications apparatus as defined in **Section 4 of The Telecommunications Act, 1984**, including telephone kiosks; (c) the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in the service of a local authority in pursuance of statutory powers or duties; (d) the vehicle to be used by a postal operator for the purpose of delivering or collecting postal packets from premises or postal boxes adjacent to **the said sides of lengths of roads**; (e) the vehicle to take in petrol, oil, water or air from any garage situated in or adjacent to **the said sides of lengths of roads**; (f) the vehicle to be used in connection with any wedding or funeral; (g) the vehicle to be used for fire brigade, ambulance or police purposes; or (h) the vehicle being a disabled person's vehicle displaying a disabled person's badge to be used by a disabled person.

9. (2) Nothing in **Article 5, Article 6** or in **Article 7** shall render it unlawful to cause or permit any vehicle to wait in **the said sides of lengths of roads** referred to in those Articles, for so long as may be necessary to enable goods to be loaded on to or unloaded from the vehicle;


9. (3) Nothing in **Article 5, Article 6, Article 7** or in **Article 8** shall render it unlawful to cause or permit any vehicle: - (a) to wait upon an authorised parking place; or (b) being a hackney carriage, to wait upon a hackney carriage stand.

Section Four – Contravention Of The Order,
Penalty Charge And Penalty Charge Notice

10. If a vehicle is left at any time in contravention of a provision of this Order a penalty charge shall be payable.

11. In the case of a vehicle in respect of which a penalty charge is payable, a penalty charge notice showing the information required by **The Traffic Management Act 2004** may then be issued by a civil enforcement officer in accordance with the requirements of that Act and any Statutory Instruments made by the Secretary of State there under.
