7. The Order of 2006 shall have effect as though in **Schedule 15**, the new twenty-four hour waiting restrictions on **Bankfield Road** was included as specified in **Schedule 1** to this Order.

# Section Three Variation Of Order Of 2006 As Respects Roads And Parts Of Roads In Which Loading And Unloading Is Prohibited Twenty-Four Hours A Day

8. The Order of 2006 shall have effect as though in **Schedule 17**, the new twenty-four hour loading and unloading restrictions inclusive on **Bankfield Road** was included as specified in **Schedule 2** to this Order.
