## ROAD TRAFFIC REGULATION ACT 1984 - SECTIONS 64 AND 65 AUTHORISATION OF TRAFFIC SIGNS AND SPECIAL DIRECTIONS

The Secretary of State for Transport, in exercise of his powers under Sections 64 and 65 of the Road Traffic Regulation Act 1984 and of all other powers enabling him in that behalf, for the purpose of informing road users of conditions attached to the use of parking places in Liverpool, hereby:-

- 1. authorises the erection at or within 5 metres of the sites marked with a red cross on the attached schedule of plans numbered GT46/2/132(Pt1) 4 of a traffic sign (hereinafter referred to as "the authorised sign A") conforming as to size, colour, and character with that shown at A on the attached schedule of drawings numbered GT46/2/132(Pt1) 5; and
- 2. authorises the erection at or within 5 metres of the sites marked with a blue cross on the attached schedule of plans numbered GT46/2/132(Pt1) 6 of a traffic sign (hereinafter referred to as "the authorised sign B") conforming as to size, colour, and character with that shown at B on the said schedule of drawings; and
- 3. authorises the placing at or within 5 metres of the sites marked with a green cross on each schedule of plans of a traffic sign consisting of a road marking (hereinafter referred to as "the authorised marking") conforming as to size, colour, and character with the vertical broken line and legend shown in diagram 1028.4 in Schedule 6 to the Traffic Signs Regulations 2002 (Part I to SI 2002/3113, "the 2002 Regulations"), save that the legend shall read "RESIDENTS PARKING" as indicated schematically at C on the said schedule of drawings; and
- 4. directs that the road marking shown in diagram 1028.4 in Schedule 6 to the 2002 Regulations need not be used in conjunction with the authorised signs A and B; and
- 5. directs that, notwithstanding the provisions of Direction 24 of the Traffic Signs General Directions 2002 (Part II to SI 2002/3113), the road marking shown in diagram 1028.4 in Schedule 6 to the 2002 Regulations need not be used in conjunction with the sign shown in diagram 660.3 in Schedule 2 to those Regulations when erected within the hatched roads on each schedule of plans; and



- 6. directs, that it is a condition of this authorisation that the authorised signs A and B shall only be erected, and the authorised marking laid, to indicate the effect of a corresponding Traffic Regulation Order; and
- 7. directs, without prejudice to any statutory provision to the like effect, that it is a condition of this authorisation that the erection of the authorised signs A and B and the laying of the authorised marking at or near the said sites shall continue to have effect only until such day as may be appointed by one month's notice given by the Secretary of State in writing to the traffic authority for the removal or alteration of the authorised signs and marking and on that day the said authorisation shall, without prejudice to the giving of any further authorisation or direction, cease to have effect.

The provisions of Regulations 12, 18 and 19 of the 2002 Regulations shall apply to the authorised signs A and B in the same manner as they apply to the sign shown in diagram 660 in Schedule 2 to those Regulations.

The provisions of Regulations 12 and 31 of the 2002 Regulations shall apply to the authorised marking in the same manner as they apply to the road marking shown in diagram 1028.4 in Schedule 6 to those Regulations.
