The City Council of Liverpool (hereinafter referred to as "the Council") in exercise of its powers under Section 9 of The Road Traffic Regulation Act 1984 (which said Act of 1984 is hereinafter referred to as "the Act of 1984") as amended by The Road Traffic (Parking) Act 1986 (hereinafter referred to as "the Act of 1986") and Section 43 of Schedule 3 of The Road Traffic Act 1991 (hereinafter referred to as "the Act of 1991") and of all other enabling powers and after consultation with the Chief Officer of Police, the Traffic Commissioner for the North West and the Merseyside Passenger Transport Executive in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Experimental Traffic Regulation Order: -

Section One - Commencement, Citation, Interpretations and General Articles

- 1(a). This Order shall come into operation on the 27th day of June 2011 and may be cited as: The City Council of Liverpool (North Part 1 Stationary Vehicle Offences) (Consolidation) (Order 2006) (Experimental Variation N°72) Order, 2011
- 1(b). This Experimental Traffic Regulation Order shall remain in force for a maximum period of up to eighteen months expiring on the 24th day of December 2012.
- 2. In this **Experimental Traffic Regulation Order** except where the context otherwise requires, the several words and expressions for which meanings are assigned by the Order of 2006 shall have the same respective meaning.
- 3. - 4. Except where otherwise stated, any reference in this **Experimental Traffic Regulation Order** to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this **Experimental Traffic Regulation Order**.
- 5. The prohibitions and restrictions imposed by this **Experimental Traffic Regulation Order** shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act of 1984 or by or under any other enactment.

Section Two - Variation Of Order Of 2006 As Respects Schedule 2 (Areas Of Highway Designated <u>As Parking Places Without Charge)</u>

6. The Order of 2006 shall have effect as though in Schedule 2 (Areas Of Highway Designated As Parking Places Without Charge): - (a) the existing parking places without charge on Thomas Drive, (north side) were omitted as specified in Schedule 1 to this Order; & (b) the parking places without charge on Thomas Drive (north side), Bowring Park Road (Slip Road) (north east side) and Rockville Road (south east side), were included as specified in Schedule 2 to this Order.

<u>Section Two - Variation Of Order Of 2006 As Respects Schedule 15 (Roads And Parts Of Roads In Which Waiting In Prohibited Twenty Four Hours A Day)</u>

7. The Order of 2006 shall have effect as though in Schedule 15 (Roads And Parts Of Roads In Which Waiting In Prohibited Twenty Four Hours A Day) the new twenty-four hour no waiting restriction on Queens Drive, Stoneycroft (east side), Bowring Park Road (Slip Road) (north east side) and Rockville Road (north west and south east sides) were included as specified in Schedule 3 to this Order.
