The City Council of Liverpool (hereinafter referred to as "**the Council**") in exercise of its powers under **Sections 1, 2, 3, 4, 9, 19, 32, 35, 38, 45, 46, 47, 48, 49, 50, 51, 52, 53** and **Part IV** of **Schedule 9** of **The Road Traffic Regulation Act 1984** (which said Act of 1984 is hereinafter referred to as "**the Act of 1984**") and of all other enabling powers and after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

1. Commencement and Citation

This Order shall come into operation on the **24th** day of **January 2011** and may be cited as: - **The Parking Places And Controlled Parking Zone (Liverpool) (Order 2009) (Variation No.24) Order, 2011.**

2. Interpretation

(1) In this Order except where the context otherwise requires, the several words and expressions for which meanings are assigned by the Order of 2009 shall have the same respective meaning.

3. The Order of 2009 shall have effect as though in **Schedule 2**: -

(a) The existing outer zone roads numbered **330A**, **330B** and **330C** were omitted from the Order as specified in **Schedule 1** to this Order.

(b) The new outer zone roads numbered **330A**, **330B** and **330C** were included as specified in **Schedule 2** to this Order.

Variation Of Order Of 2009 As Respects Roads And Parts Of Roads In Which Waiting Is Prohibited Between The Hours Of 8.00 a.m. and 6.00 p.m. On Mondays To Sundays (Outer Zone)

4. The Order of 2009 shall have effect as though in **Schedule 14**: -

(a) The existing outer zone roads numbered **330A**, **330B** and **330C** were omitted from the Order as specified in **Schedule 3** to this Order.

(b) The new outer zone roads numbered **330A**, **330B** and **330C** were included as specified in **Schedule 4** to this Order.

Variation Of Order Of 2009 As Respects Roads And Parts Of Roads In Which Waiting Is Prohibited Twenty-Four Hours A Day (Outer Zone)

5. The Order of 2009 shall have effect as though in **Schedule 15**: -

(a) The existing outer zone road numbered **330A** was omitted from the Order as specified in **Schedule 5** to this Order.

(b) The new outer zone roads numbered **330A** and **330D** were included as specified in **Schedule 6** to this Order.

Variation Of Order Of 2009 As Respects Roads And Parts Of Roads In Which Loading and Unloading Is Prohibited At Any Time (Outer Zone)

6. The Order of 2009 shall have effect as though in **Schedule 18** the new outer zone road numbered **330** was included as specified in **Schedule 7** to this Order.
