The Parking Places and Controlled Parking Zone (Liverpool) (Order 2009) (Variation No.36) Order, 2011

The City Council of Liverpool (hereinafter referred to as "the Council") in exercise of its powers under Sections 1, 2, 3, 4, 9, 19, 32, 35, 38, 45, 46, 47, 48, 49, 50, 51, 52, 53 and Part IV of Schedule 9 of The Road Traffic Regulation Act 1984 (which said Act of 1984 is hereinafter referred to as "the Act of 1984") and of all other enabling powers and after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

1. Commencement and Citation

This Order shall come into operation on the 21st day of November 2011 and may be cited as: - The Parking Places And Controlled Parking Zone (Liverpool) (Order 2009) (Variation No.36) Order, 2011.

2. Interpretation

- (1) In this Order except where the context otherwise requires, the several words and expressions for which meanings are assigned by the Order of 2009 shall have the same respective meaning.

Variation Of Order Of 2009 As Respects - Part II - Restriction On Use Of Parking Places

3. The Order of 2009 shall have effect as though in Part II - Restriction On Use Of Parking Places the existing Article 24 (Loading Bays and Pavement Loading Bays) were substituted for the new Article 24 (Loading Bays and Pavement Loading Bays) as specified below in this Order:-

Loading Bays and Pavement Loading Bays

- 24. No person shall leave a vehicle at any time at a Loading Bay (or a Pavement Loading Bay specifically described as such within Schedule 3 in the marked bay on the footway and bounded by a road traffic sign to diagram 1028.3 of The Traffic Signs Regulations and General Directions 2002): -
- 24.1 Other than a motor vehicle which is left at such Loading Bay for the purpose of loading and/or unloading heavy or unmanageable goods that are not designed to be carried by hand other than over a very short distance; and
- 24.2 Unless the vehicle is left at the Loading Bay specified in Column 2 of Schedule 3 to this Order during the hours specified in the corresponding part of Column 5 of Schedule 3 during the days specified in the corresponding part of Column 4 of Schedule 3, for a maximum period not exceeding that specified in Column 6 of Schedule 3 for the purpose of loading and/or unloading heavy or unmanageable goods that are not designed to be carried by hand other than over a very short distance; and
- 24.3 Unless the vehicle is left at the Loading Bay specified in Schedule 31 to this Order during the hours 6.00 p.m. to 10.00 a.m. for a maximum period not exceeding 1 hour for the purpose of loading and/or unloading heavy or unmanageable goods that are not designed to be carried by hand other than over a very short distance; and
- 24.4 During the maximum period for which vehicles may load and/or unload goods the driver, or other person in charge of a vehicle using a loading bay, shall not cause such vehicle to wait thereon during the hours of operation other than whilst goods, that are not designed to be carried by hand other than over a very short distance, are being continuously loaded or unloaded from the vehicle.

<u>Variation Of Order Of 2009 As Respects - Part IV – Provisions As To Permits, Vouchers And Badges</u>

4. The Order of 2009 shall have effect as though in Part IV - Provisions As To Permits, Vouchers And Badges the existing Article 61 (Display of Permit) were substituted for the new Article 61 (Display of Permit) as specified below in this Order:-

Display of Permit

- 61. A Permit issued under the provisions of this Order shall be displayed as follows:-
- 61.1. in the case of a vehicle fitted with a front windscreen on the near side thereon and immediately behind the windscreen and with its front facing forward so as to be legible from

outside the vehicle; or on the vehicle dashboard or fascia, so that the expiry date, permit type, vehicle registration etc recorded on the Permit are clearly visible to a person standing at the front or nearside of such vehicle for the whole of the time during which such vehicle is left at the Parking Place; or

61.2. in the case of a vehicle not fitted with a front windscreen, in a conspicuous position on the vehicle.

Variation Of Order Of 2009 As Respects Areas Roads And Parts Of Roads In Which Waiting Is Prohibited Between The Hours Of 8.00 a.m. and 6.00 p.m. On Mondays To Sundays (Outer Zone)

5. The Order of 2009 shall have effect as though in Schedule 14 the existing outer zone roads numbered 18E, 346, 347A, 347B, 352A, 352B, 354, 356A, 356B, 358 and 363 were omitted from the Order as specified in Schedule 1 to this Order.

Variation Of Order Of 2009 As Respects Areas Roads And Parts Of Roads In Which Waiting Is Prohibited Twenty-Four Hours A Day (Outer Zone)

6. The Order of 2009 shall have effect as though in Schedule 15: - (a) The existing outer zone roads 18H, 347A, 347B, 349, 352A, 352B, 352C, 356A, 356B, 357, 363 and 490 numbered were omitted from the Order as specified in Schedule 2 to this Order; & (b) The new outer zone roads numbered 18C, 18D, 349, 356A, 356B, 363A, 363B, 439E and 439F were included as specified in Schedule 3 to this Order.

Variation Of Order Of 2009 As Respects Areas Roads And Parts Of Roads In Which Loading and Unloading Is Prohibited Between The Hours Of 8.30 a.m. and 9.30 a.m. and Between The Hours Of 4.30 p.m. and 6.00 p.m. (Outer Zone)

7. The Order of 2009 shall have effect as though in **Schedule 17** the existing outer zone road numbered **363** was omitted from the Order as specified in **Schedule 4** to this Order.

Variation Of Order Of 2009 As Respects Areas Roads And Parts Of Roads In Which Loading and Unloading Is Prohibited At Any Time (Outer Zone)

8. The Order of 2009 shall have effect as though in **Schedule 18:** - (a) The existing outer zone roads numbered **18C** and **349** were omitted from the Order as specified in **Schedule 5** to this Order; & (b) The new outer zone roads numbered **18C**, **18F**, **349**, **356A**, **356B**, **363**, **439A** and **439B** were included as specified in **Schedule 6** to this Order.
