The Parking Places and Controlled Parking Zone (Liverpool) (Order 2009) (Experimental Variation No.34) Order, 2011

The City Council of Liverpool (hereinafter referred to as "the Council") in exercise of its powers under Section 9 of The Road Traffic Regulation Act 1984 (which said Act of 1984 is hereinafter referred to as "the Act of 1984") and of all other enabling powers and after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Experimental Traffic Regulation Order:-

1. Commencement and Citation

- (a) This Experimental Traffic Regulation Order shall come into operation on the 1st day of August 2011 and may be cited as The Parking Places And Controlled Parking Zone (Liverpool) (Order 2009) (Experimental Variation No.34) Order, 2011.
- (b) This Experimental Traffic Regulation Order shall remain in force for a maximum period of up to eighteen months expiring on the 28th day of January 2013.

2. Interpretation

- (1) In this **Experimental Traffic Regulation Order** except where the context otherwise requires, the several words and expressions for which meanings are assigned by the Order of 2009 shall have the same respective meaning.
