## The City Council of Liverpool (Football Match Parking Places and Controlled Parking Zone) (Order 2009) (Variation No.4) Order, 2009

The City Council of Liverpool in exercise of its powers under Sections 1, 2, 3, 4, 9, 19, 32, 35, 38, 45, 46, 47, 48, 49, 50, 51, 52, 53 and Part IV of Schedule 9 to The Road Traffic Regulation Act 1984 and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to The Road Traffic Regulation Act 1984 hereby makes the following Order:-

## 1. Commencement and Citation

This Order shall come into operation on the 30<sup>th</sup> day of September 2009 and may be cited as

The City Council of Liverpool (Football Match Parking Places and Controlled Parking Zone) (Order 2009) (Variation No.4) Order, 2009

## 2. Interpretation

- (1) In this Order except where the context otherwise requires, the several words and expressions for which meanings are assigned by the Order of 2009 shall have the same respective meaning.
- (2) In this Order the expression "Order of 2009" means The City Council of Liverpool Football Match Parking Places and Controlled Parking Zone Order, 2009 as amended by The City Council of Liverpool (Football Match Parking Places and Controlled Parking Zone) (Order 2009) (Variation No.1) Order, 2009; The City Council of Liverpool (Football Match Parking Places and Controlled Parking Zone) (Order 2009) (Variation No.2) Order, 2009; and The City Council of Liverpool (Football Match Parking Places and Controlled Parking Zone) (Order 2009) (Variation No.3) Order, 2009.
- 3. Variation Of The Order Of 2009 As Respects Roads And Parts Of Roads In Which Waiting Is Prohibited Between The Hours Of 5.00 p.m. And 10.00 p.m. On Mondays To Fridays Inclusive And Between The Hours Of 10.00 a.m. And 6.00 p.m. On Saturdays And Sundays From The Months Of August To May Inclusive

The Order of 2009 shall have effect as though in Schedule 3: -

- (a) The existing length of Oxton Street (from a point 10 metres west of its junction with Goodison Road for its entire length) was omitted from the Order.
- (b) The new lengths of **Oxton Street (southern and northern sides)** were included as contained in **Schedule 1** to this Order.

## 4. Variation Of The Order Of 2009 As Respects Roads And Parts Of Roads In Which Waiting Is Prohibited 24 Hours Each Day

The Order of 2009 shall have effect as though in **Schedule 4** there were included the new lengths of **Oxton Street (southern side)** as contained in **Schedule 2** to this Order.
