The City Council of Liverpool (hereinafter referred to as "the Council") in exercise of its powers under Sections 1, 2, 4, 19, 32, 35, 38, 45, 46, 49, 53 and Part IV of Schedule 9 to The Road Traffic Regulation Act 1984 (which said Act of 1984 is hereinafter referred to as "the Act of 1984") as amended by The Road Traffic (Parking) Act 1986 (hereinafter referred to as "the Act of 1986") and Section 43 of Schedule 3 of The Road Traffic Act 1991 (hereinafter referred to as "the Act of 1991") and of all other enabling powers and after consultation with the Chief Officer of Police, the Traffic Commissioner for the North West and the Merseyside Passenger Transport Executive in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order: -

**Section One**  
**Commencement, Citation, Interpretations and General Articles**

1. This Order shall come into operation on the 14<sup>th</sup> day of December 2009 and may be cited as: -

4. Except where otherwise stated, any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.

5. The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act of 1984 or by or under any other enactment.

## Section Two

### The Prohibition Of Waiting Restrictions To This Order

6. The Order of 2006 shall have effect as though in: -

(a) **Schedule 15 (Roads And Parts Of Roads In Which Waiting Is Prohibited Twenty-Four Hours A Day)** the new lengths of **Everton Road** and **Lytton Street (both sides)** were included as specified in the **Schedule 1** to this Order.

(b) **Schedule 16 (Roads And Parts Of Roads In Which Waiting Is Prohibited At Certain Times)** the new length of no waiting between the hours of 8.00 a.m. and 6.00 p.m. on any day other than a Sunday on **Everton Road (north east side)** was included as specified in the **Schedule 2** to this Order.
