**The City Council of Liverpool** (hereinafter referred to as “**the Council**”) in exercise of its powers under **Sections 1, 2, 4, 84 and Part IV of Schedule 9 to The Road Traffic Regulation Act 1984** (which said Act of 1984 is hereinafter referred to as “**the Act of 1984**”) and of all other enabling powers and after consultation with the **Chief Officer of Police, the Traffic Commissioner for the North West and the Merseyside Passenger Transport Executive** in accordance with **Part III of Schedule 9 to the Act of 1984**, hereby makes the following Order:-

**Section One - Commencement, Citation, Interpretations and General Articles**

1. This Order shall come into operation on the 18<sup>th</sup> day of January 2010 and may be cited as: - **The City Council of Liverpool (North – Part 2 Moving Vehicle Offences) (Consolidation) (Order 2006) (Variation N°37) Order 2010.**

2. In this Order except where the context otherwise requires, the several words and expressions for which meanings are assigned by the Order of 2006 shall have the same respective meaning.

3. 4. Except where otherwise stated, any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.

5. The prohibition and restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act of 1984 or by or under any other enactment.

**Section Two – Variation Of Order Of 2006 As Respects The Partial Revocation Of An Existing Traffic Regulation Order Which Is Necessary To Accommodate This Order**

6. The City Council of Liverpool (Blackmoor Drive) (Prohibition of Driving and Prohibition of Waiting) Order, 1976, is hereby revoked in so far as it relates to any vehicle proceeding in (a) a south-westerly direction along Honeys Green Lane from making a right turn into Blackmoor Drive; and (b) a north-westerly direction along Blackmoor Drive, southeast of its junction with Honeys Green Lane, entering Blackmoor Drive northwest of Honeys Green Lane.

**Section Three – Variation Of Order Of 2006 As Respects One-Way Traffic Flows**

7. The Order of 2006 shall have effect as though in **Schedule 1** there was included the new one-way traffic flow on **Alder Road** as specified in **Schedule 1** to this Order.

**Section Four – Variation Of Order Of 2006 As Respects Prohibitions Of Entry**

8. The Order of 2006 shall have effect as though in **Schedule 2** there were included the new prohibitions of entry on **Blackmoor Drive** and **Honeys Green Lane** as specified in **Schedule 2** to this Order
