<u>Section Two</u> <u>Variation Of Order Of 2006 As Respects Roads And Parts Of Roads In Which Waiting Is</u> <u>Prohibited Twenty-Four Hours A Day</u>

- 6. The Order of 2006 shall have effect as though in Schedule 15: -
- (a) The existing twenty four hour no-waiting restrictions on Richmond Row (North, South and South East sides) were omitted as specified in Schedule 1 to this Order.
- (b) The new twenty four hour no-waiting restrictions on Richmond Row (North and South sides) were included as specified in Schedule 2 to this Order.

<u>Section Three</u> <u>Variation Of Order Of 2006 As Respects Roads And Parts Of Roads In Which Loading And Unloading Is Prohibited At Certain Times</u>

- 7. The Order of 2006 shall have effect as though in Schedule 18: -
- (a) The existing no-waiting for the purpose of loading and unloading at certain times restrictions on **Richmond Row (North West and South East sides)** were omitted as specified in **Schedule 3** to this Order.

(b) The new no-waiting for the purpose of loading and unloading at certain times restrictions on Richmond Row (North and South sides) were included as specified in Schedule 4 to this Order.
