The City Council of Liverpool (hereinafter referred to as "**the Council**") in exercise of its powers under Sections 1, 2, 4, 19, 32, 35, 38, 45, 46, 49, 53 and Part IV of Schedule 9 to **The Road Traffic Regulation Act 1984** (which said Act of 1984 is hereinafter referred to as "**the Act of 1984**") as amended by **The Road Traffic (Parking) Act 1986** (hereinafter referred to as "**the Act of 1986**") and **Section 43** of **Schedule 3** of **The Road Traffic Act 1991** (hereinafter referred to as "**the Act of 1991**") and of all other enabling powers and after consultation with the **Chief Officer of Police, the Traffic Commissioner for the North West** and the **Merseyside Passenger Transport Executive** in accordance with **Part III** of **Schedule 9** to the Act of 1984, hereby makes the following Order: -

Section One
Commencement, Citation, Interpretations and General Articles

1. This Order shall come into operation on the 11th day of January 2010 and may be cited as: -

4. Except where otherwise stated, any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.

5. The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act of 1984 or by or under any other enactment.

Section Two

Variation Of Order Of 2006 As Respects Roads And Parts Of Roads In Which Waiting Is Prohibited Twenty-Four Hours A Day

6. The Order of 2006 shall have effect as though in **Schedule 15**: -

(a) The existing twenty four hour no-waiting restrictions on **Richmond Row (North, South and South East sides)** were omitted as specified in **Schedule 1** to this Order.

(b) The new twenty four hour no-waiting restrictions on **Richmond Row (North and South sides)** were included as specified in **Schedule 2** to this Order.

Section Three

Variation Of Order Of 2006 As Respects Roads And Parts Of Roads In Which Loading And Unloading Is Prohibited At Certain Times

7. The Order of 2006 shall have effect as though in **Schedule 18**: -

(a) The existing no-waiting for the purpose of loading and unloading at certain times restrictions on **Richmond Row (North West and South East sides)** were omitted as specified in **Schedule 3** to this Order.

(b) The new no-waiting for the purpose of loading and unloading at certain times restrictions on **Richmond Row (North and South sides)** were included as specified in **Schedule 4** to this Order.
