**The City Council of Liverpool
(Brook Street) (Revocation and One-Way Traffic)
Order, 2011**

The City Council of Liverpool (hereinafter referred to as "the Council") in exercise of its powers under Sections 1(1) and (2), 2(1) to (3), 4(2) and Part IV of Schedule 9 to The Road Traffic Regulation Act 1984 (which said Act of 1984 is hereinafter referred to as "the Act of 1984") and of all other enabling powers and after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

Section One – Commencement, Citation, Interpretations and General Articles

1. This Order shall come into operation on the 18th day of July 2011 and may be cited as: - **The City Council of Liverpool (Brook Street) (Revocation and One-Way Traffic) Order, 2011.**
2. Except where otherwise stated, any reference in this Order to a numbered Article is a reference to the Article bearing that number in this Order.
3. The prohibition and restriction imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act of 1984 or by or under any other enactment.

Section Two – Revocation Of An Existing Traffic Regulation Order Which Is Necessary To Accommodate This Particular Order

4. **The City Council of Liverpool (Brook Street) (Revocation, Prohibition of Waiting, Prohibition of and Restriction of Loading and Unloading, One-Way Traffic and Car Club Parking Spaces) Order, 2009,** is hereby revoked in its entirety.

Section Three – One-Way Traffic Flow To This Order

5. No person shall cause or permit any vehicle to proceed in Brook Street, in a direction other than from Old Hall Street in a south westerly direction to King Edward Street

**Section Four – Contravention Of The Order,
Penalty Charge And Penalty Charge Notice**

6. Any person who contravenes Article 5 of this Order, or who uses a vehicle, or causes or permits a vehicle to be used in contravention of Article 5 of this Order, shall be guilty of an offence.
