The City Council of Liverpool (hereinafter referred to as "the Council") in exercise of its powers under Sections 1, 2, 4, 19, 32, 35, 38, 45, 46, 49, 53 and Part IV of Schedule 9 to The Road Traffic Regulation Act 1984 (which said Act of 1984 is hereinafter referred to as "the Act of 1984") as amended by The Road Traffic (Parking) Act 1986 (hereinafter referred to as "the Act of 1986") and Section 43 of Schedule 3 of The Road Traffic Act 1991 (hereinafter referred to as "the Act of 1991") and of all other enabling powers and after consultation with the Chief Officer of Police, the Traffic Commissioner for the North West and the Merseyside Passenger Transport Executive in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order: -

Section One Commencement, Citation, Interpretations and General Articles

- 1. This Order shall come into operation on the 18th day of July 2011 and may be cited as: The City Council of Liverpool (North Part 1 Stationary Vehicle Offences) (Consolidation) (Order 2006) (Variation N°74) Order 2011.
- 2. In this Order except where the context otherwise requires, the several words and expressions for which meanings are assigned by the Order of 2006 shall have the same respective meaning.
- 3. - 4. Except where otherwise stated, any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.
- 5. The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act of 1984 or by or under any other enactment.

Section Two - Variation Of Order Of 2006 As Respects Section Five "Revocations"

- 6. The Order of 2006 shall have effect as though in Section Five "Revocations" the existing Article 45 was substituted by the new Article 45 as specified below in this Order: -
- "45. This Order shall revoke all provisions relating to Stationary Vehicle Offences within all of the current Traffic Regulation Orders affecting the North of Liverpool (but only to the extent that they relate to that area) and consolidate their effects into this Order.

Stationary Vehicle Offences for the purposes of this Consolidation Order are defined as those relating to restrictions on the waiting, loading, unloading and parking of vehicles.

The North of Liverpool for the purposes of this Order is defined as being all that part of the Liverpool City Council area which is bounded to the south by the following streets and roads:-

M62, Bowring Park Road, Edge Lane Drive, Edge Lane, North View, Mount Vernon Green, Hall Lane, Low Hill, Erskine Street, Brunswick Road, King Street, College Street North, Shaw Street, Everton Brow, Salisbury Street, Field Street, William Henry Street, Soho Street, Springfield Street, New Islington, St Anne Street, Juvenal Street, Wellington Street, Aldersey Street, Nicholas Street, Bevington Bush, Gardner's Row, Edgar Street, Leeds Street, King Edward Street, New Quay, St Nicholas Place.

But excluding the Football Match Parking Zone which is bounded by the following streets and roads:-

Miranda Road, Rosalind Way, Carisbrooke Road, Stuart Road, Taylors Lane, Haggerston Road, Walton Hall Avenue, Queens Drive Walton, Townsend Lane, Dorset Road, West Derby Road, Rocky Lane, Breckfield Road South, Breck Road, Heyworth Street, St Domingo Road, Everton Valley, Westminster Road, Fountains Road, Melrose Road."

<u>Section Three – Variation Of Order Of 2006 As Respects Schedule 2 (Areas Of Highway Designated As</u> Parking Places Without Charge)

7. The Order of 2006 shall have effect as though in Schedule 2 (Areas Of Highway Designated As Parking Places Without Charge) the existing parking place without charge on Vauxhall Road (east side) as specified in Schedule 1 to this Order was omitted.

Section Four - Variation Of Order Of 2006 As Respects Schedule 4 (Areas Of Highway Designated As Disabled Persons Parking Places)

8. The Order of 2006 shall have effect as though in Schedule 4 (Areas Of Highway Designated As Disabled Persons Parking Places) the new disabled persons parking place on Limekiln Lane (west side) was included as specified in Schedule 2 to this Order.

Section Five - Variation Of Order Of 2006 As Respects Schedule 9 (Areas Of Highway Designated As Coach Parking Places)

- 9. The Order of 2006 shall have effect as though in Schedule 9 (Areas Of Highway Designated As Coach Parking Places): -
- (a) the existing (Cruise Liner) Coach Parking Place on Bath Street (north eastern side) as specified in Schedule 3 to this Order was omitted; and
- (b) the new Coach Parking Place on Bath Street (north eastern side) was included as specified in Schedule 4 to this Order.

<u>Section Six – Variation Of Order Of 2006 As Respects Schedule 14 (Areas Of Highway Designated As</u> <u>Parking Places For Vehicles For Loading And Unloading)</u>

10. The Order of 2006 shall have effect as though in Schedule 14 (Areas Of Highway Designated As Parking Places For Vehicles For Loading And Unloading) the new parking places for vehicles for loading and unloading on Greenock Street (west side) and Roberts Street (north west side) were included as specified in Schedule 5 to this Order.

<u>Section Seven - Variation Of Order Of 2006 As Respects Schedule 15 (Roads And Parts Of Roads In Which</u> <u>Waiting In Prohibited Twenty Four Hours A Day)</u>

- 11. The Order of 2006 shall have effect as though in Schedule 15 (Roads And Parts Of Roads In Which Waiting In Prohibited Twenty Four Hours A Day): -
- (a) the existing roads and parts of roads in which waiting is prohibited twenty-four hours a day on Vauxhall Road (east and west sides) and Waterloo Road (east side) as specified in Schedule 6 to this Order were omitted; and
- (b) the new roads and parts of roads in which waiting is prohibited twenty-four hours a day on Bath Street (both and north east sides), Bevington Bush (both sides), Blackstock Street (both sides), Carruthers Street (north to south section both sides and east to west section south and north sides), Chadwick Street (north side), Chadwick Street (Traffic Islands at the junctions with Great Howard Street and Pall Mall both sides), Chisenhale Street (south and north sides), Eaton Street (both sides), Edgar Street (north and south sides), Ford Street (north and south sides), Freemasons Row (north, south and both sides), Galton Street (north and south sides), Gardner's Row (north west and north east sides), Gascoyne Street (north and south sides), Gibraltar Row (both sides), Gladstone Street (east and west sides), Greenock Street (west and east sides), Great Howard Street Slip Road (both sides), King Edward Street (both sides), Lanyork Road (both sides), Leeds Street (west bound carriageway south and north sides and east bound carriageway north side), Limekiln Lane (both sides), Naylor Street (south and north sides), Nicholas Street (north west and south east sides), Paisley Street (both sides), Pall Mall (east and west sides), Paul Street (both sides), Philips Street (both sides), Pumpfields Road (north and west sides and south and east sides), Roberts Street (south east and south sides and north west and north sides), St. Bartholomew Road (both sides), Vauxhall Road (west and east sides) and Waterloo Road (west and east sides) were included as specified in Schedule 7 to this Order.

<u>Section Eight – Variation Of Order Of 2006 As Respects Schedule 16 (Roads And Parts Of Roads In Which</u> <u>Waiting Is Prohibited At Certain Times)</u>

- 12. The Order of 2006 shall have effect as though in Schedule 16 (Roads And Parts Of Roads In Which Waiting Is Prohibited At Certain Times): -
- (a) the existing roads and parts of roads in which waiting is prohibited at certain times on Bath Street (north east and south west sides), Vauxhall Road (east and west sides) and Waterloo Road (west side) as specified in Schedule 8 to this Order were omitted; and
- (b) the new roads and parts of roads in which waiting is prohibited at certain times on Bath Street (north east and south west sides), Chadwick Street (south and north sides), Chisenhale Street (north side), Denison Street (both sides), Ford Street (north and south side), Gibraltar Row (both sides), Great Howard Street Slip Road (both sides), Leeds Street (east bound carriageway north and south sides and west bound carriageway south side), Pall Mall (east and west sides), Naylor Street (south and north sides), Paul Street (north and south sides), Vauxhall Road (west and east sides) and Waterloo Road (west and east sides) were included as specified in Schedule 9 to this Order.

Section Nine - Variation Of Order Of 2006 As Respects Schedule 18 (Roads And Parts Of Roads In Which Loading And Unloading Is Prohibited At Certain Times)

- 13. The Order of 2006 shall have effect as though in Schedule 18 (Roads And Parts Of Roads In Which Loading And Unloading Is Prohibited At Certain Times): -
- (a) the existing roads and parts of roads in which loading and unloading is prohibited at certain times on Vauxhall Road (east and west sides) as specified in Schedule 10 to this Order were omitted; and

(b) the new roads and parts of roads in which loading and unloading is prohibited at certain times on King Edward Street (both sides), Leeds Street (south and north sides) and Vauxhall Road (east and west sides) were included as specified in Schedule 11 to this Order.
