The City Council of Liverpool (hereinafter referred to as "the Council") in exercise of its powers under Sections 1, 2, 4, 19, 32, 35, 38, 45, 46, 49, 53 and Part IV of Schedule 9 to The Road Traffic Regulation Act 1984 (which said Act of 1984 is hereinafter referred to as "the Act of 1984") as amended by The Road Traffic (Parking) Act 1986 (hereinafter referred to as "the Act of 1986") and Section 43 of Schedule 3 of The Road Traffic Act 1991 (hereinafter referred to as "the Act of 1991") and of all other enabling powers and after consultation with the Chief Officer of Police, the Traffic Commissioner for the North West and the Merseyside Passenger Transport Executive in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order: -

Section One

Commencement, Citation, Interpretations and General Articles

1. This Order shall come into operation on the 29th day of March 2010 and may be cited as The City Council of Liverpool (North – Part 1 Stationary Vehicle Offences) (Consolidation) (Order 2006) (Variation N°40) Order 2010.

4. Except where otherwise stated, any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.

5. The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act of 1984 or by or under any other enactment.

Section Two

Variation Of Order Of 2006 As Regards Roads In Which Waiting Is Prohibited Twenty-Four Hours A Day

6. The Order of 2006 shall have effect as though in **Schedule 15** the new twenty-hour no-waiting restrictions on **Soho Street (both sides)** and **Springfield (north side)** were included as specified in the **Schedule** to this Order.

Roads In Which Waiting Is Prohibited Twenty-Four Hours A Day
Inclusions Into Schedule 15 of Order of 2006)

Road/Side Of Road	Extent Of Restriction
Column One	Column Two
Soho Street (both sides)	From its junction with Islington to a point 5 metres north of its junction with Roderick Street
Springfield (north side)	From its junction with Soho Street for a distance of 86 metres west of this point and incorporating the turning head.
