The City Council of Liverpool (hereinafter referred to as "the Council") in exercise of its powers under Sections 1, 2, 4, 19, 32, 35, 38, 45, 46, 49, 53 and Part IV of Schedule 9 to The Road Traffic Regulation Act 1984 (which said Act of 1984 is hereinafter referred to as "the Act of 1984") as amended by The Road Traffic (Parking) Act 1986 (hereinafter referred to as "the Act of 1986") and Section 43 of Schedule 3 of The Road Traffic Act 1991 (hereinafter referred to as "the Act of 1991") and of all other enabling powers and after consultation with the Chief Officer of Police, the Traffic Commissioner for the North West and the Merseyside Passenger Transport Executive in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order: -

<u>Section One</u> <u>Commencement, Citation, Interpretations and General Articles</u>

- 1. This Order shall come into operation on the 21st day of June 2010 and may be cited as: The City Council of Liverpool (North Part 1 Stationary Vehicle Offences) (Consolidation) (Order 2006) (Variation N°45) Order 2010.

- 4. Except where otherwise stated, any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.
- 5. The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act of 1984 or by or under any other enactment.

Section Two

<u>Variation Of Order Of 2006 As Respects Areas Of Highway Designated As Parking Places For Vehicles For Loading And Unloading</u>

6. The Order of 2006 shall have effect as though in Schedule 14 (Areas Of Highway Designated As Parking Places For Vehicles For Loading And Unloading) the new length of Beech Street (east side) was included as specified in Schedule One to this Order.

Section Three

<u>Variation Of Order Of 2006 As Respects Roads And Parts Of Roads In Which Waiting Is</u> <u>Prohibited Twenty Four Hours A Day</u>

- 7. The Order of 2006 shall have effect as though in Schedule 15 (Roads And Parts Of Roads In Which Waiting Is Prohibited Twenty Four Hours A Day): -
- (a) the existing length of **Beech Street (east side)** from its junction with Prescot Road in a southerly direction for a distance of 57 metres was omitted from the Order.
- (b) the new lengths of **Beech Street (east side)** and **Lister Road (west side)** were included as specified in **Schedule Two** to this Order.

Section Three

<u>Variation Of Order Of 2006 As Respects Roads And Parts Of Roads In Which Loading And Unloading Is Prohibited At Certain Times</u>

8. The Order of 2006 shall have effect as though in Schedule 18 (Roads In Which Loading And Unloading Is Prohibited At Certain Times) the new length of Beech Street (north east side) was included as specified in Schedule Three to this Order.
