**Order, 2010**

The **City Council of Liverpool** (hereinafter referred to as "**the Council**") in exercise of its powers under **Sections 1(1) and (2), 2(1) to (3) and 4(2) to The Road Traffic Regulation Act 1984** (which said Act of 1984 is hereinafter referred to as "**the Act of 1984**") and of all other enabling powers and after consultation with the chief officer of police in accordance with **Part III of Schedule 9** to the Act of 1984, hereby makes the following Order:-

**Section One – Commencement, Citation, Interpretations and General Articles**

1. This Order shall come into operation on the **8<sup>th</sup>** day of **November 2010** and may be cited as: -

**The City Council of Liverpool**  
**(Back Breck Road)**  
**(Prohibition of Driving Except for Access to Off-Street Premises)**  
**Order, 2010**

2. (1) In this Order, save as otherwise defined within this Order, each and every expression shall have the meaning assigned to it by **The Traffic Signs Regulations and General Directions 2002**: -

"**pedal cycle**" means a pedal bicycle or pedal tricycle, not being in either case a motor vehicle;

2. (2) Except where otherwise stated, any reference in this Order to a numbered Article is a reference to the Article bearing that number in this Order.

3. The prohibition and restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act of 1984 or by or under any other enactment.

**Section Two – The Prohibitions of Driving Except for Access to Off-Street Premises To This Order**

4. No person shall, cause or permit any vehicle to proceed in **Back Breck Road, from its junction with Fowler Street in a north easterly direction to its junction with Bulwer Street**, other than a pedal cycle, an emergency service vehicle, any vehicle being used in connection with the maintenance, improvement or reconstruction of the road, the alteration or repair in or adjacent to the road of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telegraphic line, or a vehicle being used for the

purpose of gaining access to off-street premises within or that can be directly accessed from the said length of road specified in this article.

**Section Three – Contravention Of The Order**

5. Any person who contravenes **Article 4** of this Order, or who uses a vehicle, or causes or permits a vehicle to be used in contravention of **Article 4** of this Order, shall be guilty of an offence.
