**The City Council of Liverpool** (hereinafter referred to as “**the Council**”) in exercise of its powers under **Sections 1, 2, 4, 84 and Part IV of Schedule 9 to The Road Traffic Regulation Act 1984** (which said Act of 1984 is hereinafter referred to as “**the Act of 1984**”) and of all other enabling powers and after consultation with the **Chief Officer of Police, the Traffic Commissioner for the North West and the Merseyside Passenger Transport Executive** in accordance with **Part III of Schedule 9** to the Act of 1984, hereby makes the following Order:-

**Section One - Commencement, Citation, Interpretations and General Articles**

**1. This Order shall come into operation on the 24<sup>th</sup> day of January 2011 and may be cited as: - The City Council of Liverpool (North – Part 2 Moving Vehicle Offences) (Consolidation) (Order 2006) (Variation N°41) Order 2011.**

**2. In this Order except where the context otherwise requires, the several words and expressions for which meanings are assigned by the Order of 2006 shall have the same respective meaning.**

4. Except where otherwise stated, any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.

5. The prohibition and restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act of 1984 or by or under any other enactment.

### **Section Two – Variation Of Order Of 2006 As Respects To Reserved Cycle Lanes**

6. The Order of 2006 shall have effect as though in **Schedule 8 (Reserved Cycle Lanes)** the new reserved cycle lane was included as specified below in **Schedule 1** to this Order.

<b>Column 1</b> <b>Road Name</b>	<b>Column 2</b> <b>Extent Of Reserved Cycle Lane</b>
<b>Netherfield Road South (south-west side)</b>	<b>From a point 86.5m north of its junction with Everton Brow in a northerly direction to its junction with Prince Edwin Street.</b>

### **Section Three – Variation Of Order Of 2006 As Respects To Speed Limit Restrictions**

7. The Order of 2006 shall have effect as though in **Schedule 13 (Speed Limit Restrictions)** the new twenty miles per hour speed limit restrictions were included as specified below in **Schedule 2** to this Order.
