The City Council of Liverpool (hereinafter referred to as "the Council") in exercise of its powers under Sections 1, 2, 4, 19, 32, 35, 38, 45, 46, 49, 53 and Part IV of Schedule 9 to The Road Traffic Regulation Act 1984 (which said Act of 1984 is hereinafter referred to as "the Act of 1984") as amended by The Road Traffic (Parking) Act 1986 (hereinafter referred to as "the Act of 1986") and Section 43 of Schedule 3 of The Road Traffic Act 1991 (hereinafter referred to as "the Act of 1991") and of all other enabling powers and after consultation with the Chief Officer of Police, the Traffic Commissioner for the North West and the Merseyside Passenger Transport Executive in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order: -

Section One - Commencement, Citation, Interpretations and General Articles

- 4. Except where otherwise stated, any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.
- 5. The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act of 1984 or by or under any other enactment.

Section Two - Variation Of Order Of 2006 As Respects Schedule 3 (Residents Parking Places)

6. The Order of 2006 shall have effect as though in Schedule 3 (Residents Parking Places) the new residents parking place was included as specified in Schedule 1 to this Order.

Section Three - Variation Of Order Of 2006 As Respects Schedule 15 (Roads And Parts Of Roads In Which Waiting In Prohibited Twenty Four Hours A Day)

7. The Order of 2006 shall have effect as though in Schedule 15 (Roads And Parts Of Roads In Which Waiting In Prohibited Twenty Four Hours A Day): - (a) the existing twenty-four hour no waiting restrictions were omitted as specified in Schedule 2 to this Order: & (b) the new twenty-four hour no waiting restrictions were included as specified in Schedule 3 to this Order.

Section Four - Variation Of Order Of 2006 As Respects Schedule 17 (Roads And Parts Of Roads In Which Loading And Unloading Is Prohibited Twenty Four Hours A Day)

8. The Order of 2006 shall have effect as though in Schedule 17 (Roads And Parts Of Roads In Which Loading And Unloading Is Prohibited Twenty Four Hours A Day): - (a) the existing twenty-four hour no waiting restrictions for the purposes of loading and unloading were omitted as specified in Schedule 4 to this Order: & (b) the new twenty-four hour no waiting restrictions for the purposes of loading and unloading were included as specified in Schedule 5 to this Order.

Section Five - Variation Of Order Of 2006 As Respects Schedule 18 (Roads And Parts Of Roads In Which Loading And Unloading Is Prohibited At Certain Times)

9. The Order of 2006 shall have effect as though in Schedule 18 (Roads And Parts Of Roads In Which Loading And Unloading Is Prohibited At Certain Times): - (a) the existing no waiting restrictions for the purposes of loading and unloading at certain times were omitted as specified in Schedule 6 to this Order: & (b) the new no waiting restrictions for the purposes of loading and unloading at certain times were included as specified in Schedule 7 to this Order.
