The City Council of Liverpool (hereinafter referred to as "the Council") in exercise of its powers under Sections 1, 2, 4, 19, 32, 35, 38, 45, 46, 49, 53 and Part IV of Schedule 9 to The Road Traffic Regulation Act 1984 (which said Act of 1984 is hereinafter referred to as "the Act of 1984") as amended by The Road Traffic (Parking) Act 1986 (hereinafter referred to as "the Act of 1986") and Section 43 of Schedule 3 of The Road Traffic Act 1991 (hereinafter referred to as "the Act of 1991") and of all other enabling powers and after consultation with the Chief Officer of Police, the Traffic Commissioner for the North West and the Merseyside Passenger Transport Executive in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order: -

Section One Commencement, Citation, Interpretations and General Articles

- 5. The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act of 1984 or by or under any other enactment.

Section Two Variation Of Order Of 2006 As Respects Areas Of Highway Designated As Disabled Residents Parking Places

- 6. The Order of 2006 shall have effect as though in Schedule 5 the: -
- (a) Existing disabled resident parking places on: Evered Avenue (Bay N° N2025); Malvern Road (Bay N° N2166) and Fell Street (Bay N°2235) were revoked as specified in Schedule 1 to this Order.
- (b) New disabled resident parking places on: Eastbourne Road (Bay N° N2420); Jonville Road (Bay N° N2421; Grace Road (Bay N° N2422); Beaver Grove (Bay N° N2423); Hollyfield Road (Bay N° N2424); Eskdale Road (Bay N° N2425); Oakhill Road (Bay N° N2426); Woodhall Road (Bay N° N2427); Wharncliffe Road (Bay N° N2428); Southgate Road (Bay N° N2429); Moscow Drive (Bay N° N2430); and Ling Street (Bay N°2431) were included as specified in Schedule 2 to this Order.
