The City Council of Liverpool (hereinafter referred to as "the Council") in exercise of its powers under Sections 1, 2, 4, 19, 32, 35, 38, 45, 46, 49, 53 and Part IV of Schedule 9 to The Road Traffic Regulation Act 1984 (which said Act of 1984 is hereinafter referred to as "the Act of 1984") as amended by The Road Traffic (Parking) Act 1986 (hereinafter referred to as "the Act of 1986") and Section 43 of Schedule 3 of The Road Traffic Act 1991 (hereinafter referred to as "the Act of 1991") and of all other enabling powers and after consultation with the Chief Officer of Police, the Traffic Commissioner for the North West and the Merseyside Passenger Transport Executive in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order: -

Section One Commencement, Citation, Interpretations and General Articles

- 1. This Order shall come into operation on the 30th day of July 2012 and may be cited as: The City Council of Liverpool (North Part 1 Stationary Vehicle Offences) (Consolidation) (Order 2006) (Variation N°87) Order 2012.

- 4. Except where otherwise stated, any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.
- 5. The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act of 1984 or by or under any other enactment.

Variation Of The Order Of 2006 As Respects SECTION FOUR – VARIOUS PARKING PLACES

6. The Order of 2006 shall have effect as though the existing Article 14 (Parking Places Without Charge) and Article 42 (Restriction Of Waiting Of Vehicles In Parking Places) were both substituted by the new Article 14 (Parking Places Without Charge) and Article 42 (Restriction Of Waiting Of Vehicles In Parking Places) as specified overleaf in this Order:-

Parking Places Without Charge

14. Any person may leave a vehicle at any designated Parking Place described as being without charge in Schedule 2 to this Order, in the roads or lengths of roads, special manner of standing, during the permitted days and hours and for the maximum duration of stay contained in columns 1, 2, 3 and 4 respectively of Schedule 2 to this Order.

Restriction Of Waiting Of Vehicles In Parking Places

- 42. (1) Notwithstanding the foregoing provisions of this Order, any vehicle may wait during the permitted hours anywhere on the carriageway in a parking place (other than a parking place or part of a parking place the use of which has been suspended under Article 40 of this Order) for so long as may be necessary if: - (a) the vehicle is waiting to enable a person to board or alight from the vehicle; (b) the vehicle is waiting owing to the driver being prevented from proceeding by circumstances beyond his control or to such waiting being necessary in order to avoid an accident; (c) the vehicle is a vehicle used for police, fire brigade or ambulance purposes, or a vehicle (other than a passenger vehicle) in the service of a local authority which is being used in pursuance of statutory powers or duties; (d) The vehicle, if it cannot conveniently be used for such purposes in any other road, to be used in connection with any of the following operations, namely: - (i) Building, industrial or demolition operations; (ii) The removal of any obstruction to traffic; (iii) The maintenance, improvement or reconstruction of the said roads, lengths of roads or sides of lengths of roads; (iv) The laying, erection, alteration or repair in, or in land adjacent to, the said roads, lengths of roads or sides of lengths of roads of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telecommunications apparatus as defined in Section 4 of The Telecommunications Act, 1984, including telephone kiosks; (e) The vehicle to be used by a postal operator for the purpose of delivering or collecting postal packets from premises or postal boxes adjacent to the road; (f) the vehicle (not being a passenger vehicle) is waiting to enable it to be used for any purpose specified in Article 40(1)(b) of this Order; (g) the vehicle (not being a passenger vehicle) is in actual use in connection with the removal of furniture from one office or dwelling house to another or the removal of furniture from such premises to a depository or to such premises from a depository; (h) the vehicle is waiting if goods are being sold or offered for sale from the vehicle by a person who is licensed by the Council to sell goods from a stationary pitch situated in the parking place; (i) the vehicle is waiting to enable it to be used in connection with lawfully posting or removing advertising material in the form of posters on or from, or cleaning windows or chimneys in, premises adjacent to the parking place in which the vehicle is waiting; or (j) in any other case the vehicle is waiting, for so long as may be necessary, for the purpose of delivering or collecting goods including, so far as a Bank is concerned, cash or other valuables or valuable securities, or loading or unloading the vehicle at premises adjacent to the parking place in which the vehicle is waiting.
- 42. (2) No charge specified in the foregoing provisions of this Order shall be payable in respect of any vehicle waiting in a parking place in accordance with the foregoing provisions of this Article.
- 42. (3) Except as provided in the foregoing provisions of this Order, the driver of a vehicle shall not cause or permit the vehicle to wait in a parking place.
- 42. (4) Nothing in the foregoing provisions of this Article shall be taken as authorising anything which would be a contravention of any regulations made or having effect as if made under Section 25 of the Act of 1984.

<u>Variation Of The Order Of 2006 As Respects Areas Of Highway Designated As Parking Places</u> <u>Without Charge</u>

7. The Order of 2006 shall have effect as though in **Schedule 2** the new roads were included as specified in **Schedule 1** to this Order.

<u>Variation Of The Order Of 2006 As Respects Roads And Parts Of Roads In Which Waiting In</u> Prohibited Twenty Four Hours A Day

- 8. The Order of 2006 shall have effect as though in Schedule 15: -
- (a) The existing roads were omitted from the Order as specified in **Schedule 2** to this Order.
- (b) The new roads were included as specified in **Schedule 3** to this Order.

<u>Variation Of The Order Of 2006 As Respects Roads And Parts Of Roads In Which Waiting Is</u> Prohibited At Certain Times

- 9. The Order of 2006 shall have effect as though in Schedule 16: -
- (a) The existing roads were omitted from the Order as specified in **Schedule 4** to this Order.
- (b) The new road was included as specified in **Schedule 5** to this Order.

<u>Variation Of The Order Of 2006 As Respects Roads And Parts Of Roads In Which Loading And Unloading Is Prohibited Twenty Four Hours A Day</u>

10. The Order of 2006 shall have effect as though in **Schedule 17** the new roads were included as specified in **Schedule 6** to this Order.

<u>Variation Of The Order Of 2006 As Respects Roads And Parts Of Roads In Which Loading And Unloading Is Prohibited At Certain Times</u>

- 11. The Order of 2006 shall have effect as though in Schedule 18: -
- (a) The existing roads were omitted from the Order as specified in **Schedule 7** to this Order.
- (b) The new road was included as specified in **Schedule 8** to this Order.
