The City Council of Liverpool in exercise of its powers under Sections 1, 2, 3, 4, 9, 19, 32, 35, 38, 45, 46, 47, 48, 49, 50, 51, 52, 53 and Part IV of Schedule 9 to The Road Traffic Regulation Act 1984 and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to The Road Traffic Regulation Act 1984 hereby makes the following Order:-

1. Commencement and Citation

This Order shall come into operation on the 1st day of October 2012 and may be cited as: - The City Council of Liverpool (Football Match Parking Places and Controlled Parking Zone) (Order 2009) (Variation No.20) Order, 2012.

2. Interpretation

- (1) In this Order except where the context otherwise requires, the several words and expressions for which meanings are assigned by the Order of 2009 shall have the same respective meaning.

Variation Of The Order Of 2009 As Respects Article 2 (Interpretation)

3. The Order of 2009 shall have effect as though in Article 2 (Interpretation) the existing interpretation of "Controlled Hours" was substituted by the new interpretation of "Controlled Hours" as specified below in this Order: -

"Controlled Hours" means:- (a) in respect of Parking Places (except Doctors Parking Places) the period between 5.00 p.m. and 10.00 p.m. on Mondays to Fridays inclusive and 10.00 a.m. and 6.00 p.m. on Saturdays and Sundays between the months of August and May inclusive; (b) in respect of each Doctors Parking Places specified in Column 1 of Schedule 8 means the period specified in the corresponding part of Column 6 of Schedule 8; (c) in respect of any Bus Stop Clear Way (For Information Only) the period between 5.00 p.m. and 10.00 p.m. on Mondays to Fridays inclusive and 10.00 a.m. and 6.00 p.m. on Saturdays and Sundays between the months of August and May inclusive; (d) in respect of each Limited Waiting Parking Bay specified in Column 1 of Schedule 18 means the days and hours specified in Columns 3 and 4 respectively in Schedule 18, for a maximum period not exceeding that specified in Column 5 of Schedule 18, and if a period of time less than that specified in Column 6 of Schedule 18 has elapsed since the termination during the said hours of the last period of waiting (if any) by that vehicle on the same side of length of road; and (e) in respect of each Goods Vehicle Loading And Unloading Only Bays specified in Column 1 of Schedule 19 mean the days and hours specified in Columns 3 and 4 respectively in Schedule 19, for a maximum period not exceeding that specified in Column 5 of Schedule 19, and if a period of time less than that specified in Column 6 of Schedule 19 has elapsed since the termination during the said hours of the last period of loading and/or unloading (if any) by that vehicle on the same side of length of road.

<u>Variation Of The Order Of 2009 As Respects PART II RESTRICTION OF USE</u> OF PARKING PLACES

4. The Order of 2009 shall have effect as though the existing Article 12B (Parking Places For Goods Vehicles For Loading And Unloading Only) was substituted by the new Article 12B (Parking Places For Goods Vehicles For Loading And Unloading Only) as specified below/overleaf in this Order:-

Parking Places For Goods Vehicles For Loading And Unloading Only

12B. No person shall leave a vehicle at any time at a Goods Vehicle Loading And Unloading Only Bay:-

- (i) Other than a Goods Vehicle which is left at such a Goods Vehicle Loading And Unloading Only Bay for the purpose of loading and/or unloading goods; and
- (ii) Unless the Goods Vehicle is left at the Goods Vehicle Loading And Unloading Only Bay specified in Column 1 of Schedule 19 of this Order during the hours specified in the corresponding part of Column 4 of Schedule 19 of this Order during the days specified in the corresponding part of Column 3 of Schedule 19 of this Order, for a maximum period not exceeding that specified in Column 5 of Schedule 19 of this Order, and if a period of time less than that specified in Column 6 of Schedule 19 of this Order has elapsed since the termination during the said hours of the last period of loading and/or unloading (if any) by that vehicle on the same side of length of road.
- (iii) During the maximum period for which goods vehicles may load and/or unload goods the driver, or other person in charge of a vehicle using a loading bay, shall not

cause such vehicle to wait thereon during the hours of operation other than whilst goods are being continuously loaded or unloaded from the vehicle.

<u>Variation Of The Order Of 2009 As Respects PART III PROVISIONS AS TO PERMITS AND BADGES</u>

5. The Order of 2009 shall have effect as though the existing Article 29 (Display of Permit) was substituted by the new Article 29 (Display of Permit) as specified below/overleaf in this Order:-

Display of Permit

- 29. A Permit issued under the provisions of this Order shall be displayed as follows:-
- (a) in the case of a vehicle fitted with a front windscreen on the near side thereon and immediately behind the windscreen and with its front facing forward so that the expiry date, permit type, vehicle registration, etc. recorded on the Permit are clearly visible to a person standing at the front or nearside of such vehicle for the full duration that the vehicle is parked in the Parking Place; or
- (b) on the vehicle dashboard or fascia panel so that the front face of the permit is legible from outside the vehicle for the full duration that the vehicle is parked in the Parking Place.

6. The Order of 2009 shall have effect as though the existing Column Headings of Schedule 19 (Areas Of Highway Designated As Parking Places For Goods Vehicles For Loading And Unloading Only) was substituted by the new Column Headings of Schedule 19 (Areas Of Highway Designated As Parking Places For Goods Vehicles For Loading And Unloading Only) as specified below in this Order: -
