## The City Council Of Liverpool (Allerton Road District Shopping Centre) (Revocation, One-Way Traffic, Prohibition and Restriction of Waiting, Prohibition of Loading and Unloading and Prohibition of "U"-Turn) (Order, 1995) (Revocation) Order, 2008

The City Council of Liverpool (hereinafter referred to as "the Council") in exercise of its powers under Sections 1(1) and (2), 2(1) to (3), 4(2) and Part IV of Schedule 9 to The Road Traffic Regulation Act 1984 (which said Act of 1984 is hereinafter referred to as "the Act of 1984") and of all other enabling powers and after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

## **Section One – Commencement and Citation**

1. This Order shall come into operation on the 2<sup>nd</sup> day of July 2008 and may be cited as: - The City Council Of Liverpool (Allerton Road District Shopping Centre) (Revocation, One-Way Traffic, Prohibition and Restriction of Waiting, Prohibition of Loading and Unloading and Prohibition of "U"-Turn) (Order, 1995) (Revocation) Order, 2008.
