**The Parking Places and Controlled Parking Zone
(Liverpool) (Order 2009) (Variation No.55) Order, 2013**

The City Council of Liverpool (hereinafter referred to as "**the Council**") in exercise of its powers under **Sections 1, 2, 3, 4, 9, 19, 32, 35, 38, 45, 46, 47, 48, 49, 50, 51, 52, 53** and **Part IV of Schedule 9 of The Road Traffic Regulation Act 1984** (which said Act of 1984 is hereinafter referred to as "**the Act of 1984**") and of all other enabling powers and after consultation with the chief officer of police in accordance with **Part III of Schedule 9** to the Act of 1984, hereby makes the following Order:-

1. Commencement and Citation

This Order shall come into operation on the 20th day of May 2013 and may be cited as: - The Parking Places And Controlled Parking Zone (Liverpool) (Order 2009) (Variation No.55) Order, 2013.

2. Interpretation

(1) In this Order except where the context otherwise requires, the several words and expressions for which meanings are assigned by the Order of 2009 shall have the same respective meaning.

(2) Furthermore, in this Order the expression "**Order of 2009**" means **The Parking Places And Controlled Parking Zone (Liverpool) Order 2009**, as amended.

Variation Of The Order Of 2009 As Respects Roads And Parts Of Roads In Which Waiting Is Prohibited Between The Hours Of 8.00 a.m. and 6.00 p.m. On Mondays To Sundays

3. The Order of 2009 shall have effect as though in **Schedule 14** the new outer zone roads numbered **347A** and **347B** were included as specified in **Schedule 1** to this Order.

Variation Of The Order Of 2009 As Respects Roads And Parts Of Roads In Which Waiting Is Prohibited Twenty-Four Hours A Day

4. The Order of 2009 shall have effect as though in **Schedule 15** the new outer zone roads numbered **347A** and **347B** were included as specified in **Schedule 2** to this Order.

Roads and parts of roads in which waiting is prohibited between the hours of 8.00 a.m. and 6.00 p.m. on Mondays to Sundays (Outer Zone)

INCLUSIONS into Schedule 14 of the Order of 2009

347A	Crown Street	its south west side, from its junction with Elizabeth Street to a point 36m north west of its junction with Brownlow Hill
347B	Crown Street	its north east side, from its junction with West Derby Street to a point 36m north west of its junction with Paddington

Schedule 2

Roads and parts of roads in which waiting is prohibited twenty four hours a day (Outer Zone)

INCLUSIONS into Schedule 15 of the Order of 2009

347A	Crown Street	its south west side, from its junction with Brownlow Hill in a north westerly direction for a distance of 36m
347B	Crown Street	its north east side, from its junction with Paddington in a north westerly direction for a distance of 36m
